TO ADVANCE THE EDUCATION OF THE PUBLIC BY CARRYING OUT RESEARCH INTO ANY PUBLIC QUESTIONS WHETHER LOCAL NATIONAL OR INTERNATIONAL, AND PUBLISHING THE USEFUL RESULTS OF SUCH RESEARCH. 4. TO ADVANCE THE EDUCATION OF THE PUBLIC BY PROMOTING PUBLIC UNDERSTANDING OF ANY SUBJECT OF EDUCATIONAL VALUE WHERE WOMEN HAVE PARTICULAR KNOWLEDGE OR EXPERIENCE. 5. TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION FOR SUCH WOMEN IN THE INTERESTS OF SOCIAL WELFARE AND WITH A VIEW TO IMPROVING THEIR CONDITIONS OF LIFE.

**Activities:** To advance the education of women and to provide them with facilities for recreation or other leisure time activities particularly in the interest of social welfare for all and with a view to improving their conditions of life.
