INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF

**LONDON FRIENDS OF KAMENITZER YESHIVA JERUSALEM**

I report on the accounts of the Trust for the year ended 31 March 2022 which are set out on pages 4 to 5.

Respective Responsibilities of Trustee and Examiner
