**Review of Major Risks:**

The Trustees confirm that the major risks to which the Charity is exposed, as identified by the Trustees, have been reviewed and systems have been established to mitigate those risks.

The Covid-19 outbreak occurred during the previous year. The full impact of the Covid-19 outbreak cannot be estimated with any certainty, but a review of the Charity's financial position has satisfied the Trustees that it has adequate reserves and mitigation strategies to deal with the impact of the outbreak.

**INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF  
THE PAMELA BARLOW CHARITABLE TRUST**

I report to the trustees on my examination of the accounts of The Pamela Barlow Charitable Trust ('the charity') for the year ended 5 April 2021, which are set out on pages 5 to 7.

**Responsibilities and basis of report**

I have no concerns and have come across no other matters in connection with the examination to which attention should be drawn in this report in order to enable a proper understanding of the accounts to be reached.
