### Annual Report for the Year ending February 2021

The objects of the charity are

(a) to provide the necessary facilities for the care, recreation and education of children during out of school hours and school holidays, and for young people generally

(b) to advance the education and training of the persons in the provision of such care, education and recreational facilities.

- MAY aims to be an umbrella body for various activities in and around Moreton, stimulating new ones and supporting existing ones. It is able to submit funding applications on behalf of the activities. Currently it is fully responsible for the Yard Youth Club.

- Membership is open to any interested individual or organisation, without charge.

### “The Yard” Youth Club

The Yard Youth Club runs from a purpose-built youth setting and provides a safe, adult-led, non-academic environment, open to all young people. It offers three weekly sessions of indoor and outdoor activities, advertised in advance through a newsletter, website and information board.

#### Prior Activities

Mondays 7-9.30 pm: free entry for young people aged 13+.

- Tuesdays 6-8 pm for young people transitioning between primary school and secondary (ages 10½ (Year 6) to 13).

- Wednesday 6-9 pm for young people aged 8-12: a pre-planned programme of sports activities (weather permitting), games, crafts, and cooking.

#### Covid

Unfortunately This year has been a very traumatic time for the Club and the Young people. We were forced to close on the 20th March and remained closed for the whole period.

During this period our employed staff were furloughed. We continued to pay them and received the JRS from HMRC

#### Support by volunteers

We were able to give some support to the club members by meeting them outside premises and giving them access to help lines and phone support.

We received the drawdown from The National Lottery which supported the staff and overhead costs

It was a desperate year and so disappointing to have close such a vibrant facility.

Notes to the Financial Statements

**1. General Information**

Moretonhampstead Association for Youth is an unincorporated charity registered with the Charity Commission, registered charity number 1085831. The principal address is Greenhill, Fore Street, Moretonhampstead, Devon, TQ13 8LL.

**2. Accounting Policies**

**2.1. Basis of Preparation of Financial Statements**

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)", Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Charities Act 2011.

The charity is a Public Benefit Entity as defined by FRS 102.

**2.2. Cash and Cash Equivalents**

Cash and cash equivalents are basic financial assets and include cash in hand and deposits held at call with banks, other short-term highly liquid investments that mature in no more than three months from the date of acquisition and are readily convertible to a known amount of cash with insignificant risk of change in value, and bank overdrafts.
