"SOCIALLY EXCLUDED PEOPLE" MEAN PEOPLE SUFFERING FROM SOCIAL OR ECONOMIC DISADVANTAGES WHOSE CAPACITY AND SKILLS NEED TO BE DEVELOPED BY THE ACTIVITIES OF THE CHARITY AS DETAILED IN THE OBJECT.

**Activities:** Smart works with the homeless and people who suffer social disadvantage through the arts, creating training, jobs and commercial opportunities and more importantly, giving hope and renewing self-esteem to people whose lives have been seriously damaged. Smart acts as intermediary facilitating exhibitions and workshops in the major art galleries, museums and the corporate sector.
