TRUSTEES' REPORT (INCLUDING DIRECTORS' REPORT)

FOR THE YEAR ENDED 31 MARCH 2021

The trustees present their report and financial statements for the year ended 31 March 2021.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the charity's [governing document], the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)".

During the year, the organisation was significantly affected, as were many others, by the Coronavirus (Covid-19) pandemic. Our initial plan in response to the lockdown restrictions imposed on 23 March, 2020 was to ensure our staff and service users were provided with detailed information to keep themselves safe. We implemented home working for the majority of staff, providing the required IT and mobile technology to facilitate this for employees normally office based, to continue to support the service users on their caseloads. We continued to deliver our needle and syringe service at all locations, whilst adhering to the safety guidelines for our staff and service users. This service was delivered on rota, taking into consideration the self-isolation requirements for staff with underlying conditions and those who were in the shielding category. The Engagement Outreach service and the Floating Support service continued in Neath Port Talbot, working with housing partners, to ensure our homeless population were securely and safely accommodated in B&B provision in accordance with the self-isolation and lockdown regulations. We worked with our commissioners to agree our plan of action and were in weekly communication with the Welsh Government Substance Misuse Branch, who provided assurance that funding would remain constant. We are pleased to report that we did not need to access the furlough scheme.

Objectives and activities

Our charity's aims as set out in the objects contained in the company's memorandum of association are to:

'Reduce, treat and prevent the harm caused by dependency and addiction to individuals, their families and the wider community including interventions to reduce harm in the criminal justice system'.

Our values are:

Public benefit

In developing strategies for the charity to promote its objectives, the Board had due regard to the Charity Commission's guidance in respect of public benefit requirements. The main activities undertaken to further the charity's purposes for the public benefit are detailed throughout the report.

Achievements and performance

Effectiveness – Individuals and Families

We deliver a wide range of recovery interventions for individuals and their families. In a year, we would usually work with around 18,000 individuals across our geographical areas in the community, educational establishments and custodial environments, but due to the Covid-19 pandemic, this number was considerably less, e.g. we were unable to deliver our programme in schools due to the closure of educational establishments. We are proud to report we were able to support a significant number of people and their family members to improve outcomes and can report the following:

- Adults Services = 776
- Outreach Engagement Service = 74
- Family Services = 220 (Parental Substance Misuse = 119/Family and Significant Others = 101)
- SWITCH Young Persons Service = 1,009 (significantly lower due to the pandemic impact on schools)
- Youth Justice Service and Hillside Substance Misuse Service = 108
- Needle and Syringe Programme = 1,002 unique individuals/2,761 transactions

We are delighted to witness the changes in individuals as they travel along their recovery journey, through our harm minimisation interventions, community outreach and engagement services, working with families in their own homes and engaging people in the DOMINO Project to make productive use of time learning new skills or re-learning skills or interests lost. The Cyfle Cymru European Funded project moved into its fifth year in September and significant outcomes are being achieved by participants on this project as they acquire new skills through training and achieve volunteering and employment outcomes. We motivate and encourage, support and enthuse, generating hope that change is possible through therapeutic interventions such as our 12-Step Minnesota Model abstinence treatment programme. Many individuals completing this programme make significant positive changes that are enduring.

Our services have been disrupted during the Covid-19 pandemic, with many staff working from home. Our initial contingency plan was no face-to-face interventions, apart from needle exchange and engagement outreach. All staff were provided with comprehensive guidance on procedures, including PPE requirements for the different elements of the work. Staff working from home, due to shielding or underlying conditions, were provided with the required equipment to continue supporting our service users, either by telephone, text or online, depending on the service user's preference. A service user survey was implemented to seek the views of service users on the support they received during the pandemic and the findings were positive, with an average score of 9 given (0 = poor/10 = excellent) on the service received. During the year, we began to slowly open up face-to-face services again whilst adhering to the social distancing guidelines, having to source alternative accommodation to deliver our 12-Step group programme to safely continue this therapeutic work. We were also guided by our prison colleagues with arrangements for face-to-face work with the men in custody. DOMINO diversionary activities were curtailed due to the Welsh Government Covid-19 guidelines, however, we continued to support participants online on an individual and group activity basis.

Effectiveness – communities

We deliver the following services that are designed with safer communities in mind:

DOMINO Therapeutic Recreation; DYFODOL Substance Misuse Services in partnership with G4S as lead and Kaleidoscope that contribute to reducing reoffending, Youth Justice substance misuse services, a specialist substance misuse service at Hillside Secure Children's Home and our work with the National Probation Service. Our work extends to our communities, working in partnership with a range of statutory and other third sector organisations to improve outcomes for families affected by substance misuse. We have successfully delivered in collaboration with DACW partners and Addaction (now 'We are with You'), the UK-wide Drink Wise Age Well Project that brought £4 million from the Big Lottery Fund to raise awareness of alcohol in people over 50 in Wales, a project that was completed on 31 March 2020. This project was a community wide initiative, the outcomes of which will be utilised to inform policy, raise awareness of the consequences of alcohol as we age, deliver training to staff working in the community and provide interventions for older individuals who would not ordinarily have accessed services. We were fortunate that all the Drink Wise Age Well roadshows across Wales were completed by the week before the first lockdown, however, the legacy training was cancelled due to the pandemic. This was completed electronically during February 2021 across the seven regions of Wales.

We strive to raise awareness of and reduce the stigma associated with substance misuse to build positive and effective relationships with the communities we serve. This can be evidenced by the successful achievements of our service users as they make significant changes in their lives, improve family relationships and social networks and begin to make a valuable contribution to their communities and the economy in Wales.

Our prison work was significantly affected by the pandemic, with all contact with prisoners curtailed. We worked closely with each establishment during 2020-2021 to resume services under the guidance of the Ministry of Justice and prison Governors. Our specialist service in Hillside was also affected as our worker was initially instructed to work from home and later joined a service rota.

Key service developments

Welsh Centre for Action on Dependency and Addiction Limited (WCADA) is one of the leading recovery organisations in Wales, playing a pivotal role in the development and delivery of effective treatment for individuals affected by substance misuse.

Notable activities during the year: Neath Port Talbot Substance Misuse Housing Support, a pilot project providing intensive peripatetic housing related support services for adults with alcohol and/or drug use issues. It is funded through the Housing Support Grant in partnership with Neath Port Talbot County Borough Council. The service works closely with street homeless, those vulnerably housed and the Neath Port Talbot Street Vulnerability MARAC (Multi Agency Risk Assessment Conference). The pilot project commenced on 1.04.2020, with an option to extend for up to 12 months. The service has worked above its contracted units (16) due to the pandemic and supporting those temporarily housed in hotels and B&B's, providing 22 units of support.

Our priority is the continuing effective and efficient delivery of all our services and contracts.

The Critical Incident Group, initiated in 2018 by the Joint Public Service Boards in Swansea and Neath Port Talbot in response to increases in drug related death, severe infections in injecting drug users and disrupting 'County Lines', continued into 2019-2020. An outcome of the Critical Incident Group was the implementation of an outreach engagement service to be piloted for six months from February 2019, in order to reach extremely vulnerable alcohol and drug users who are not engaged in services. The successful outcome of this pilot secured permanent funding to continue delivery. This service has continued during the Covid-19 pandemic and has received a commendation for the excellent support they have provided for our most vulnerable people and successful relationships forged with a range of partners to meet the needs of this client group. We additionally received a Housing Support Grant for an Engagement Outreach Assistant post to enhance the capacity of the Engagement Outreach Service.

Change Step funding from the Armed Forces Covenant Fund Trust was successfully procured by CAIS and our partnership continues. We are extremely grateful to Geraint Jones for his hard work that enables us to continue delivering this invaluable service for two years from 1 April 2019 for our veterans and their families in our area. The mentors have continued to support our veterans by telephone during the lockdown period, with some crisis face-to-face support provided at a social distance. Full face-to-face support was reinstated in line with our Recovery Planning System.

We were fortunate to receive covid relief funds from a range of sources, such as Moondance, Welsh Government SMAF Winter Fund, BAVO (Bridgend Association of Voluntary Organisations), Western Power Distribution, the Festive Fund, Swansea Council, Wales Coronavirus Resilience Fund, and several supermarkets also donated produce to enable us to provide food parcels to the families we support.

Our Health & Safety Officer developed a comprehensive Recovery Planning System that was regularly updated during the year in response to changes in regulations and lifting of restrictions. This has been a critical role that has contributed a great deal to our response to the Coronavirus (Covid-19) pandemic.

We continued our focus on GDPR and ensuring adherence to the legislation and its implementation. An audit was planned towards the end of Q4, however, this was interrupted by the Covid-19 restrictions. We have however, ensured adherence to the regulations with respect to home working and security of information.

All our social events such as our Volunteer Celebration Event, Family Fun Day, Recovery Celebration and Christmas Party for service users and their families had to be cancelled due to the pandemic, the first year this has happened. We are very much looking forward to the time we are able to hold these events once again.

We are extremely proud of our achievement of the Investors in People Silver Award and the PQASSO Quality Mark at Level 1 and continue to monitor our performance against these standards. PQASSO/Trusted Charity Mark is the Practical Quality Assurance System for Small Organisations, a quality assurance system that helps management to run an organisation effectively and efficiently. It has 91 indicators under 11 quality areas: Governance; Planning; Leadership and management; User-centred Service; Managing People; Learning and Development; Managing Money; Managing Resources; External Communications; Working with Others and; Assessing Outcomes and Impact.

The year 2020-2021 has been a year of transitions for the WCADA training department due to the pandemic. One of the biggest transitions during the year was moving our training online through mediums of Zoom and MS Teams. WCADA trainers soon learned these new skills and WCADA's training service was reinstated with less printing and transporting of equipment. Previous customers began to tentatively return, core training for staff returned and also the volunteer training course was delivered. One of the most exciting changes was the updating of the WCADA core training strategy that went live during 2020-2021, increasing the number of sessions available to staff.

WCADA trainers also delivered free 'bite-sized' training sessions and due to the new online platforms, we were able to reach across Wales providing sessions such as 'Introduction to Image & Performance Enhancing Drugs' to professionals in Carmarthen and Newport without the consequences of travelling and consequential reduced impact on the environment.

Our reputable volunteer training course resumed and we were able to train two more cohorts of volunteers during this year, meaning that more than 20 new volunteers started providing vital work in supporting our services

What stayed the same was the consistently high level of feedback received from training participants with 100% of trainees still scoring an 8-10 on recommending WCADA's training provision.

We maintained our Agored Cymru accreditation during the year.

Partnerships

WCADA is committed to delivering the best possible service to our service users. To maintain a high standard of service, we work with others to deliver best possible evidenced based treatment for our service users.

These are just a few services we work closely with:

- In Health: ABMU Health Board, Community Drug and Alcohol Team (CDAT), Community Mental Health Teams (CMHT), CAMHS (Community Adolescent Mental Health Service), GPs and Health Visitors, Hospitals and Psychiatric Units.
- In crime reduction: HMPPS (Her Majesty's Prisons and Probation Service), HMP Prison Service, G4S, the Police, National Probation Service, Women's Aid, Youth Justice Service and Hillside.
- In the community: Local Authority Social Services, Community Safety Partnerships, Citizens Advice Bureau, Housing Providers, Job Centre Plus, Residential Rehabilitation centres and other third sector organisations.

The re-commissioning of our Treatment Service across Swansea and Neath Port Talbot has been delayed due to the pandemic and work involved in the restructuring of services across the region. The Western Bay Area Planning Board has agreed to enter an Alliance Contracting Model that will need a great deal of thought and partnership development prior to re-commissioning.

We are fully committed to working in partnership to achieve the best outcomes for our service users and their families and this can be evidenced by our engagement and contribution to the following working groups:

Our involvement in the DACW consortium continues with current membership consisting of Barod, Cais, Hafal, Kaleidoscope, Safer Wales and WCADA. A review of our aims and objectives will be essential for us in preparing for the future, with a key objective of influencing policy on substance use in Wales. Our Chief Executive stepped down as Chair in September 2020, continuing in the Treasurer role. We initiated weekly meetings at the outset of lockdown due to Covid-19, with key Welsh Government Substance Misuse representatives joining us to share information and keep up to date on service delivery and government guidelines. This support from Welsh Government was much appreciated during what has been a difficult year.

We joined Adferiad CIO on 1 April 2019 as a third partner with CAIS and Hafal. This partnership was developed to respond to the needs of people facing a range of co-occurring health conditions and complex social circumstances, people who are seldom seen and seldom heard. Karen Ozzati and Rebecca Hancock (Chief and Deputy Chief Executive, respectively) represent WCADA as trustees on the Adferiad Board. We have developed this partnership through the financial year where complete merger became the focus as the year progressed, meetings moving on-line as with many others during the pandemic. The legal process in preparation for the full merger on 1 April 2021 was facilitated by the international law firm, Allen & Overy, with an intention to merge notice published on 10 December 2020. The support provided by this team of lawyers was invaluable and much appreciated and enabled a smooth transfer on the agreed date as planned.

Financial review

Risk assessment and management

The trustees have overall responsibility for ensuring that the charity has appropriate systems of control, both financial and operational; for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity; for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud and other irregularities. The systems of internal control are designed to provide reasonable assurance that:

- The charity is operating efficiently and effectively in the pursuit of its objectives
- Funds are applied in accordance with the intentions of the funder
- Its assets are safeguarded against unauthorised use or disposition
- Proper records are maintained and financial information used within the charity or for publication is reliable
- The charity complies with relevant laws and regulations.

They are also designed to provide reasonable, but not absolute assurance against material misstatement or loss. They include:

- A strategic plan and an annual budget approved by the trustees
- Regular consideration by the trustees of financial results and variance from budgets
- Delegation of authority and segregation of duties
- A governance programme involving regular visits to all WCADA's services
- Identification and management of risks.

As part of an ongoing overall risk management strategy development process, WCADA continues to review previous risk mapping work to ensure that it has identified and responded to the different types of risk the charity faces, prioritising them in terms of potential impact and likelihood of occurrence and identifying means of mitigating the risks including the internal control systems in operation. A comprehensive contingency plan and recovery planning system has been developed in response to Covid-19. These documents are updated regularly in response to changes in regulations and guidance.

The trustees are pleased to report that provisions are in place to manage the risks considered being potentially the most major, and as part of an ongoing process the scope and implementation of the new risk management strategy will be reviewed and extended during the coming year. The charity is also taking steps to ensure that business risk management is an integral part of its organisational culture.

The trustees have identified the key risks affecting the charity and have devised various plans to mitigate against the risks noted below:

- Maintenance of leasehold premises at 40 St. James' Crescent, Uplands, Swansea.
- Impact of Covid-19 long term. To mitigate this risk, as yet unknown, innovative practice has been developed to ensure that support continues for all service users currently engaged and for those newly referred into the treatment system. We are expecting increased alcohol issues identified by individuals who are not known to us due to the impact of Covid-19, and restrictions imposed that have negatively affected mental health and increased isolation and loneliness. We have been fortunate to acquire increased funding from a range of sources to support specific Covid-19 outreach work that we have implemented during 2020-2021.
- Implementation of WCCIS (Welsh Community Care Information System) WCCIS is a single information solution supporting the integrated delivery of innovative, person-centred community health and social care. WCCIS will allow local authorities and community health services to share care records and optimise services for citizens across Wales; as required by the Integrated Health and Social Care, Social Services and Well-being (Wales) Act 2014.

Principal funding sources

Our core work is delivered for four main local authorities – Neath Port Talbot, Swansea, Bridgend and Rhondda Cynon Taf and is funded by a combination of the Welsh Government SMAPF (Substance Misuse Action Plan Fund) and joint commissioning with the Swansea Bay Health Board, Cwm Taf Morgannwg Health Board and Local Authorities through the APB (Area Planning Boards). We deliver a specialist substance misuse service in the Welsh Public Prisons commissioned by the South Wales Police and Crime Commissioner and HMPPS and a specialist young persons substance misuse service funded by the Youth Justice Board. We additionally receive funding from a range of other commissioners including the European Social Fund through Welsh Government, Armed Forces Community Covenant, Supporting People and Families First.

Results

The charity has made an overall deficit totalling £391,141 for the year ended 31 March 2021 attributable to a deficit of £407,591 in unrestricted funds and a surplus of £16,450 attributable to restricted funds. The trustees are confident that steps are being taken to mitigate this risk during 2021-2022 to ensure the charity continues as a going concern.

Reserves policy

The Trustees believe that an appropriate level of reserve for the company is an amount equivalent to providing a 'medium comfort level', equal to three months' salaries, for combined risks as defined by the company's annual financial risk review. This policy and the stated reserve requirement will be reviewed at least annually or more frequently as and when the financial risk review document is updated. Aside from retaining a prudent amount in reserves each year, most of the charity's funds are to be spent in the short term so there are few funds for long term investment.

The Directors may also require the development of an additional 'discretionary' reserve, built up through WCADA's income generation streams, for the purposes of discretionary spending on various projects that arise from time to time to enable WCADA's strategy and objectives to be achieved. This reserve will be clearly separated from WCADA's reserve to cover financial risks.

As at 31 March 2021 the charity had total reserves of £979,924 consisting of a deficit in unrestricted funds of £112,216 and a surplus in restricted reserves of £1,092,540.

Future plans

Adferiad Recovery and the successful implementation of the merger is a priority during 2021-2022 and we will work together to ensure the smooth transfer of staff, services/contracts and assets into Adferiad. The merged organisation will bring together the broad range of skills, knowledge and experience of dedicated teams who are passionate about making a difference in the lives of the people and communities we serve: our aim over time is to use this combined expertise to offer more and help us jointly to provide even better services to clients.

Our main objective continues to be the delivery of effective treatment for people affected by substance misuse and our strap line captures this aim: **'Inspiring Change – Achieving Potential'**. As a consequence of the merger, we have broadened our objectives to include mental health, co-occurring and complex needs in addition to substance use and will consequently have the expertise and reach across Wales and into England to provide a full holistic service for the individuals who need our help.

The PQASSO and Investors in people quality standards are valid for three years, during which time, we will continue to monitor our performance in each of the areas to maintain standards and work towards improving on our existing achievements in 2021-2022.

It is unfortunate that Covid-19 has significantly affected our events calendar during 2020-2021. This has been disappointing, but understandable, for our service users and their families. Safety of all is our priority and we will reinstate these events when appropriate. Events are being planned across Wales during 2021-2022 when restrictions are eased.

We have built good relationships with the Cwm Taf Morgannwg Area Planning Board during the first year of the boundary realignment and worked together to ensure that the service users in Bridgend were unaffected by the transfer and continued to receive the services to meet their needs. This service has been extended to 31 March 2022 and the re-commissioning process is expected to begin towards the end of the Summer 2021.

We will continue to work with the Area Planning Boards to address issues of concern across Swansea Bay and Cwm Taf Morgannwg and will make a commitment to working with our partners and communities to reduce the harms caused by alcohol and drugs in our areas.

The Covid-19 pandemic has significantly affected our activities as with many other organisations. Our early focus was on the wellbeing of staff, volunteers and our service users and we are pleased to report that transmission of the virus has been kept to a minimum. We have a comprehensive Recovery Planning System in place and workforce Covid-19 risk assessments have been completed and regularly reviewed. Our agencies remained open throughout, albeit at reduced opening hours initially, but soon resumed to normal working hours. We have significant supplies of hand-sanitiser and PPE supplies and would like to thank our patron, Michael Sheen, for his generous donation of supplies to the organisation during a time when they were difficult to acquire. We would also like to express our gratitude for the Welsh Government SMAF Winter Fund support that enabled the purchase of essential supplies and equipment during the pandemic. We set up systems for providing support to service users, internal and external meetings and provided all staff with the required equipment to work safely and securely from home and in preparation for any National or local increases in virus transmission and potential further restrictions.

The Trustees are very conscious of the difficult and challenging times ahead. The Coronavirus pandemic has exacerbated many of the problems already facing the sector. WCADA, as part of the new merged organisation, Adferiad Recovery, will be working in both the bidding for such contracts and the delivery of services. Both Hafal and CAIS share the same values, principles and objectives as WCADA and we look forward to the future when we are able to bid for funding to provide more holistic services together to deliver the best possible outcomes for our service users under Adferiad Recovery.

We would also like to take this opportunity of expressing our gratitude to our staff and volunteers for continuing to provide support to our service users, whether at home, or at agency locations. This commitment to making a difference is much appreciated. Gratitude is also extended to individuals who have worked to acquire additional funding to support the specific Covid-19 services we can now provide.

We aim to raise awareness of the enormous body of knowledge that WCADA staff have on substance misuse and its treatment to influence policy, change perceptions and reduce stigma. Building upon the reputation of WCADA, now part of Adferiad Recovery, beyond those who work in the sector is important if we are going to attract the resources and recognition we need to tackle the challenges that lie ahead.

Structure, governance and management

Governing Document

The organisation is a charitable company limited by guarantee, incorporated on 26 April, 2001 and registered as a charity on 25 July 2001. The company was established under a Memorandum of Association which established the objects and powers of the charitable company and is governed under its Articles of Association. The Articles of Association were reviewed during the merger discussions and implementation to ensure future proofing.

Recruitment and appointment of new trustees

All new trustees are members of the organisation and are elected annually at the WCADA Annual General Meeting. The officers are elected from the trustees. All new trustees complete an application form that includes a conflicts of interest section and receive an induction pack, guidance documents and training regarding the roles and responsibilities of being a trustee.

There has been significant change during the latter part of 2020, when our trustees became part of the Adferiad Recovery Shadow Board, with the first formal meeting held on 27 January 2021. Several introductory meetings with the trustees of Hafal and CAIS were held prior to this first official meeting. There have been no changes in our board of trustees during the year and all elected to join the Adferiad Board as we move into 2021-2022. The senior management team values the directors' support, advice and expertise.

Organisational Structure

The trustees delegate decision-making for day-to-day operational issues to the Senior Management Team who work closely with Service Managers and Team Leaders. Quarterly trustee meetings with key staff enable trustees to direct the work of the organisation and receive feedback and reports from staff. The trustees delegate the management of the charity to the Chief Executive, Karen Ozzati, who is supported by the Deputy Chief Executive, Becky Hancock and Senior Managers in HR and Finance. WCADA works closely with other local organisations, jointly delivering services in some cases.

Remuneration of key management personnel

The organisation reviews salaries and expenses every year while setting the budget. As there have been no increases in our funding streams over several years, decisions on increases are dependent upon the Trustees agreeing that the costs can be covered by other sources of funding, or from reserves, designated for this purpose. Four posts have been identified (Chief Executive, Deputy Chief Executive, HR Manager and Finance and Business Development Manager) as key management personnel.

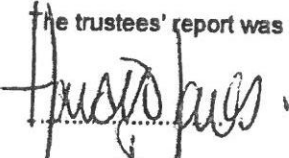

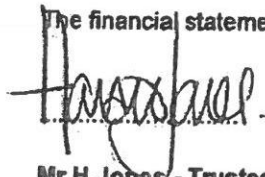

1 Accounting policies

Charity information

Welsh Centre for Action on Dependency and Addiction Ltd is a private company limited by guarantee, incorporated in England and Wales. The registered office is 41/42 St James Crescent, Uplands, Swansea, SA1 6DR, United Kingdom.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charity's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)". The charity is a Public Benefit Entity as defined by FRS 102.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The accounts have been prepared under the historical cost convention modified to include the revaluation of freehold properties. The principal accounting policies adopted are set out below.

1.2 Going concern

The charity transferred all of its assets and liabilities to Adferiad Recovery Limited on 1st April 2021.

The financial statements have been prepared on a basis other than that of a going concern which includes, where appropriate, writing down the company's assets to net realisable value. The financial statements do not include any provision for the future costs of terminating the business of the company except to the extent that such costs were committed at the balance sheet date.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

1.4 Income

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Occupancy and rent charges are recognised in the period to which the service is provided with any amounts received in advance deferred.

Grants are only included in the SoFA when the general income recognition criteria are met.

In the case of performance related grants, income must only be recognised to the extent that the charity has provided the specified goods or services, as entitlement to the grant only occurs when the performance related conditions are met.

Donated goods are measured at fair value (the amount for which the asset could be exchanged) unless impractical to do so.

The value of any voluntary help received is not included in the accounts but is described in the trustees' annual report.

Interest income is included in the accounts when receipt is probable and the amount receivable can be measured reliably.

Turnover is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods and services provided in the normal course of business, net of discounts, VAT and other sales related taxes.

1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

Costs of raising funds comprise the costs in relation to generating income such as fundraising activities.

Expenditure on charitable activities includes all costs relating to the furtherance of the charity's objectives as stated in the trustees report and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

Support costs have been allocated between governance costs and other support. Governance costs comprise all costs involving public accountability of the charity and its compliance with regulation and good practice.

Support costs include central functions and have been allocated to activity cost categories on a basis consistent with the use of resources.

1.6 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following bases:

Freehold land and buildings	2% reducing balance
Leasehold improvements	10% straight line / length of lease
Motor vehicles & equipment	25% reducing balance

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognised in net income/(expenditure) for the year.

1.7 Impairment of fixed assets

At each reporting end date, the charity reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

1.8 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

1.9 Financial instruments

The charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the charity's balance sheet when the charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Derecognition of financial assets

Financial assets are derecognised only when the contractual rights to the cash flows from the asset expire or are settled, or when the charity transfers the financial asset and substantially all the risks and rewards of ownership to another entity, or if some significant risks and rewards of ownership are retained but control of the asset has transferred to another party that is able to sell the asset in its entirety to an unrelated third party.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method.

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

Derecognition of financial liabilities

Financial liabilities are derecognised when the charity's contractual obligations expire or are discharged or cancelled.

1.10 Taxation

As a registered charity Welsh Centre for Action on Dependency and Addiction Limited is entitled to the exemption from taxation in respect of income and capital gains received with sections 478-489 of the Corporation Tax Act 2010 and section 256 of the Taxation of Chargeable Gains Act 1992 to the extent that these are applied to its charitable objects purposes only.

1.11 Employee benefits

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the charity is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

1.12 Retirement benefits

Payments to defined contribution retirement benefit schemes are charged as an expense as they fall due.

1.13 Leases

Rentals are charged on a straight line basis over the lease term.

2 Critical accounting estimates and judgements

In the application of the charity's accounting policies, the trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

27 Related party transactions

Ein Cyfle CIO

The CEO and Deputy CEO are trustees of Ein Cyfle CIO (Charity Number: 1175085), a charitable incorporated organisation registered in England and Wales. The charity issued a loan of £50,000 to the CIO when it entered into a joint partnership along with CAIS and Hafal. This sum is equal to the contribution of the other two charities to effect the equal partnership of all three charities involved in Adferiad from 1st April 2019. This was agreed between the partners to support the continuation of the good work being done with our most vulnerable people by Inroads and The Living Room, two charities at risk of closure.

In 2020 the charity further supported the Adferiad Recovery operations by providing cash funding for the salary costs of the Adferiad Director to support the continuation of service delivery on existing contracts, support the staff and seek new opportunities. This is in line with the other partners support provision. The total cost relating to 2019/20 £34,274. The total cost in 2020/21 was £31,742.

Amounts outstanding at the year end and repayable at a future date totalled £50,000 (2020: £50,000).

Adferiad Recovery Limited

On 1st April 2021 the transferred its net assets to Adferiad Recovery Limited (formerly CAIS). All of the charity's operations will be carried out within Adferiad Recovery Limited from this date.

The charity received a loan from Adferiad Recovery Limited in March 2021 totalling £250,000 to assist the charity in repayment of its bank loan with NatWest. The loan will be settled in 2021/22 when the net assets of the charity are transferred across.

During the year the charity invoiced Adferiad Recovery Limited £396,624 in relation to the Cyfle Cymru and Change Step project. Amounts outstanding at the year end totalled £10,755.

During the year Adferiad Recovery Limited invoiced the charity £730 for database recharges. Amounts outstanding at the year end totalled £125.
