The Charity's management committee meets at regular intervals and is responsible for the strategic direction and policy of the Charity.

The trustees have assessed the major risks to which the Charity is exposed and are satisfied those systems are in place to mitigate exposure to the major risks.

OBJECTIVES AND ACTIVITIES

Objective of the charity

New Life In Christ Ministries – North Yorkshire is a non-denominational, bible based, Christian Church offering religious worship services, bible studies and other community activities on a weekly basis.

Summary of main activities undertaken for the public benefit in relation to these objects:

- We run ministries, teaching seminars and Bible study workshops for adults & children.
- Making disciples and equipping our members for mission work.
- We offer help & assistance to other charities in need who share similar objectives.
- We are working towards having our own property for worship and community outreach.
- Aim to increase the number of our church members, enhance their spiritual wellbeing, and inspire them to engage in community activities that promote stronger community.

The Trustees confirm that they have complied with their duty in section 17(5) of the 2011 Charities Act to have due regard to the guidance on public benefit published by the Commission in exercising their powers or duties.

ACHIEVEMENTS AND PERFORMANCE

Summary of the main achievements of the charity during the year:

- Ongoing provision of professional training for the church musicians and worship team via Zoom.
- Regular leadership team meetings on Zoom.
- Presentation of quarterly financial reports to the leadership team.
- Donations to Compassion UK and some local charitable causes.
- After the lockdown was lifted in September 2021, we used the Harrogate Railway Football Club for our meetings from September 2021.
- Pastor David's contract ended and was not renewed on 1 October 2021, as he and his wife left New Life in Christ Ministries – North Yorkshire.

FINANCIAL REVIEW

Financial review

Income increased by 4% during the year to £59,889 (2020 - £57,755) and expenditure increased by 7% to £63,843 (2020 - £59,407.) This resulted in net expenditure of £3,954 (2020 – net expenditure £1,652.)

Reserves policy

It is the policy of the Charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three to six month's expenditure.

The charity held cash reserves at the year end equating to 6 months expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Charity's current activities while consideration is given to ways in which additional funds may be raised.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The Trustees are responsible for preparing the Annual Report and the Financial Statements in accordance with applicable law and regulations.
