TO PROMOTE FOR THE PUBLIC BENEFIT, IN THE LONDON BOROUGH OF CROYDON AND SURROUNDING AREAS, WITH A VIEW TO THE PRESERVATION OF PUBLIC ORDER, THE PROVISION OF SERVICES DIRECTED TOWARDS MEDIATION, CONCILIATION, RECONCILIATION AND REPARATION, BETWEEN INDIVIDUALS, ORGANISATIONS, OR GROUPS INVOLVED OR LIKELY TO BE INVOLVED IN DISPUTES OR INTERPERSONAL CONFLICT; 2. TO ADVANCE THE EDUCATION OF THE PUBLIC, IN THE LONDON BOROUGH OF CROYDON AND SURROUNDING AREAS, IN THE METHODS OF MEDIATION, CONCILIATION, RECONCILIATION, REPARATION, IN THE NEEDS OF VICTIMS AND OFFENDERS FOR SUCH SERVICES, AND IN THE MEANS OF MANAGING SUCH SERVICES.

**Activities:** To promote for the public benefit, in the London Borough of Croydon and surrounding areas, with a view to the preservation of public order, the provision of services directed towards mediation, conciliation, reconciliation and reparation, between individuals, organisations or groups involved, or likely to be involved in, disputes or interpersonal conflict.
