OBJECTIVES AND ACTIVITIES

Objectives and Aims

The charity aims to provide help and assistance to young deaf children in the surrounding district. This is achieved by the various activities put on by the charity throughout the year. It is hoped that the activities will help in the development of the children and experience a wider choice of activities

Siblings are welcome to participate in activities and support is offered to families through a monthly parent support group and through signing sessions in the family home.

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

Activities Undertaken achieve objectives

We continue to reach out to as many young deaf children as possible and strive to give them a better life experience from the various activities throughout the year. We are looking to develop our programme of events wherever possible.

Main activities undertaken to further the charity's purposes for the public benefit

The Trustees have taken due regard for public benefit. The focus of our activities will remain a programme of events throughout the year to enhance the experiences of young deaf children. The activities help their self-confidence and social skill. All are welcome and we continue to reach out to as many young deaf children as possible within our district.

Achievements and performance

We set out in Our Mission Statement that the aim of our charity is to encourage our deaf children and young people to become confident and independent.

We have been able to provide a range of different activities in which they socialise and improve their communication skills. Parents and carers report back on the progress shown and praise the support they are given

Financial Review

1 ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

1 ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2109)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

The financial statements have been prepared on a going basis. The trustees have reviewed and considered relevant information, including the annual budget and future cash flows in making their assessment. In particular, in response to the COVID-19 pandemic, the trustees have tested their cash flow analysis to take into account the impact on their business of possible scenarios brought on by the impact of COVID - 19, alongside the measures that they can take to mitigate the current adverse conditions, and the current resources available, the trustees have concluded that they can continue to adopt the going concern basis in preparing the annual report and account.

Income
