Activities

Objects: (1) THE ADVANCEMENT OF RELIGION. TO PRESERVE, MAINTAIN, REPAIR IMPROVE, AND BEAUTIFY THE PARISH CHURCH OF ST GEORGE HANWORTH PARK IN THE COUNTY OF MIDDLESEX AND ITS CONTENTS INCLUDING GLASS, MONUMENTS, BELLS AND ORNAMENTS . (2) THE PRESERVATION, MAINTENANCE, AND ENHANCEMENT OF THE CHURCHYARD, ITS WALLS, RAILINGS, LYCH GATE, LIGHTING, TREES, SHRUBS, MONUMENTS, PATHS, AND THE PROVISION OF FURTHER FACILITIES. (3) THE PRESERVATION OF THE GEORGIAN RECTORY, ITS GROUNDS AND OUTBUILDINGS AND THEIR ENHANCEMENT AND DEVELOPMENT FOR WIDER USE, IN THE LONDON BOROUGH OF HOUNSLOW, THE DIOCESE OF LONDON, AND THE PARISH OF ST. GEORGE'S HANWORTH PARK.

Activities: Operates in the London Borough of Hounslow, specifically the area around Hanworth Park. Activities: fundraising to preserve and promote the built heritage around Hanworth Park, specifically: St George's Church, St George's Church Yard, Tudor Walls, Tudor Stable Block, Georgian Rectory, Hanworth Park House. Educational activities to raise the profile of local heritage in the community.
