Objects: FOR PROMOTING AIDING AND FURTHERING THE OBJECTS AND WORK OF THE CHURCH OF ENGLAND IN THE PARISH OF BRODSWORTH¹. THE AUGMENTATION OF THE ENDOWMENT OF THE CHURCH². THE REPAIR MAINTENANCE AND UPKEEP OF THE CHURCH AND ITS FURNISHINGS AND ORNAMENTS³. THE UPKEEP OF THE SERVICES OF THE CHURCH INCLUDING THE EXPENSES OF THE ORGAN AND CHOIR THEREOF⁴. THE PAYMENT OF THE EXPENSES REPAIR IMPROVEMENT AND UPKEEP OF ANY CHURCHYARD OR BURIAL GROUND FORMING PART OF THE CHURCH AND ADAPTING THE SAME FOR USE FOR SUCH PURPOSES AND THE PAYMENT OF ALL RATES TAXES INSURANCE PREMIUMS AND OTHER OUTGOING OF WHATEVER NATURE PAYABLE IN RESPECT OF THE CHURCH⁵. ANY OTHER CHARITABLE PURPOSES FOR THE BENEFIT OF THE CHURCH AS THE TRUSTEES SHALL FROM TIME TO TIME APPOINT OR DECIDE

Activities: The Trust exists to support the maintenance, upkeep and preservation of the medieval church of St Michael and All Angels, Brodsworth, near Doncaster. St Michael and All Angels is a Grade II* listed building which serves both its traditional parish of Brodsworth and a wider community of visitors and friends.
