St Charles PTA increasingly relies on the running of several large time-consuming events/activities throughout the year which each raise a significant amount of funds. Other large events that took place during the year were the Christmas Market (£8,160), the Summer Fair (£4,969) and the Quiz night (£3,262).

We also ran several other events/activities such as Cake Sales, Year Book sales, the ongoing Elmbridge Lottery a handful of smaller events /activities all bringing a combined amount of £4,508.

The total amount raised for the year was £20,900, exceeding the annual target* of £17,500 by 20%.

As a result of the significant PTA reserves built up over previous years the PTA was able to meet its commitment to the school of £17,500 for IT funding.





The PTA introduced a new event this year, in conjunction with the board of governors – the Governors Ball, which raised £3,162 for the PTA, which comprised half of the total proceeds from the event. Other large events that took place during the year were the Christmas Market (£8,545), the Football Tournament (£3,507) and the Quiz night (£2,423).

We also ran several other events/activities such as Cake Sales, Year Book sales, the ongoing Elmbridge Lottery a handful of smaller events /activities all bringing a combined amount of £6,491.

The total amount raised for the year was £24,128, exceeding the annual target* of £17,500 by 30%.

As a result of the significant PTA reserves built up over previous years the PTA was able to meet its commitment to the school of £17,500 for IT funding plus a donation of £16,168 for new laptops.



Achievements and performance

Summary of the main achievements of the charity during the year

St Charles PTA increasingly relies on the running of several large time-consuming events/activities throughout the year which each raise a significant amount of funds. Unfortunately, due to the COVID-19 pandemic and the resultant lockdown from 20 March 2020 to the end of the school year, a number of events that are normally on the school calendar were not able to take place, including the Easter and Summer Fair events. Instead the PTA invited children to participate in the Holt 50 challenge, commemorating the Headteacher's 50th birthday, and encourage family and friends to make a donation to the PTA. This event raised £8,506. The other large events taking place during the year were the Christmas Market (£4,117), the Christmas Raffle (£2,710) and the Summer Auction (£2,116). In total these events raised £17,449. We also ran a number of other events/activities such as the Quiz, Secret Santa, Year Book and the ongoing Lottery (previously run by St Charles PTA; now we partake in the Elmbridge Lottery) which each had an income of between £1-2k and a combined amount of £5,311. In addition, there were a dozen or so smaller events /activities undertaken through the year.

The total amount raised for the year was £25,723, exceeding the annual target* of £17,500 by 47%.

As a result of the significant PTA reserves built up over previous years the PTA was able to meet its commitment to the school of £17,500 for IT funding plus £243 for the leavers gifts.


