Reports

Chair of Trustees Report:-

This year has been a very stable one. The Centre is busy on Saturdays and operating in much the same way as it did before the covid pandemic; Trustee meetings have returned to face to face meetings – with some trustees attending by zoom on occasion. The Trustees have met regularly and routinely to provide governance and support. We were fortunate to have the support of Simon Rivers to finalise last year's accounts and this year's as well. We are grateful to him for his involvement and experience.

There was a break-in to the church and Neutral Ground office in November 2022 which was distressing, created inconvenience and resulted in the loss of some Christmas presents being collected for our children. More importantly, there was a fantastic response from the local community which resulted in donations and offers of support which completely outstripped the losses incurred.

More positively, a nursery has now begun to operate from the William Temple community hall, new security doors have been fitted and the outdoor football area is up and running again. We have received a Good Hygiene rating 5. These, together with steady financial support and a stable group of Trustees and volunteers, have meant that we have had a successful year supporting local families and consolidating links with our partners.

As we approach our 30th year, I would like to remember Pam Rackshaw our first co-ordinator who did so much to establish our ethos and set Neutral Ground on a stable footing and who was above all else a kind and compassionate person with an unending focus on the best interests of our children. Similarly, we have been so fortunate with her two successors, Liz Cutajar and Gemma Smith: Liz brought strong values, organisational skills and understanding of the roles of volunteers and Gemma has given us her fresh perspective, modernisation and community focussed approach. We are fortunate to have Liz's continuing involvement and expertise in her role as a valued Trustee.

Finally, I would like to thank all the Trustees and volunteers for their amazing and unerring work for our families and children over this year and reaching back over the last

30 years. Their dedication has made Neutral Ground a successful, flexible and resilient centre adding to the quality of life for our local children.

Reports

Chair of Trustees Report

This year began well with a very positive accreditation report from The National Association of Child Contact Centres and the gradual relaxing of covid restrictions which has meant that over the year we could offer a more flexible service to more families. The pandemic continues to cast a long shadow, however, and we are not sure when we will reach a 'new normal' and what that may look like. Some families continue to feel unsafe about mixing with others.

There has been a continued increase in the number of referrals received over the past year, perhaps due to the stresses of lockdown or financial burden. We will continue to work within the government restrictions to be able to offer more families the chance to have contact. One positive outcome has been that some long term families have found the confidence to develop alternative arrangements and have managed to sustain them moving forward.

We have also been pleased to see some volunteers move on actively using their experience with Neutral Ground in the new challenges they have taken on. In addition, we have recruited new volunteers who are settling in well.

The loss of legal aid has continued to have a huge impact on people wanting to access our centre, as we offer a free service that many people would struggle to afford contact in other settings. At the beginning of the financial year, CAF/CASS wrote out to Contact Centres across the country with a rather disconcerting and unhelpful letter suggesting that they were reviewing their commitments and support to Contact Centres. Thus adding to the uncertainty and precarious feeling that some Centres are experiencing. Fortunately, we are long established and have the support of a number of organisations which put us in a good position to weather such storms. We will of course keep a careful eye on developments as it is vital for Contact Centres to have good relations with CAF/CASS.

In September, William Temple Church gained a new vicar, Rev Ruth Turner, who has subsequently joined our Board of Trustees and provided a welcome new perspective and enthusiasm for our work.

As ever, the Trustees have met regularly through the year and reviewed developments as we have gradually re-extended our services and ensured that we continue to have the appropriate protocols and policies in place. I finish with three quotes from our NACCC accreditation report received in April 2021 at the very beginning of this accounting year:

“The centre has demonstrated that all have worked hard to encourage parents to use the centre as a stepping stone to enhance the quality contact time children have with their absent parent and to improve their own communication between each other.”

“It is clear from the assessor meeting parents, children and volunteers that Neutral Ground offers an invaluable service for those families that have attended and presently attend.”

“A great amount of commitment and hard work by the coordinator, volunteers and committee members have ensured the centre is well staffed, supportive, available, welcoming, inviting to all who use the service.”

Report from Co-ordinator.

After my fifth year at Neutral Ground I would once again like to thank the Trustees and the volunteers for the continued love and support they have shown me.

Since our last AGM we have worked hard to get through our waiting list and regain the atmosphere and families we had at our centre before COVID-19.

In September 2021 we removed our contact pods and introduced lateral flow tests for volunteers and visiting adults. This allowed us to return to a more communal contact session format allowing us to offer increased spaces for contact visits while ensuring the safety and wellbeing of all involved.

We continued to temperature check the children visiting their parents and handwashing and mask use remained in place.

We have continued to offer virtual contact to families who are isolating, offering zoom conference calls for parents needing advice and support.

In addition to our working relationship with Fare Share; we have made a link with Greggs and now collect unsold food on a Tuesday and a Friday. This helps to feed both our volunteers and families. We have also donated this food to local ambulance stations and the fire brigade if we have too much. The local adventure playground in Plumstead have also benefited from us having the excess food. In return we have given some families information about our centre.

September also saw the arrival of our New Vicar and Volunteer/Trustee Ruth Turner.



At Christmas we received many donations of advent calendars & Selection boxes from supporters of Neutral Ground to distribute to our families.

We have seen an increase of 2 new volunteers so far this year; and 2 of our volunteers were successful in their adoption journey and have moved on.

In June we had a group of 20 American students from European Cultural Experiences Ltd. They were directed to us by Volunteer Centre Greenwich. They worked hard to transform our garden area and fill our sandpit with sand.





We look forward to meeting our new families and the continued success of Neutral Ground Child Contact Centre.
