**Objects:** THE OBJECTS FOR WHICH THE COMPANY IS ESTABLISHED ARE FOR THE PUBLIC BENEFIT TO PROMOTE THE EDUCATION OF CHILDREN IN ACCORDANCE WITH THE MONTESSORI METHOD OF EDUCATION IN PARTICULAR BY: (A) PROMOTING EDUCATION AND TRAINING IN THE MONTESSORI METHOD AND ESTABLISHING AND ENGENDERING, ESTABLISHING AND MAINTAINING, SUPERVISING, CONTROLLING AND PROMOTING STANDARDS IN THE MONTESSORI METHOD AND IN PARTICULAR MONITORING THE CONDUCT OF MONTESSORI EXAMINATIONS. (B) MODERATING THE EXAMINATIONS OF THOSE WHO ARE BEING TRAINED IN THE MONTESSORI METHOD AND MODERATING ANY OTHER FORMS OF ASSESSMENT LEADING TO AN AWARD OF A MONTESSORI DIPLOMA, SO AS TO STANDARDISE THE CRITERIA BY WHICH PROSPECTIVE TEACHERS OF THE MONTESSORI METHOD ARE EXAMINED WITH SPECIAL REGARD TO ENSURING COMPETENCY AND GENERALLY TO SET PREREQUISITES AS TO THE SUPERVISION AND CONDUCT OF EXAMINATIONS FOR MONTESSORI DIPLOMAS AND GENERALLY ANY OTHER CRITERIA SET TO REGULATE THE COMPETENCY OF TEACHERS OF THE MONTESSORI METHOD. (C) PROMOTING GOOD PRACTICE AND STANDARDS IN MONTESSORI SCHOOLS, AND AWARDING ACCREDITATION IN RECOGNITION OF SUCH.

**Activities:** To raise and maintain standards in authentic Montessori provision nationally. M.E.(UK) has instituted an accreditation system for Montessori nursery schools. M.E. (UK) holds an annual Accredited Schools' Day and an annual National M.E. (UK) Conference. These contribute to Montessori practitioners' professional development. Trustees meet with government bodies concerning Early Years Education.
