Objects: (I) THE ALLEVIATION OF POVERTY AND THE AMELIORATION OF THE DESTITUTE, AS DEFINED HEREIN, INITIALLY WITHIN THE MUNICIPAL PARAMETERS OF MIRPUR CITY, PAKISTAN, AZAD KASHMIR;(II) WITHOUT PREJUDICE TO THE GENERALITY AND THE MULTI-DISENSICAL ASPECTS OF THE ABOVE, AND MORE SPECIFICALLY TO;(A) PROVIDE THE ESSENTIAL FOOD, CLOTHING AND SHELTER TO THE DESTITUTE;(B) TO PROVIDE FINANCIAL SUCCOUR TO THE DESTITUTE;(C) TO PROVIDE FREE MEDICAL CARE FOR THE DESTITUTE;(D) TO PROVIDE FREE AMBULANCE FOR THE DESTITUTE;(E) TO PROVIDE FREE EDUCATION TO THE CHILDREN OF THE DESTITUTE;(F) TO ASSIST FINANCIALLY THE DESTITUTE IN THE CONTEXT OF THEIR CHILDREN'S MARRIAGES;(G) TO ASSIST IN THE TRACING AND RECOVERY OF MISSING PERSONS;(H) TO ESTABLISH AND OPERATE DISPENSARIES AT THE TEHSIL (DISTRICT) AND DISTRICT HEADQUARTERS IN AZAD KASHMIR;(I) TO ARRANGE FOR THE TRANSPORTATION OF THE DEAD BODIES OF THE KASHMIRIES FROM ISLAMABAD AIRPORT;(J) TO ESTABLISH AND OPERATE A CONTROL ROOM FOR THE CO-ORDINATION OF THE VARIOUS FUNCTIONS AND ACTIVITIES OF THE TRUST; AND THE EXPEDITIOUS PROVISION THEREOF;(K) TO ACCOMPLISH THE AFORESAID PURPOSES AND OBJECTS OF THE TRUST THROUGHOUT THE TERRITORY OF AZAD KASHMIR.
