PROVIDED ALWAYS THAT THE PERFORMANCE OF ANY ACT BY THE CHARITY IN THE ACHIEVEMENT OR PROMOTION OF THE OBJECTS SHALL ONLY ENHANCE (AND NOT REPLACE OR BE IN SUBSTITUTION FOR) ANYTHING FOR WHICH PROVISION IS MADE BY STATUTORY AUTHORITY.
