The Coronavirus Pandemic had a huge adverse effect on the Charity, resulting in the closure of the hall for the greater part of the year. Income was down by £5,000 but thanks to government grants we have been able to absorb the losses.

We wish to build an extension to the hall to enable the chairs and tables to be stored away from the stage. This will free up the stage for use and also make it easier for hirers to access the tables and chairs from ground level. We obtained a lottery grant of £10,000 towards the cost and hope to start building in 2021
