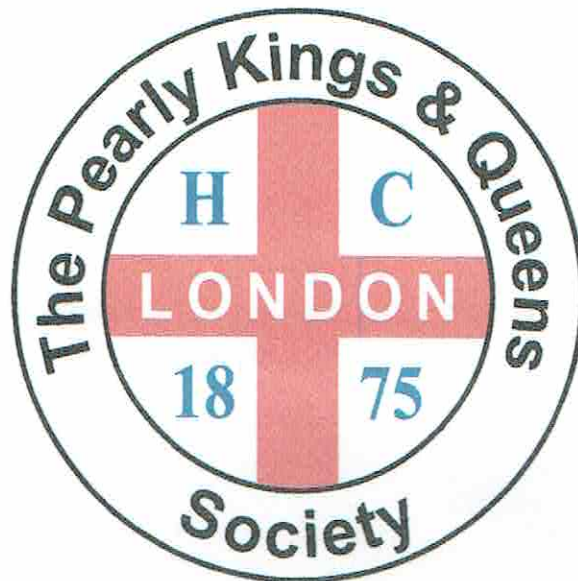

### STATEMENT OF TRUSTEE'S RESPONSIBILITIES

The Trustees present their Trustee's Annual Report (TAR) together with the financial statements of the charity for the year ending 31 March 2025 which are also prepared to meet the requirements for a Trustees' report and accounts in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the charity and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently these accounts do not express an audit opinion on the view given by the financial statements.

The financial statements comply with the Charities Act 2011, the Memorandum and Articles of Association, and Accounting and reporting by Charities: Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102).

#### **Our purpose and activities**

The Society was established particularly for the benefit of persons in the Greater London Area and Home Counties, to relieve poverty and sickness and for such other charitable purposes as the Trustee's, shall from time to time, determine.

#### **Organisation**

The board of trustees administers the charity and meets at least twice a year in addition to the monthly meetings of the members. At these meetings there is discussion on financial affairs, administration and any other requirements as outlined by the charity commission.

#### **Trustee induction and training**

New trustees undergo an orientation meeting with the Chair and/or senior officer to brief them on: their legal obligations under charity; the Charity Commission guidance on public benefit; and inform them of the content of the Memorandum and Articles of Association, the committee and decision-making processes. An Induction Handbook was produced and adopted in this 23/24 year to aid the induction and help with the charity governance.

#### **Risk management**

The trustees have a risk management strategy which comprises:

- Meeting once a year to review the principal risks and uncertainties that the charity currently faces. The establishment and review of policies, systems and procedures to mitigate those risks identified in the annual review; and
- The implementation of procedures designed to minimise or manage any potential impact on the charity should those risks materialise.

### **Finance/Funding Strategy**

The financial management of the charity is very important to us all and we have great transparency in how and where our funds are allocated. As a charity we are keen to ensure that our mission and objectives are fully met. During the current year, the Trustees undertook their annual review of systems, it was agreed that the procedures remain the same, i.e. operating from a Reserve Account, a Main Account plus a Working Account and reporting on this monthly to members.

Additionally, the LPK&Qs have income streams from 1 x Worldpay, 2 x SumUp handset machines which are used for collections made by card rather than cash, and a PayPal account which is actioned by a QR code.

### **Reserves Policy**

An unrestricted reserves policy is drawn up each year on the appropriate use of accumulated funds. The Treasurer and Trustees examine ways of ensuring that there is appropriate 'contingency' funding to support the committed expenditure costs by producing a budget for the on-coming year.

### **The Future**

Following yet another busy and successful year the LPK&Qs were delighted to welcome three new members to our Society, Evie, Evette and Jasmine our new Pearly Consorts. It is so wonderful to know that we are taking positive action to keep this wonderful tradition alive.

### **Staffing and Volunteers**

There are **no paid** staff in the LPK&Qs charitable society, the society is run and supported exclusively by volunteers. All volunteers undertake tasks at their own expense and as such the Trustees welcome every opportunity to thank this dedicated team of individuals. Our volunteer Pearly Kings, Queens, Princes, Princesses, Prides and Consorts, are wonderful people who go above and beyond any expectation of them.

It appreciated that each year we have this opportunity to record our thanks and gratitude for all the hard work and dedication of all our members, each and everyone is so important for the continuance of this wonderful tradition. Without this dedication we would have no funds to distribute to charitable causes, to all our members – *Thank you.*

### TRUSTEES ANNUAL REVIEW - (TAR) ACTIVITIES, ACHIEVEMENTS AND PERFORMANCE

The Society envisage the engagements in 2024 to slow down having followed the once in a lifetime event of the past two years, we were wrong. Delivering over 200 sessions we were amazed to have increased income!

- **New Consorts** - As mentioned above we welcomed three new Consorts, Evie, Evette and Jasmine, who all bring positive skills and attributes to our society – welcome.
- **Social Media/Public Relations** - Further improvements on our social media were made and Evie generously volunteered to take on the running of our Instagram page. Amongst many 'stories' please seek out the video marking International Women's Day, it is a wonderful collection.
- **New PayPal account and QR Code** - The new QR coded has been incorporated into our leaflets and went live early in 24/25.
- **Card Reader machines** – Having acknowledged the positive impact of our card machine, it was agreed to research the best provider and to purchase two more readers, this is already showing positive outcomes.
- **Portobello Road** – With huge thanks to John D, a collecting opportunity was secured at Portobello Road, this has been great fun with several collecting dates delivered so far.
- **The Sweeps Festival** - mentioned last year was also attended again and this time our members were officially recognised by having a stage presence! Thank you to all the people in Rochester offering their support with donations.
- **Harvest Festival** – this was yet again another success, we had identified a new venue for the reception, The Lord Raglan was an excellent setting for the after-event celebrations. We would also like to thank Gemma, her family and friends for undertaking the whole catering on our behalf, the feedback from the mayors and other dignitaries was extremely positive.
- **Other regular diary events** - The Faversham Hop Festival, Annual Boat Party, Harvest Festival, Mad Hatters Tea Party, and the St. George's Day in Trafalgar Square all took place with great attendance by our members. Please see our website for updates on these events for 25/26.
- **Finally** – We are delighted to report that we achieved charitable status with Microsoft, this will have provided the charity with numerous benefits and access to training events.

### Principles for our work

The charity is administered by a Trustee Board, consisting of elected officers, Chair, Secretary, Treasurer and four other members of the Society's Management Committee and it is their intention to maintain the charity principles in the same vein as the Pearly founder Henry Croft who raised funds to primarily support the needy and the sick.

### **Collecting**

We had not expected it but we found that 2023/234 was just as busy as the year before. At the latter end of the year, thanks to John Dowell we secured a new collecting site in Portobello Road. Over the year we undertook **68** collecting sessions (previous years **50, 26, 73** respectively). Key venues for collecting were Covent Garden (every third Sunday of the month), Brick Lane (first Sunday in the month) and Polhill by prior appointment. The Greenwich Market sessions, Brick Lane sessions have fallen off, the members will be looking strategically at collecting over the coming months.

### **Events**

As mentioned above we were engaged for many Jubilee events the increase was exceptional and is unlikely to be matched for some time. In the period we delivered **40 sessions** (previous years **56, 10, 63**), a summary of these events is available on request.

### **Presentations**

Presentations for 2024/25 period were **58** (previous years **29, 10, 37**), a further increase which marks an increase in our work in care homes, and other groups such as Women's Institute (Wis), University of the 3<sup>rd</sup> Age (U3A) and the Active Retirement Groups (ARAs).

### **Miscellaneous fundraising**

We had **34** miscellaneous sessions during the period (previous years **10, 5, 30**).

### **Thank you**

The trustees wish to record their thanks for the effort and work undertaken by our Pearlies in achieving this amazing body of work, a total of **200 delivery sessions** (previous year **145, 51, 203**). Total income generated in the period was **£35,344.34 compared to £25,674.93** in the previous year. Please note this is inflated due to two years backdated Gift Aid £4410.28. However, taking this into account there is still a substantial increase on funds raised, again we thank all our members in achieving this.

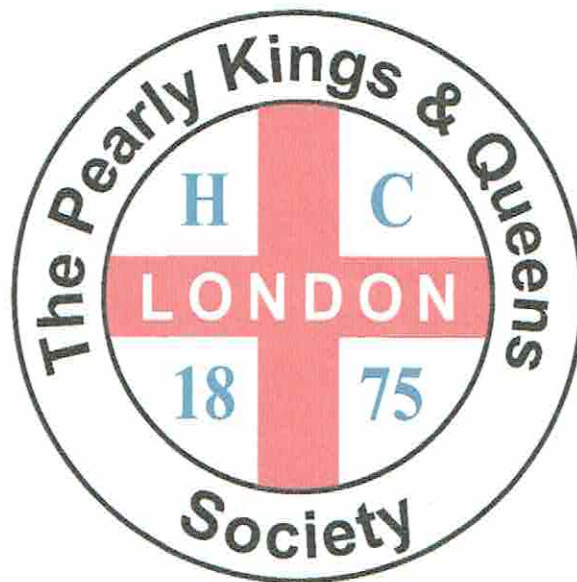

As recorded in 22/23 accounts, the recommendation to add at least one additional signatory should be finalised. In December 2023 PH was requested to close the original account.

An unrestricted reserves policy is drawn up each year on the appropriate use of accumulated funds. The Treasurer and Trustees examine ways of ensuring that there is appropriate 'contingency' funding to support the committed expenditure costs by producing a budget for the on-coming year. In line with last year's external examiners recommendations we were able to make donations beyond our income and utilised some of the reserve that had been accumulated during lockdown. Please see the summary accounts at the end of this report for full details.

The LPK&Qs go forward yet again with an uplifted spirit as we welcomed another new member John Dowell as our new Pearly Consort.





#### **TRUSTEES ANNUAL REVIEW - (TAR) ACTIVITIES, ACHIEVEMENTS AND PERFORMANCE**

We commenced our volunteering activities with great enthusiasm in 2023. Following the most extraordinary year of ups and downs we commenced a number of engagements involving the coronation of the new King.

- During this period we successfully registered for Gift Aid and as we could go back three years we had a first drawn down of £579.38.
- Our Pearly Consort Gail became Queen of Bexley, a first time Queen for the borough
- As mentioned above we welcomed John Dowell as Pearly Consort
- A new website was set up to reflect the requirements of the Charity Commission and we were supported pro-bono by SME Solutions. SME have supported us in submitting a bid to the Lottery for support with uplifting our website and IT needs.
- A New multi signatory PayPal was set up in the final quarter of the year and it is hoped that we will be issuing a new QR code for literature in the coming year
- Sweeps Festival – A return Rochester for this festival by the Pearlies after many years (thanks to Gail), we are scheduled to appear again in 24/25 and we look forward to reporting on this next year.
- We were delighted to be invited along to the St. George's Day event in Trafalgar Square by City Hall, an event enjoyed by all.
- Last but not least our wonderful Harvest Festival returned, it was a great event after being away due to Covid and very apt as it was our 25<sup>th</sup> anniversary of the event. We engaged the same format and evaluated the day as a great success after listening to the members of public and dignitaries who attended.
