The Charity is governed by a Trust Deed dated 2 January 2002.

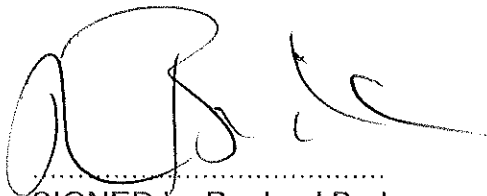
The objects of the Charity are general charitable purposes, educational training and the relief of poverty.
