**Activities:** TO ACQUIRE & HOLD FREEHOLD OR LEASEHOLD LAND OR ANY OTHER INTEREST OR RIGHT IN LAND IN PARTICULAR THE AREA KNOWN AS DURDHAM DOWN BRISTOL FOR THE PROTECTION & PRESERVATION OF ITS NATURAL AND ECOLOGICAL FEATURES INCLUDING PRESERVATION & PROTECTION OF PLANT LIFE FOR THE BENEFIT OF MEMBERS OF THE PUBLIC GENERALLY WITH A PREFERENCE FOR THE INHABITANTS OF THE CITY OF BRISTOL & ITS NEIGHBOURHOOD.
