TO PROVIDE ONE OR MORE RESIDENTIAL HOMES, ASSOCIATED AMENITIES AND CARE SERVICES FOR CHILDREN AND ADULTS SUFFERING FROM PHYSICAL AND/OR MENTAL DISABILITIES AND WITH ASSOCIATED SPECIAL NEEDS IN ENGLAND AND WALES.

**Activities:** Birtenshaw operates a special school, college, eight specialist children's homes, including a short break centre, and provides domiciliary care & therapies. The charity supports children, young people and young adults who have a moderate to severe learning disability, including Autistic Spectrum conditions and those with a significant physical disability/impairment including complex health needs.
