During the period under review the charity has been able to provide a significant amount of donations back to the school. A significant part of the fundraising activities were towards a new timber trail for the playground, this was purchased in the 24/25 school year.

Significant amounts donated to the school during the year under review included new Ipads for classes and beginning to fit out a media suite for pupils.

Whilst the charity has held a cash balance over recent years, we work closely with the school senior management team to ensure that there is a plan in place to spend funds. However, as with the timber trail, at times a significant amount of money is required to complete a project and therefore monies must be held during this time.


