The charity is committed to providing humanitarian relief, primarily in the form of healthcare to impoverished people in the region of Jhelum, Pakistan. Its guiding principle is to alleviate the suffering of those who do not have the financial means available to have their basic healthcare needs attended to.

- To date, over the past 11 years of operation, the charity has undertaken many successful activities, such as the ones listed below:
  - Eye camps offering check-ups and treatment
  - Vaccination of children against polio and other fatal diseases
  - Distribution of 5 truck loads of food and clothes for the victims of the Pakistan earthquake in 2005
  - Teaching facilities for 114 orphan children at a village school
  - Arranging of a free dental camp where over 100 patients have been treated
  - Opening a kidney care centre and general outpatients clinic (1200 square yards of land donated by a local farmer) at Thati Gujran, Jhelum.
  - Aid provided to the victims of the flood in Pakistan in 2010.
