TRUSTEES' REPORT 2024-2025

1. The Objectives

- (1) The advancement of the Christian Faith in accordance with the statement of Doctrines in the Trust Schedule and, in particular, by the provision of Christian literature in various media.
- (2) The promotion of any other charitable purpose the benefit of the community of Mid and West Wales by the advancement of education, the protection of health and the relief of poverty and sickness as an expression of the Christian Faith.

2. Strategies, Activities and Achievements in view of these Objectives

The Centre has striven to keep the above objectives in mind as it has worked through the year. The general pattern is as follows:

- the Centre is open five days a week, closed on Sundays and Mondays, as the footfall on Mondays was much lower than Wednesdays, traditionally the other day we were closed and traditionally a half-day shopping closure in Lampeter (the Church Ladies' Meeting is now held there on Monday mornings too instead of Wednesday mornings); this change – closing on Mondays and opening on Wednesdays – has continued to be most beneficial to the Centre as it has continued to be much busier; opening hours are between 10.00 a.m. and 4.00 p.m.; the staff always pray together before opening and after closing
- generally the footfall has quite substantially increase this last year and this has been most pleasing and encouraging; as before, from time to time we catered for groups/parties who arranged to come for lunch or tea on special occasions such as birthdays; we also catered for weddings, funeral teas and for special day and evening events; we were very busy in 2024 again with Christmas Dinners
- the Christian Bookstall and the Cwtsh (the area where a variety of other materials are available) have continued to be the focus of many visits, enquiries and sales; this service continues to be enhanced by the substantial second-hand Christian books' service located on separate shelving; (sales from these areas during the last year have been steady throughout)
- we provide a free Wi-Fi service to customers
- again as a result of the building of a church next door, Lampeter Evangelical Church, advantages have accrued to both the church and the Centre as they continue to liaise well together – services at the church are followed by our opening the Centre so that people may have further more informal fellowship together and this has proved to be very popular; the completion of the church building means that the

accommodation on the first floor of the building has been refurbished – one flat continues to be occupied and another part of the accommodation is provided for members of the church who have returned from the mission field in Kenya to live in Lampeter for some time – they are providing voluntary help to the church and the Centre; though the Church and the Centre are two independent charities, many of the church's trustees are also trustees of The Lampeter Christian Centre; a legal agreement has been drawn up by means of which access from one entity to the other is acknowledged, in order to facilitate co-operation in promoting the Gospel in the town and community; the new large patio built at the back of both properties in 2020-2021 has continued to be a worthwhile investment and a distinct improvement on the precious smaller patio, new furniture was purchased and all this has been much used and appreciated by clientele

- the Centre continues to be regularly used by a variety of groups or societies during the daytime e.g. a Knitting Group supported by Lampeter Evangelical Church has been meeting every month to provide for those in need, Reading Group, Knits and Natters, Sewing Group, a Chess Club, Multiple Sclerosis Group, Ramblers' Association, men's group, a women's group and Bible Study groups
- the Centre is used from time to time in the evening, outside of ordinary hours e.g. various groups who ask for food to be served, training and professional development events, cookery demonstrations etc.; alas, the University in Lampeter has closed its campus, so the number of students involved with The Mustard Seed has declined; however, there are designs by the Local Authority to establish the campus as a Centre for Vocational Education, so we might well benefit from this development
- staffing: there are still a good number of volunteers, including some with special needs, who contribute substantially to the workforce, but there are also a number of individuals who are paid for their services: we now employ a number of nearly full-time employees as well as other part-time individuals; five of the staff are currently on the pay-roll
- procedures for the safekeeping of foodstuff etc. are carefully adhered to, and the Centre has already received many different awards for its standards of food and hygiene; we are glad to report that this last year the previous grade 4 was improved to the top grade, a grade 5
- the Centre is closed for an extended period of time only between Christmas and the New Year, usually for approximately ten days; a general cleaning and maintenance programme is undertaken at this time; this is apart from the ongoing maintenance that arises as necessary from time to time; the general décor is important to maintain and is well respected (all areas over the last few years have been refurbished); this has led to further improvements and the general ambience of the Centre is much appreciated by customers

- we try to maintain the building to the highest standards possible: there have been many improvements to certain aspects of its fabric during the year – this has actually been helped by the building of the church next door - and all the necessary repairs have been carried out promptly
- the Trustees confer and plan with one another and once a year hold an A.G.M. (the last one was held in February 2025 and we envisage holding our next one early in the New Year); minutes of these meetings are kept; the meetings keep eyes focussed on strategy (in line with the objectives) as well as giving attention to the operational everyday matters; the Trustees also over many years met monthly for Prayer Meetings before Covid - the disruption caused by Covid however means that these have not yet managed to be reconvened
- from time to time consideration is focussed on giving to charities, whether they be local good causes or known international Christian organisations , or even individual Christians or people in need (e.g. we provide support for one child's educational needs in a third world country through a Christian Charity, Compassion); our financial position continues to be generally sound and indeed has continued to be more encouraging in 2024-2025; though meeting the increases in the Basic Wage and National Insurance have brought some challenges, we seem to be coping very well
- in January 2017 we came on-stream with regard to workplace pensions enrolment; four members of staff continue to be on this scheme
- we are members of the Lampeter Chamber of Trade and get involved in all the various community events that they arrange throughout the year; this has allowed us to contribute and play our part fully this year again in the local community; meetings are held on a monthly basis
- the Centre works entirely bilingually, through the use of both Welsh and English languages.

3. Future Plans

Several issues have been discussed and will continue to need further attention again this year:

- we still continue to ponder whether we should appoint a manager (from amongst our full-time/nearly full-time employees) who would further our attempts to meet the objectives delineated in our Charity Deed document; we have already given further responsibilities to some of those individuals in order to relieve Trustees and to make fuller use of employees' varied skills; we continue to need a succession plan however and one substantial step in that direction has been the election of a new, younger Treasurer this year
- there would be an advantage in increasing again the number of Trustees, although there are six Trustees at present – such an increase would further complement the skills and experience of the existing Board of Trustees

- the enhancement of Christian counselling and support
- continually improving the premises by means of further developments and possible light refurbishments, renewal of equipment and the use of further strategies to reach out to people in the community; the standing of The Mustard Seed we feel has been enhanced by the building of the church next door and we are often visited by groups who want special teas provided **along with a guided tour of the church**; we are confident that this will be a continuing element into the future.

4. Finances

Great care is taken with accounts, but naturally finances – as suggested from the above arrangements and activities – are used to further the Centre’s objectives.

The following comments need to be noted:

- regular use is made of a professional accountant to help with the Centre’s financial obligations
- payment is made each year for the Centre’s accounts to be audited
- the Treasurer regularly liaises with the accountant and trustees and matters are discussed openly and thoroughly
- we have a well-established website
- our card facility (debit and credit cards) introduced some years ago has undoubtedly enhanced the service provided by the Centre
- sums of money are sent to Christian charities and individuals every year, at local, national and international levels, including missionary work, as noted above.

5. Conclusion

In view of the above, the Trustees would like to express their gratitude to the Officers of Lampeter Christian Centre for their faithful adherence to the terms of the Trust.

We are encouraged that the Centre continues to flourish and meets its responsibilities to bring the Gospel of Jesus Christ to the local community whilst also facilitating local and world-wide missionary movements and associations, charity groups and support for individuals. We are satisfied that the accounts have been kept to the highest standard and that all transactions have been carried out with the utmost integrity. Money has been prudently used to pursue effectively, efficiently and successfully the Centre’s stated objectives.

We trust that the Centre will continue to know much blessing in the future and are very happy to endorse the vision that we as Trustees have to continue the strengthening of the cause of Jesus Christ.



TRUSTEES' REPORT 2023-2024

1. The Objectives

- (1) The advancement of the Christian Faith in accordance with the statement of Doctrines in the Trust Schedule and, in particular, by the provision of Christian literature in various media.
- (2) The promotion of any other charitable purpose for the benefit of the community of Mid and West Wales by the advancement of education, the protection of health and the relief of poverty and sickness as an expression of the Christian Faith.

2. Strategies, Activities and Achievements in view of these Objectives

The Centre has now fully reopened after Covid. The Centre has striven to keep all the above objectives in mind as it has worked through the year. The general pattern is as follows:

- the Centre is open five days a week, closed on Sundays and Mondays, as the footfall on Mondays was much lower than Wednesdays, traditionally the other day we were closed and traditionally a half-day shopping closure in Lampeter (the Church Ladies' Meeting is now held there on Monday mornings too instead of Wednesday mornings); this change – closing on Mondays and opening on Wednesdays – has continued to be most beneficial to the Centre as it has been much busier; opening hours are between 10.00 a.m. and 4.00 p.m.; the staff always pray together before opening and after closing
- generally the footfall has continued to increase since and this has been most pleasing and encouraging, and now we are back to working to the full seating capacity we had before the pandemic; as before, from time to time we catered for groups/parties who arranged to come for lunch or tea on special occasions such as birthdays; we also catered for weddings, funeral teas and for special day and evening events; we were very busy in 2023 again with Christmas Dinners
- the Christian Bookstall and the Cwtsh (the area where a variety of other materials are available) have continued to be the focus of many visits, enquiries and sales; this service continues to be enhanced by the substantial second-hand Christian books' service located on separate shelving; (sales from these areas during the last year have been steady throughout)
- we provide a free Wi-Fi service to customers
- the disruption caused by the building of a church next door, Lampeter Evangelical Church, has now come to an end, and indeed the church and the Centre continue to liaise well together – services at the church are followed by our opening the Centre so that people may have

further more informal fellowship together and this has proved to be very popular; the completion of the church building means that the accommodation on the first floor of the building has been refurbished – one flat is now occupied and another part of the accommodation is provided for members of the church who have returned from the mission field in Kenya to live in Lampeter for some time – they will be giving voluntary help to the church and the Centre; though the Church and the Centre are two independent charities, many of the church's trustees are also trustees of The Lampeter Christian Centre; a legal agreement has been drawn up by means of which access from one entity to the other is acknowledged, in order to facilitate co-operation in promoting the Gospel in the town and community; the new large patio built at the back of both properties in 2020-2021 has proved to be a worthwhile investment and a distinct improvement on the precious smaller patio, new furniture was purchased and all this has been much used and appreciated by clientele

- the Centre continues to be regularly used by a variety of groups or societies during the daytime e.g. a Christian charity Knitting Group supported by Lampeter Evangelical Church meets every month to provide for needy people in other countries, particularly the Eastern Europe countries, Reading Group, Knits and Natters, Sewing Group, a Chess Club, Multiple Sclerosis Group, Ramblers' Association, men's group, a women's group and Bible Study groups
- the Centre is used quite regularly in the evening, outside of ordinary hours e.g. various groups who ask for food to be served, training and professional development events, cookery demonstrations etc.; Christian Union students from the University of Wales Trinity Saint David at Lampeter are continuing to use *Yr Hedyn Mwstard* for some of their activities too, though this has continued to be measurably declined compared with several years ago
- staffing: there are still a good number of volunteers, including those with special needs, who contribute substantially to the workforce, but there are also a number of individuals who are paid for their services: we now employ a number of nearly full-time employees as well as other part-time individuals; five of the staff are currently on the payroll (for a time this year there were six)
- procedures for the safekeeping of foodstuff etc. are carefully adhered to, and the Centre has already received many different awards for its standards of food and hygiene; we are currently awarded a grade 4
- the Centre is closed for an extended period of time only between Christmas and the New Year, usually for approximately ten days; a general cleaning and maintenance programme is undertaken at this time; this is apart from the ongoing maintenance that arises as necessary from time to time; the general décor is important to maintain and is well respected (all areas over the last few years have been refurbished); this has led to further improvements and the general ambience of the Centre is much appreciated by customers

- we try to maintain the building to the highest standards possible: there have been many improvements to certain aspects of its fabric during the year – this has actually been helped by the building of the church next door - and all the necessary repairs have been carried out promptly
- the Trustees over the years have met for business meetings both formally and informally (these include financial reports) and once a year hold an A.G.M. (the last one held in the early Summer of 2024 and we envisage holding our next one early in the New Year); minutes of these meetings are kept; the meetings keep eyes focussed on strategy (in line with the objectives) as well as giving attention to the operational everyday matters; the Trustees also over many years met monthly for Prayer Meetings before Covid - the disruption caused by Covid however means that these have not yet managed to be reconvened
- from time to time consideration is focussed on giving to charities, whether they be local good causes or known international Christian organisations , or even individual Christians or people in need (e.g. we provide support for one child's educational needs in a third world country through a Christian Charity, Compassion); our financial position continues to be generally sound and indeed has continued to be more encouraging since we fully opened following Covid; though meeting the increases in the Basic Wage and National Insurance have brought some challenges, we seem to be coping well
- in January 2017 we came on-stream with regard to workplace pensions enrolment; four members of staff continue to be on this scheme
- we are members of the Lampeter Chamber of Trade and get involved in all the various community events that they arrange throughout the year; this has allowed us to contribute and play our part fully this year again in the local community; meetings are held on a monthly basis
- the Centre works entirely bilingually, through the use of both Welsh and English languages.

3. Future Plans

Several issues have been discussed and will continue to need further attention again this year:

- we still continue to ponder whether we should appoint a manager (from amongst our full-time/nearly full-time employees) who would further our attempts to meet the objectives delineated in our Charity Deed document; we have already given further responsibilities to some of those individuals in order to relieve Trustees and to make fuller use of employees' varied skills; we continue to need a succession plan however
- there would be an advantage in increasing again the number of Trustees, although there are six Trustees at present – such an increase

would further complement the skills and experience of the existing Board of Trustees

- the enhancement of Christian counselling and support
- continually improving the premises by means of further developments and possible light refurbishments, renewal of equipment and the use of further strategies to reach out to people in the community; the standing of The Mustard Seed we feel has been enhanced by the building of the church next door and we are often visited by groups who want special teas provided **along with a guided tour of the church**; we are confident that this will be a continuing element into the future.

4. Finances

Great care is taken with accounts, but naturally finances – as suggested from the above arrangements and activities – are used to further the Centre's objectives.

The following comments need to be noted:

- regular use is made of a professional accountant to help with the Centre's financial obligations
- payment is made each year for the Centre accounts to be audited
- the Treasurer presents accounts regularly to members during the any Business Meetings and they are discussed openly and thoroughly
- we have a well-established website
- our card facility (debit and credit cards) introduced some years ago has undoubtedly enhanced the service provided by the Centre
- sums of money are sent to Christian charities and individuals every year, at local, national and international levels, including missionary work, as noted above.

5. Conclusion

In view of the above, the Trustees would like to express their gratitude to the Officers of Lampeter Christian Centre for their faithful adherence to the terms of the Trust.

We are encouraged that the Centre continues to flourish and meets its responsibilities to bring the Gospel of Jesus Christ to the local community whilst also facilitating local and world-wide missionary movements and associations, charity groups and support for individuals. We are satisfied that the accounts have been kept to the highest standard and that all transactions have been carried out with the utmost integrity. Money has been prudently used to pursue effectively, efficiently and successfully the Centre's stated objectives.

We trust that the Centre will continue to know much blessing in the future and are very happy to endorse the vision that we as Trustees have to continue the strengthening of the cause of Jesus Christ.



TRUSTEES' REPORT 2022-2023

1. The Objectives

- (1) The advancement of the Christian Faith in accordance with the statement of Doctrines in the Trust Schedule and, in particular, by the provision of Christian literature in various media.
- (2) The promotion of any other charitable purpose for the benefit of the community of Mid and West Wales by the advancement of education, the protection of health and the relief of poverty and sickness as an expression of the Christian Faith.

2. Strategies, Activities and Achievements in view of these Objectives

The Centre has now fully reopened after Covid. The Centre has striven to keep all the above objectives in mind as it has worked through the year. The general pattern is as follows:

- the Centre is open five days a week, closed on Sundays and Mondays, as the footfall on Mondays was much lower than Wednesdays, traditionally the other day we were closed and traditionally a half-day shopping closure in Lampeter (the Church Ladies' Meeting is now held there on Monday mornings too instead of Wednesday mornings); this change – closing on Mondays and opening on Wednesdays – has been most beneficial to the Centre as it has been much busier; opening hours are between 10.00 a.m. and 4.00 p.m.; the staff always pray together before opening and after closing
- generally the footfall has continued to increase since and this has been most pleasing and encouraging, and now we are back to working to the full seating capacity we had before the pandemic; as before, from time to time we catered for groups/parties who arranged to come for lunch or tea on special occasions such as birthdays; we also catered for weddings, funeral teas and for special day and evening events; we were very busy in 2022 again with Christmas Dinners
- the Christian Bookstall and the Cwtsh (the area where a variety of other materials are available) have continued to be the focus of many visits, enquiries and sales; this service continues to be enhanced by the substantial second-hand Christian books' service located on separate shelving; (sales from these areas during the last year have been steady throughout)
- we provide a free Wi-Fi service to customers
- the disruption caused by the building of a church next door, Lampeter Evangelical Church, has now come to an end, and indeed the church and the Centre liaise well together – services at the church are followed by our opening the Centre so that people may have further

more informal fellowship together and this has proved to be very popular; the completion of the church building means that the accommodation on the first floor of the building has been refurbished – one flat is now occupied and another part of the accommodation is soon to be provided for members of the church who are returning from the mission field in Kenya to live in Lampeter for some time – they will be giving voluntary help to the church and the Centre; though the Church and the Centre are two independent charities, many of the church's trustees are also trustees of The Lampeter Christian Centre; a legal agreement has been drawn up by means of which access from one entity to the other is acknowledged, in order to facilitate co-operation in promoting the Gospel in the town and community; the new large patio built at the back of both properties in 2020-2021 has proved to be a worthwhile investment and a distinct improvement on the precious smaller patio, new furniture was purchased and all this has been much used and appreciated by clientele

- the Centre continues to be regularly used by a variety of groups or societies during the daytime e.g. a Blythwood (Christian charity) Knitting Group supported by Lampeter Evangelical Church meets every month to provide for needy people in other countries, particularly the Eastern Europe countries, reading group, Knits and Natters, Sewing Group, a men's group, a women's group and Bible Study groups – we are practically back to the pre-Covid situation
- the Centre is used quite regularly in the evening, outside of ordinary hours e.g. several church meetings are held (Bible Studies and Prayer Meetings, Missionary Meetings, Church Business Meetings), other Church events, various groups who ask for food to be served, training and professional development events, cookery demonstrations etc.; Christian Union students from the University of Wales Trinity Saint David at Lampeter are continuing to use *Yr Hedyn Mwstard* for some of their activities too, though this has measurably declined compared with several years ago
- staffing: there are still a good number of volunteers, including those with special needs, who contribute substantially to the workforce, but there are also a number of individuals who are paid for their services: we now employ a number of nearly full-time employees as well as other part-time individuals; five of the staff are on the pay-roll
- procedures for the safekeeping of foodstuff etc. are carefully adhered to, and the Centre has already received many different awards for its standards of food and hygiene; we are currently awarded a grade 4
- the Centre is closed for an extended period of time only between Christmas and the New Year, usually for approximately ten days; a general cleaning and maintenance programme is undertaken at this time; this is apart from the ongoing maintenance that arises as necessary from time to time; the general décor is important to maintain and is well respected and this year we have fully refurbished the one area which remained, namely the Meeting Room at the back of

the property; this has led to further improvements and the general ambience of the Centre is much appreciated by customers

- we try to maintain the building to the highest standards possible: there have been many improvements to certain aspects of its fabric during the year – this has actually been helped by the building of the church next door - and all the necessary repairs have been carried out promptly
- the Trustees over the years have met for business meetings both formally and informally (these include financial reports) and once a year hold an A.G.M. (the last one held in the early Spring of 2023 and we envisage holding our next one this coming Autumn); minutes of these meetings are kept; the meetings keep eyes focussed on strategy (in line with the objectives) as well as giving attention to the operational everyday matters; the Trustees also over many years met monthly for Prayer Meetings before Covid - the disruption caused by Covid however means that these have not yet managed to be reconvened
- from time to time consideration is focussed on giving to charities, whether they be local good causes or known international Christian organisations , or even individual Christians or people in need (e.g. we provide support for one child's educational needs in a third world country through a Christian Charity, Compassion); our financial position continues to be generally sound and indeed has continued to be more encouraging since we fully opened following Covid; though meeting the increases in the Basic Wage and National Insurance have brought some challenges, we seem to be coping well
- in January 2017 we came on-stream with regard to workplace pensions enrolment; four members of staff continue to be on this scheme
- we are members of the Lampeter Chamber of Trade and get involved in all the various community events that they arrange throughout the year; this has allowed us to contribute and play our part fully this year again in the local community; meetings are held on a monthly basis
- the Centre works entirely bilingually, through the use of both Welsh and English languages.

3. Future Plans

Several issues have been discussed and will continue to need further attention again this year:

- we still continue to ponder whether we should appoint a manager (from amongst our full-time/nearly full-time employees) who would further our attempts to meet the objectives delineated in our Charity Deed document; we have already given further responsibilities to some of those individuals in order to relieve Trustees and to make fuller use of employees' varied skills; we continue to need a succession plan however

- there would be an advantage in increasing again the number of Trustees, although there are six Trustees at present – such an increase would further complement the skills and experience of the existing Board of Trustees
- the enhancement of Christian counselling and support
- continually improving the premises by means of further developments and possible light refurbishments, renewal of equipment and the use of further strategies to reach out to people in the community; the standing of The Mustard Seed we feel has been enhanced by the building of the church next door and we are often visited by groups who want special teas provided **along with a guided tour of the church**; we are confident that this will be a continuing element into the future.

4. Finances

Great care is taken with accounts, but naturally finances – as suggested from the above arrangements and activities – are used to further the Centre’s objectives. The following comments need to be noted:

- regular use is made of a professional accountant to help with the Centre’s financial obligations
- payment is made each year for the Centre accounts to be audited
- the Treasurer presents accounts regularly to members during the any Business Meetings and they are discussed openly and thoroughly
- we have a well-established website
- our card facility (debit and credit cards) introduced some years ago has undoubtedly enhanced the service provided by the Centre
- sums of money are sent to Christian charities and individuals every year, at local, national and international levels, including missionary work, as noted above.

5. Conclusion

In view of the above, the Trustees would like to express their gratitude to the Officers of Lampeter Christian Centre for their faithful adherence to the terms of the Trust.

We are encouraged that the Centre continues to flourish and meets its responsibilities to bring the Gospel of Jesus Christ to the local community whilst also facilitating local and world-wide missionary movements and associations, charity groups and support for individuals. We are satisfied that the accounts have been kept to the highest standard and that all transactions have been carried out with the utmost integrity. Money has been prudently used to pursue effectively, efficiently and successfully the Centre’s stated objectives.

We trust that the Centre will continue to know much blessing in the future and are very happy to endorse the vision that we as Trustees have to continue the strengthening of the cause of Jesus Christ.



TRUSTEES' REPORT 2021-2022

1. The Objectives

- (1) The advancement of the Christian Faith in accordance with the statement of Doctrines in the Trust Schedule and, in particular, by the provision of Christian literature in various media.
- (2) The promotion of any other charitable purpose for the benefit of the community of Mid and West Wales by the advancement of education, the protection of health and the relief of poverty and sickness as an expression of the Christian Faith.

2. Strategies, Activities and Achievements in view of these Objectives

The Centre has now practically fully reopened after Covid. The Centre has striven to keep all the above objectives in mind as it has worked through the year. The general pattern is as follows:

- the Centre is open five days a week, closed on Sundays and now Mondays, as the footfall on Mondays was much lower than Wednesdays, traditionally the other day we were closed and traditionally a half-day shopping closure in Lampeter (the Church Ladies' Meeting is now held there on Monday mornings too instead of Wednesday mornings); opening hours are between 10.00 a.m. and 4.00 p.m.; the staff always pray together before opening and after closing
- generally the footfall has noticeably increased since Covid restrictions have been eased, and this has been most pleasing and encouraging, even though we are still not working to the full seating capacity we had before the pandemic; as before, from time to time we catered for groups/parties who arranged to come for lunch or tea on special occasions such as birthdays; we also catered for funeral teas and for special evening events; we were very busy in 2021 again with Christmas Dinners, and we had a particularly busy evening when the town held its Christmas late night opening at the end of November
- the Christian Bookstall and the Cwtsh (the area where a variety of other materials are available) have continued to be the focus of many visits, enquiries and sales; this service is enhanced by the substantial second-hand Christian books' service located on separate shelving; (sales from these areas during the last year have been steady throughout this year)
- we provide a free Wi-Fi service to customers
- our upstairs accommodation and other areas of the Centre have continued to be disrupted this year by the building of a church next door, Lampeter Evangelical Church (now open, though still not finally

complete); however, we envisage that the accommodation will be refurbished and used before the end of 2022; all this has been a major venture on behalf of Lampeter Evangelical Church with whom we have a close association; though we are two independent charities, many of the church's trustees are also trustees of The Lampeter Christian Centre; a legal agreement has been drawn up by means of which access from one entity to the other is acknowledged, in order to facilitate co-operation in promoting the Gospel in the town and community; during the year a new large patio was built at the back of both properties, a distinct improvement on the precious smaller patio, new furniture was purchased and all this has been much used and appreciated by clientele

- the Centre continues to be regularly used by a variety of groups or societies during the daytime e.g. a Blythswood (Christian charity) Knitting Group supported by Lampeter Evangelical Church meets every month to provide for needy people in other countries, particularly the Eastern Europe countries, reading group, Knits and Natters, Sewing Group, Beekeepers' Association, a men's group, a women's group and Bible Study groups – some other groups have been affected by the lockdowns and have not yet reappeared
- the Centre is used quite regularly in the evening, outside of ordinary hours e.g. several church meetings are held (Bible Studies and Prayer Meetings, Missionary Meetings, Church Business Meetings), other Church events, various groups who ask for food to be served, training and professional development events, cookery demonstrations etc.; Christian Union students from the University of Wales Trinity Saint David at Lampeter are continuing to use *Yr Hedyn Mwstard* for some of their activities too, though this has measurably declined compared with several years ago
- staffing: there are still a good number of volunteers, including those with special needs, who contribute substantially to the workforce, but there are also a number of individuals who are paid for their services: we now employ one full-time and three nearly full-time employees as well as other part-time individuals; four of the staff are on the pay-roll; the furlough scheme which helped to sustain us during the various lockdown periods came to an end of course during 2021
- procedures for the safekeeping of foodstuff etc. are carefully adhered to, and the Centre has already received many different awards for its standards of food and hygiene; we are currently awarded a grade 5
- the Centre is closed for an extended period of time only between Christmas and the New Year, usually for approximately ten days; a general cleaning and maintenance programme is undertaken at this time; this is apart from the ongoing maintenance that arises as necessary from time to time; the general décor is important to maintain and is well respected and we envisage some work will have to be done in one area particularly in the near future (the Meeting Room at the back of the property) in consequence of the church being built next door since it has meant new entrances being opened for access

between the two buildings; our major refurbishment in 2021 has been much admired by customers

- we try to maintain the building to the highest standards possible: there have been many improvements to certain aspects of its fabric during the year and all the necessary repairs have been carried out promptly
- the Trustees over the years have met for business meetings both formally and informally (these include regular financial reports) and once a year hold an A.G.M. (the last one held in the Autumn of 2021 and we envisage holding our next one this coming Autumn); minutes of these meetings are kept; the meetings keep eyes focussed on strategy (in line with the objectives) as well as giving attention to the operational everyday matters; the Trustees also met monthly for Prayer Meetings before Covid, but these have been affected by lockdown periods
- from time to time consideration is focussed on giving to charities, whether they be local good causes or known international Christian organisations, or even individual Christians or people in need (e.g. we provide support one child's educational needs in a third world country through a Christian Charity); our financial position continues to be generally sound and indeed has been more encouraging since we fully opened following Covid; though meeting the increases in the Basic Wage and National Insurance have brought some challenges, we seem to be coping well
- in January 2017 we came on-stream with regard to workplace pensions enrolment; four members of staff are now on this scheme
- we are members of the Lampeter Chamber of Trade and get involved in all the various community events that they arrange throughout the year; this has allowed us to contribute and play our part fully this year again in the local community; meetings by means of Zoom (and later resuming person to person meetings); last year's Late-Night Opening Event in Lampeter was a particular success for us
- the Centre works entirely bilingually, through the use of both Welsh and English languages.

3. Future Plans

Several issues have been discussed and will continue to need further attention again this year:

- we still continue to ponder whether we should appoint a manager (from amongst our full-time/nearly full-time employees) who would further our attempts to meet the objectives delineated in our Charity Deed document; we have already given further responsibilities to some of those individuals in order to relieve Trustees and to make fuller use of employees' varied skills; we need a succession plan however
- there would be an advantage in increasing again the number of Trustees, although there are six Trustees at present – such an increase

would further complement the skills and experience of the existing Board of Trustees

- the enhancement of Christian counselling and support
- continually improving the premises by means of further developments and possible refurbishments, renewal of equipment and the use of further strategies to reach out to people in the community; the standing of The Mustard Seed we feel has been enhanced by the building of the church next door and we are often visited by groups who want special teas provided **along with a guided tour of the church**; we are confident that this will be a continuing element into the future.

4. Finances

Great care is taken with accounts, but naturally finances – as suggested from the above arrangements and activities – are used to further the Centre's objectives.

The following comments need to be noted:

- regular use is made of a professional accountant to help with the Centre's financial obligations
- payment is made each year for the Centre accounts to be audited
- the Treasurer presents accounts regularly to members during the any Business Meetings and they are discussed openly and thoroughly
- we have a well-established website
- our card facility (debit and credit cards) introduced some years ago has undoubtedly enhanced the service provided by the Centre
- sums of money are sent to Christian charities and individuals every year, at local, national and international levels, including missionary work, as noted above.

5. Conclusion

In view of the above, the Trustees would like to express their gratitude to the Officers of Lampeter Christian Centre for their faithful adherence to the terms of the Trust.

We are encouraged that the Centre continues to flourish and meets its responsibilities to bring the Gospel of Jesus Christ to the local community whilst also facilitating local and world-wide missionary movements and associations, charity groups and support for individuals. We are satisfied that the accounts have been kept to the highest standard and that all transactions have been carried out with the utmost integrity. Money has been prudently used to pursue effectively, efficiently and successfully the Centre's stated objectives.

We trust that the Centre will continue to know much blessing in the future and are very happy to endorse the vision that we as Trustees have to continue the strengthening of the cause of Jesus Christ.

TRUSTEES' REPORT 2020-2021

1. The Objectives

- (1) The advancement of the Christian Faith in accordance with the statement of Doctrines in the Trust Schedule and, in particular, by the provision of Christian literature in various media.
- (2) The promotion of any other charitable purpose for the benefit of the community of Mid and West Wales by the advancement of education, the protection of health and the relief of poverty and sickness as an expression of the Christian Faith.

2. Strategies, Activities and Achievements in view of these Objectives

It has to be said at the outset that the following details have continued to be seriously affected by the lockdown resulting from the coronavirus outbreak. Everything was closed down on March 21st 2020, reopened in August 2020, but then closed for 5 months from December 21st 2020 until May 20th 2021. The Centre has now reopened but only for part of the week, awaiting a further relaxation of restrictions.

The Centre has striven to keep all the above objectives in mind as it has worked through the year. **The general pattern – were it not for Covid restrictions - is as follows:**

- the Centre is open five days a week, closed on Sundays and Wednesdays (a Church Ladies' Meeting is held there on Wednesday mornings) between 10.00 a.m. and 4.00 p.m.; the staff always pray together before opening and after closing
- generally the footfall has steadied somewhat, in spite of restrictions; as before, from time to time we catered for groups/parties who arranged to come for lunch or tea on special occasions such as birthdays; we also catered for funeral teas and for special evening events; we were particularly busy in 2020 again with Christmas Dinners
- the Christian Bookstall and the Cwtsh (the area where a variety of other materials are available) have continued to be the focus of many visits, enquiries and sales; this service is enhanced by the substantial second-hand Christian books' service located on separate shelving; (sales from these areas during the last year, though regular, have experienced something of an upturn this year)
- we provide a free Wi-Fi service to customers
- our upstairs accommodation and other areas of the Centre have continued to be disrupted this year by the building of a church next door, Lampeter Evangelical Church (now open, though still not finally complete); this has been a major venture on behalf of Lampeter Evangelical Church with whom we have a close association; though we

are two independent charities, many of the church's trustees are also trustees of The Lampeter Christian Centre; a legal agreement has been drawn up by means of which access from one entity to the other is acknowledged, in order to facilitate co-operation in promoting the Gospel in the town and community

- the Centre continues to be regularly used by a variety of groups or societies during the daytime e.g. a Blythswood (Christian charity) Knitting Group supported by Lampeter Evangelical Church meets every month to provide for needy people in other countries, particularly the Eastern Europe countries, reading group, Knits and Natters, Beekeepers' Association, a men's group, a singing group, Alzheimer's Society, MS group, Bible Study groups, an epilepsy group, computer classes' groups, as well as other bodies, over 20 altogether
- the Centre is used quite regularly in the evening, outside of ordinary hours e.g. several church meetings are held (Bible Studies and Prayer Meetings, Missionary Meetings, Learning Welsh Courses, Church Business Meetings), Church events (such as the St. David's Day Cawl Evening), various groups who ask for food to be served, training and professional development events, Gideons International (now called Good News For Everyone) meetings, cookery demonstrations etc.; Christian Union students from the University of Wales Trinity Saint David at Lampeter are continuing to use *Yr Hedyn Mwstard* for some of their activities too, though this has measurably declined over the last couple of years
- staffing: there are still a good number of volunteers, including those with special needs, who contribute substantially to the workforce, but there are also a few individuals who are paid for their services: we now employ one full-time and three nearly full-time employees as well as other part-time individuals; four of the staff are on the pay-roll; **those on the payroll continue to be on the furlough scheme established by the Government in 2020, but are now working part of the week under flexible furlough arrangements**
- procedures for the safekeeping of foodstuff etc. are carefully adhered to, and the Centre has already received many different awards for its standards of food and hygiene; we are currently awarded a grade 5
- the Centre is closed for an extended period of time only between Christmas and the New Year, usually for approximately ten days; a general cleaning and maintenance programme is undertaken at this time; this is apart from the ongoing maintenance that arises as necessary from time to time; the general décor is important to maintain and is well respected and we envisage some work will have to be done in consequence of the church being built next door since it has meant new entrances being built for access between the two buildings; **we took advantage of the prolonged period of closure in 2020 to substantially refurbish the premises and the outside patio, and this has resulted in wide-ranging expressions of appreciation by customers**

- we try to maintain the building to the highest standards possible: there have been many improvements to certain aspects of its fabric during the year and all the necessary repairs have been carried out promptly
- we test the fire alarm system regularly
- the Trustees over the years have met for business meetings both formally and informally (these include regular financial reports) and once a year hold an A.G.M. **but these have unfortunately been badly affected by Covid restrictions during this last year;** minutes of these meetings are kept; the meetings keep eyes focussed on strategy (in line with the objectives) as well as giving attention to the operational everyday matters; the Trustees also meet monthly for Prayer Meetings
- twice a year, in March and September, consideration is focussed on giving to charities, whether they be local good causes or known international Christian organisations , or even individual Christians or people in need (e.g. we provide support one child's educational needs in a third world country through a Christian Charity); our financial position continues to be generally sound, but has continued to be under more pressure – though more encouraging at present in spite of the lockdown period – being the result as we see it of Government increases to the Basic Wage; **however our financial position this year has been healthier, since we have benefitted from various Government Grants as well as the furlough scheme; early on in the first lockdown we negotiated a loan of £10,000 but we are glad to report that this has now been fully repaid**
- in January 2017 we came on-stream with regard to workplace pensions enrolment; four members of staff have joined this scheme
- we are members of the Lampeter Chamber of Trade and get involved in all the various community events that they arrange throughout the year; this has allowed us to contribute and play our part fully this year again in the local community; meetings by means of Zoom and certain activities have continued in spite of the lockdowns
- the Centre works entirely bilingually, through the use of both Welsh and English languages.

3. Future Plans

Several issues have been discussed and will need further attention again this year:

- we still continue to ponder whether we should appoint a manager (from amongst our full-time/nearly full-time employees) who would further our attempts to meet the objectives delineated in our Charity Deed document; we have already given further responsibilities to some of those individuals in order to relieve Trustees and to make fuller use of employees' varied skills

- there would be an advantage in increasing again the number of Trustees, although we appointed two new Trustees in 2017, bringing the number of Trustees to six – this would further complement the skills and experience of the existing Board of Trustees
- the enhancement of Christian counselling and support
- continually improving the premises by means of further developments and possible refurbishments, renewal of equipment and the use of further strategies to reach out to people in the community; this will be a necessary element in the next few months or so as a result of the changes being made as a consequence of the new church building next door (see above.)

4. Finances

Great care is taken with accounts, but naturally finances – as suggested from the above arrangements and activities – are used to further the Centre's objectives. The following comments need to be noted:

- regular use is made of a professional accountant to help with the Centre's financial obligations
- payment is made each year for the Centre accounts to be audited
- the Treasurer presents accounts regularly to members during the monthly Business Meetings and they are discussed openly and thoroughly
- we have a well-established website
- our card facility (debit and credit cards) introduced some years ago has undoubtedly enhanced the service provided by the Centre
- sums of money are sent to Christian charities and individuals every year, at local, national and international levels, including missionary work, as noted above.

5. Conclusion

In view of the above, the Trustees would like to express their gratitude to the Officers of Lampeter Christian Centre for their faithful adherence to the terms of the Trust.

We are encouraged that the Centre continues to flourish and meets its responsibilities to bring the Gospel of Jesus Christ to the local community whilst also facilitating local and world-wide missionary movements and associations, charity groups and support for individuals. We are satisfied that the accounts have been kept to the highest standard and that all transactions have been carried out with the utmost integrity. Money has been prudently used to pursue effectively, efficiently and successfully the Centre's stated objectives.

We trust that the Centre will continue to know much blessing in the future and are very happy to endorse the vision that we as Trustees have to continue the strengthening of the cause of Jesus Christ.
