TO CREATE A MEMORIAL AREA WHERE TREES CAN BE PLANTED OR DEDICATED IN MEMORY OF DEPARTED FRIENDS AND LOVED ONES.5. TO PLANT TREES WHEREVER APPROPRIATE AND TO PRODUCE A SUSTAINABLE SUPPLY OF WOODLAND PRODUCTS AND TIMBER BY MANAGING THE WOODLAND IN WAYS CONSISTENT WITH THE FOREGOING OBJECTS.
