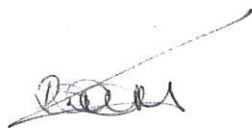

Wilton Productions is a registered Charity. All the Charity's income is applied to its charitable objectives, and the association is therefore exempt under current legislation from most forms of taxation.

The Charity is not VAT registered, and all expenditure includes irrecoverable VAT.

**6 Trustee Remuneration**

There was no reimbursement of travel expenses during the year.

**7 Related Party Transactions**

During the financial period the Charity had no related party transactions with its Trustees.

**8 Going Concern**

This provides the benefit of the organisation having a distinct legal identity and provides Limited Liability for the Trustees.

The charity generates the majority of its income from ticket sales, and therefore the trustees consider the charity to be a going concern.
