Activities: Supporting children ,through projects run by the Holy Cross AIDS Hospice in Emoyeni, KwazuluNatal South Africa, who have been orphaned as a result of AIDS or are suffering with AIDS or HIV positive in this deeply rural area. Currently, the charity through its support of these programs reaches out to over 500 child headed families and 1700 orphans
