Funds may only be used to fulfil the main purpose which is fundraising to provide facilities or equipment which support Connor Downs Academy and further the education of the children;
6. To provide activities and events to support and enhance the Academy's provision.

Achievements and Performance

The trustees carry out the charity's purposes for the benefit of the children attending Connor Downs Academy. Each trustee understands and follows the constitution and the guidance issued by the Charity Commission.

The charity successfully raised funds and obtained grants resulting in an exciting new outdoor play area and bike shelter.

Both projects promoted children's health and well-being and supported sustainability and environmental awareness.



Financial Review

All funds received from grants are used as intended on application. Additional funds held will enable the charity to continue to achieve their objectives for the benefit of the school community. The balance as at 31st March 2022 was £7,070.

The charity continues to hold fundraising events such as fayres, discos and sales as well as making grant applications where opportunities arise and are appropriate.

As the current cost of living rises for families, the trustees are mindful of the financial impact this has on fundraising. The trustees therefore consider the ways the charity raises funds and delivers their objectives to secure the future of the charity.

The trustees are responsible for the general control of the management of the administration of the charity including the cash held.
