Objects: The charity's purposes are: I. The advancement of Christian religion, particularly by: - a. the institution and maintenance in affiliated towers of; full Sunday service ringing, other service ringing, and ringing for national and local civic occasions. b. the fostering of the closest possible co-operation with the church, its gospel mission, other owners of bell installations, and with the community. c. the recognition of the position of ringers as members of the church community, d. the encouragement of recruitment and training of ringers and advancement of the art of change ringing. e. the provision of assistance to owners or promoters of affiliated bell installations. II. The advancement of the education of the public in the art and science of bell ringing, by promoting and encouraging the practice of bellringing and by supporting the recruitment and development of bellringers.

Activities: The society fosters the maintenance of Sunday Service bell ringing within the Archdeaconries of Lichfield and Walsall. We encourage the recruitment and training of ringers and the advancement of the art of change ringing and provide guidance and assistance to affiliated tower bands. We provide grants to affiliated church authorities for the provision, maintenance or improvement of their bells.

Para 1.17 and 1.19	We support church bell ringing in the two archdeaconries that form our "territory" in the southern half of the historic county of Staffordshire. The ringing of bells is one of the traditional elements of the soundscape in the United Kingdom, whether for church services, or for other significant public occasions and events. As a society our activity includes training of ringers, training encouragement support to individual tower groups, advice on maintenance & repair of bells / bell frames and provision of grant support to bell related projects.

		such as training, installation of training devices Grants are normally awarded on the basis of up to 15% of the cost of physical installations. Training support grants are assessed on individual merit. Grants are payable upon sight of an invoice for the work and on evidence of having obtained comparative and competitive quotes.
Policy on social investment including program related investment	Para 1.38	The society provides support an training to volunteers for the delivery of ringing and basic maintenance at towers within the territory. The society makes no distinction and welcomes ringers from all backgrounds in encouraging them to contribute to ringing activities for the public benefit.
Contribution made by volunteers	Para 1.38	The work of the society is entirely by volunteers. The activity of church bell ringing is entirely voluntary. We support the safe contribution by volunteers to significant maintenance & repair activities.

Para 1.20	During the year, the principal achievement of the society was to maintain a network of ringers despite the lockdowns imposed by Covid-19 restrictions, through a programme of on-line events, so that as restrictions were lifted, there remained sufficient and capable ringers to resume ringing activities. Despite the restrictions, maintenance and repair activities took place at several towers, to which the following grants were awarded: Coseley: £785 towards sound control Penn: £2000 refurbishment of bell fittings Willenhall: £2800 refurbishment of bell fittings Walsall: £150 provision of sensors & software for a training facility The society also advises and has offered support to ongoing projects at Coseley, Wednesbury & Stafford.

Expenditure, including grants made was £6958. The society was the beneficiary of a bequest of £76612 from a deceased former member. This substantially changes our financial status and the trustees are evaluating how to best use and invest this to forward the aims of the society.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	Historic Policy for reserves has been to hold £10-15,000 in a deposit account, for the purpose of awarding grants. That to be balanced over years to address the fluctuating demand on grants and relatively low speed of bell restoration activities. Following receipt of the bequest, we are considering the amount to be held in reserve for enhanced grant awards.
