ALBANS DISTRICT BY THE PROVISION OF ICT TRAINING AND SUPPORT WITH A VIEW TO IMPROVING TRAINING OPPORTUNITIES.

Activities: provides free and subsidised basic introductory computer training in public access venues to meet the needs of people of all ages and abilities, including the disadvantaged (whether through disability, homelessness, social exclusion, or unemployment). This basic training is available to anyone over the age of 16 living in St Albans and District and very suitable for older people.
