TO PROVIDE FOR THE RELIEF OF PERSONS WHO ARE IN NEED BY REASON OF THEIR SICKNESS, POOR HEALTH, INFIRMITY OR DISABLEMENT WHO ARE CURRENTLY REGISTERED TO, OR RESIDING IN OR VISITING A HOSPITAL, HOME, CHARITY, HOSPICE OR OTHER MEDICAL INSTITUTION BY THE PROVISION OF, BUT NOT LIMITED TO, ENTERTAINERS, MUSICIANS, MAGICIANS OR STORYTELLERS WITH THE OBJECT OF PROVIDING RESPITE FROM THEIR CONDITION

Activities: Musicians in need due to poverty, social, economic or financial circumstances have benefited. 1 to1 health services have continued through the year with great success. Community Respite/ health courses with approx 100 wkly participants continue with success. Conditions range from depression, arthritis, CVD, COPD. Entertainment, music & health resources continue to be developed.
