Joint foreword from the Chair and CEO

We are delighted to present our report of activities and performance in the year to end March 2024. This was a very busy year for the charity, building on developments in the previous year to continue to grow and diversify our offer, strengthening our team, and our partnerships, and continuing to increase the number of people we support in the Creative Response community.

There is much to celebrate in the achievements and progress outlined here - including our work in new spaces and to increase our reach and impact. And the developments outlined have readied us for planned further growth, including work now underway to pilot a new service in Hampshire and to reach additional groups with specific needs in the community, for example with a new support offer to older people facing loneliness or isolation.

We remain committed to supporting as many vulnerable adults as possible with our vital therapeutic community arts service and continue to seek out and develop partnerships with others to increase our shared reach and impact. In the year on which we are now reporting, this has included several joint projects with staff and students of the University of the Creative Arts, Farnham and the continued provision of support to Ukrainian refugees in Surrey, with Activate Learning.

Three spectacular exhibitions of fresh and diverse work were held at our studios: our annual community summer exhibition, Flourish in June-July 2023; a 3D exhibition of large scale sculptures in Tom's dinosaur 'take-over' in January 2024; and an important series of portrait photographs: Unbowed: Stories of Ukraine, which opened on the second anniversary of the war, on 24 February this year, sharing the experiences of women in our Ukraine group of leaving their homes and coming to the UK..

Feedback from our participants continues consistently to evidence the importance of the support our expert team of artists provide, and the tangible impact that attending our arts sessions, and being part of our community, has for those we serve: helping people stay as stable and well as is possible for them; to find joy and enrichment in the arts and creativity; and to (re)build wider social lives.

Trustees Report

The Trustees (who are also Directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Creative Response (Arts) Limited for the year ended 31 March 2024.

The Annual Report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual Report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the company qualifies as small under section 382 of the Companies Act 2006, the Strategic Report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Structure, governance and management

a. CONSTITUTION

Set up in 1993, Creative Response (Arts) Limited was incorporated as a company limited by guarantee on 11 March 1997 with company registration number 04404746 (England and Wales) and was set up by memorandum and articles of association on 27 March 2002. It is a registered charity: registration number 1096890 (England and Wales).

The 'object' of the company, as set out in the governing documents, is to relieve persons with mental health problems or alcohol or drug problems by provision of therapeutic arts activities. Today, Creative Response provides therapeutic community arts to vulnerable adults experiencing a wide range of mental ill-health difficulties, as well as who have learning and/or physical disabilities, who live in Surrey and North East Hampshire.

There have been no changes in the charity objects since the last annual report.

b. METHOD OF APPOINTMENT OR ELECTION OF TRUSTEES

The management of the company is the responsibility of the Board of Trustees who are elected under the terms of the Articles of Association. New trustees are appointed by the current Trustees.

c. ORGANISATIONAL STRUCTURE AND DECISION MAKING

The Board that oversees the charity's work currently has 8 Trustees. The Articles of Association require that there should be a minimum of 3, and sets no upper limit.

The Chief Executive Officer is responsible for the day-to-day management of the organisation, supported by an Operations Manager, a finance administrator, an administrative officer, 14 artworkers and 8 volunteers.

No team member received a remuneration over £60,000.

Trustees received no remuneration or other benefit.

Objectives and Activities

a. OBJECTIVES

Creative Response offers therapeutic community arts to vulnerable adults experiencing mental ill? health and/or who have physical and/or learning disabilities. We take a person?centred approach, tailoring support to the needs of the individual.

Through the provision of our service we seek to:

- help our participants access the benefits of the arts and creativity for mental health and wellbeing, including to equip our participants with tools that enable them to sustain their own wellbeing outside the studios;
- Offer social and community connection, to help tackle loneliness and isolation;
- By supporting people through recovery and to stay as stable and well as is possible for them, helping enable them to: (re)engage with social life; build their self?esteem and resilience; and move on to new things when they are ready.

We seek to enrich the lives of vulnerable adults through our own arts and community offer, and by providing support and encouragement to people in our community to explore other things. We have supported vulnerable adults into work for the first time, or to volunteer; to enrol in further education, or university; and to join creative and other activities on offer in the wider local community.

b. MAIN ACTIVITIES UNDERTAKEN TO FURTHER THE CHARITY'S PURPOSES FOR PUBLIC BENEFIT

Our main activity is the provision of therapeutic arts sessions for vulnerable adults. These aim to improve mental health and emotional wellbeing. Our arts sessions mostly take place at our studios in central Farnham, on weekdays, during term time. But in this year we have also offered an online art group, an online creative writing session and from time-to-time provided activities at other locations for the purposes of enriching the experience of existing participants.

We have additionally run an outreach service at Hale Community Centre, to engage new participants and started a new group, at the Garden Gallery, Museum of Farnham. The Garden Gallery space provides an 'annex' to our main studios, and has enabled us to improve our support to new and existing participants with significant physical disabilities, as a fully accessible offer in a bright and beautiful space.

Our art sessions are run by a highly skilled and experienced team of artists, with expertise in a wide range of creative practices. The sessions offer a sharing of skills and knowledge in a safe and supportive environment, as well as providing an important community connection for those we support. Operating in small groups, with the same team and peers together each week, we create a sense of community and belonging that offers the necessary support and security for our participants that helps them (re)build wider social lives.

Our sessions provide support to vulnerable adults referred to us by:

- Surrey, Hampshire and Berkshire County Council Adult Social Care;;
- community mental health services;
- GPs;
- social prescribers; and
- other professionals.

Achievements and performance

a. ACHIEVEMENTS AND PERFORMANCE

This year Creative Response celebrated 30 years of service to the local community. As well as undertaking several special projects to celebrate this important milestone, we have focused strongly in this period on action to ensure our resilience for the future and to plan for further growth.

Activity to this end has included the recruitment and training of 3 new artists, increasing the size of the artist team by about 25% and a programme of work to strengthen our support for our volunteers, which has further diversified the skills and experience in our team and nearly doubled the number of volunteers engaged in supporting our community. We remain very grateful to all of the team for their brilliant work, and particularly our amazing volunteers for their brilliant support to our participants, and in helping ensure the sustainability of our service offer.

The development of a new regular workspace in our gallery at Vernon House has increased our capacity by around a third, enabling us now to support up to 27 participants each day at the main studios. We are gradually increasing year-on-year the number of people we are supporting with around 25% increase between the start of 22-23 (around 80) and the end of 23-24 (around 100).

Working in partnership with the University of Creative Arts (UCA) Farnham we have offered our participants the opportunity to try various new creative practices again this year, including a phonotrope workshop on the university campus. And our participants also had the opportunity to partner with UCA students to produce an interactive installation for the Farnham Literary Festival in March 2024 reflecting on the value of writing. This was on display to the public in the Farnham Town Council offices for the duration of the Festival.

Our gallery hosted 3 well-attended exhibitions: the annual whole-community summer exhibition; a photography exhibition of work by the Ukraine group; and a solo show for one of our participants, Tom, celebrating his production of 13 large dinosaur sculptures which were subsequently adopted by local schools, libraries and others.

We ran a successful pilot service offer at Hale Community Centre in the second half of the year, taking our service the Upper Hale/Sandy Hill community of Farnham. This brought several new clients to our service.

We were extremely proud of the successful implementation of a new partnership with the Farnham GPs Social Prescribing service, through which we have increased the support we provide on an 'early intervention' basis, enabling us to reach 8 new people via a quick and straightforward new referral route.

A special collaboration with the design team at Arcadis, Brighton saw the purchase of a collection of Creative Response works for a new local NHS facility. And we were very pleased, at the suggestion of one of our participants, to be able to support our community through a new partnership with Sport in Mind, with whom we started a dedicated walking group for our community in June 2023.

A comprehensive review of our policies and procedures this year strengthened several aspects of practice and our governance arrangements, including the production of a new team policy handbook published in September 2023.

Financial Review

a. GOING CONCERN

After making appropriate enquiries, the Trustees have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. For this reason they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Accounting Policies.

b. RESERVES POLICY

The Trustees have set a reserves policy to hold a minimum of three month's operating costs to account for fluctuations in income

c. PRINCIPAL FUNDING

Surrey County Council remained a significant funder of the service, including through a Better Care Fund grant. Some participants were supported by Hampshire and Berkshire County Councils as well as through grant funding from a number of local charitable trusts, including in particular the Broadhurst Trust, with whom we are very fortunate to enjoy a strong and enduring partnership.

We remain very grateful for support this year from donors to the Community Foundation for Surrey, the Post Code Society Trust, the National Lottery Heritage Fund, Music at the Pottery, Farnham Hedgehogs, South Street Trust, Farnham Town Council, St.Peter's Charity Woking, Farnham Institute, Farnham Lions, and Sport England.

No income was received from outside of the UK.

d. RISK MANAGEMENT

The Trustees continue to regularly review the key organisational risks, in particular those related to safeguarding, fundraising and financial risks and the Board remains satisfied that systems and procedures are in place to mitigate our exposure to the major risks.

We are pleased to report that the Charity had no reportable incidents during the reporting year.

e. FUNDS

A portion of funds held are defined as restricted. See Section 11 for details of restricted funds.

f. RESULTS FOR THE YEAR

The results for the year and the financial position of the company are as shown in the annexed financial statements.



NOTES TO THE FINANCIAL STATEMENTS

1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS 102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

Creative Response (Arts) Limited meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

1.2 Company Status

The company is a company limited by guarantee. The members of the company are the Trustees named on page . In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

1.3 Going concern

The Trustees consider that there are no material uncertainties about the company's ability to continue as a going concern.

1.4 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the company and include project management carried out at Headquarters. Governance costs are those incurred in connection with administration of the company and compliance with constitutional and statutory requirements.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation. A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed assets may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, on a reducing balance basis.

1.7 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.8 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.9 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

1.10 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

1.11 Operating leases

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the lease term.

1.12 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the company for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

The Trustees (who are also Directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Creative Response (Arts) Limited for the year ended 31 March 2023.

The Annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the company qualifies as small under section 382 of the Companies Act 2006, the Strategic report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Structure, governance and management

a. CONSTITUTION

Set up in 1993, Creative Response (Arts) Limited was incorporated as a company limited by guarantee on 11 March 1997 with company registration number 04404746 (England and Wales) and was set up by memorandum and articles of association on 27 March 2002. It is a registered charity, registration number 1096890 (England and Wales).

The principal object of the company is to relieve persons with mental health problems or alcohol or drug problems by provision of therapeutic arts activities. Geographically, we will provide arts for wellbeing services to people who live in Surrey and North East Hampshire.

The charity's administrative function comprises a Chief Executive Officer, Operations Manager, and a finance administrator.

A team of paid Arts Workers and volunteers, as well as student placements from Universities and Colleges run the sessions for participants.

There have been no changes in the objectives since the last annual report.

b. METHOD OF APPOINTMENT OR ELECTION OF TRUSTEES

The management of the company is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

Each new trustee needs to be proposed and then seconded by current Trustees. Once appointed, they then attend the regular Trustee meetings. In addition to this each Trustee will specialise in their own area of interest/expertise in order to assist the Charity.

c. ORGANISATIONAL STRUCTURE AND DECISION MAKING

Creative Response (Arts) Limited, as an organisation, has a board of trustees, currently five, but the board by its governing document may continue to manage with two trustees.

Creative Response (Arts) Limited has a Chief Executive Officer assisted by an Operations Manager, a finance administrator, 12 arts workers and 7 volunteers. We use practising artists who worked on a part-time, self-employed basis. We also contracted an HR person on a fixed term contract to assist with HR policies.

All Trustees, Staff, Arts Workers and Volunteers receive DBS checks on a regular basis. Trustees received no remuneration or benefit, no staff received a remuneration of over £60,000. Our highest paid member of staff received remuneration and benefits of £30,037 in the financial year reported.

The Chief Executive Officer has overall responsibility for the day-to-day management of the organisation.

The company undertook a strategy review in January 2023 which confirmed our primary objectives as the following:

- Provide a safe space for people to explore the arts and creativity to make social and community connections for their mental health and well-being and to enable them to live their lives to their fullest potential.

Review premises options with the objective to improve disabled access.

- Continue to develop collaborative partnership such as those developed with Active Learning, Daisy and Space2Grow as well as working with the Farnham Library and other charities to offer our services to more participants and enhance space available to disabled participants.
- Hours of Operation:
We provide face-to-face services Monday through Friday, usually 10 till 3, as well as remote zoom services on a Tuesday afternoon. We also provide creative writing sessions on a Thursday.
- Funding priorities are:
To protect existing funding base.
Strengthen our relationships with Surrey County Council Adult Social care and North Hants Adult Social Care.
Build upon our relationships with Broadhurst, Active Learning, Daisy charities as well as NE Hants social services and social prescribing organisations.

Seek to increase funding base by exploring new sources.

We have now successfully transitioned from our covid model to a steady state face to face delivery model. We have started an exciting new partnership with Active Learning to provide sessions for Ukraine refugees.

We are extremely grateful for the support we received from Farnham and Surrey Councils, NE Hants Adult Social Services and Care Commissioning Group, NHS Frimley, CFFS, the Post Code Lottery fund, Farnham Hedgehogs, South Street Trust and Broadhurst charity. We would also like to thank the Mayor of Waverley for choosing to make us one of his charities of the year and for his and the Mayor of Farnham for their unstinting support.

Objectives and Activities

a. POLICIES AND OBJECTIVES

Creative Response is an arts for wellbeing charity working with individuals who are vulnerable due to mental ill-health, physical or learning disabilities or substance misuse problems. Practising artists work alongside participants to share skills, knowledge and creativity in a safe and supportive environment. This gives a new focus and the experience of engaging with life in a different way. The aim is to foster resilience and so enable them to move on to achieve greater independence.

b. MAIN ACTIVITIES UNDERTAKEN TO FURTHER THE CHARITY'S PURPOSES FOR PUBLIC BENEFIT

Creative Response is an independent, arts for wellbeing organisation, established by professional practising artists who offer a unique, supportive environment, promoting personal resilience and wellbeing through art.

We offer creative sessions of person centred support, based on a foundation of mutual trust.

Transferable life skills gained through participation in art, craft, music and performance to maintain wellbeing. An Outreach service is available for those struggling to access our service.

There is a continuing emphasis on building resilience and independence.

We take referrals from Surrey, Hampshire and Berkshire through key workers, CPN, Occupational Therapist, GP, CMHRS, Adult Social Care and Self-Referral.

We have this year increased our offering to provide sessions five days a week at our offices in Farnham in Surrey, as well as continuing on-line sessions. We also provide an on-line creative writing group.

As a result of this and the collaborative work with other organisations we have been able to increase the number of people we support by 35 people to a total of 115. Our core participant attendance has increased by 5 to 85 and we have, through our partnership with Active Learning, added a further 30 people.

In addition, Creative Response has its own dedicated professional exhibition space that hosts seasonal exhibitions of our artists' work. Once again, we hosted our highly successful Summer Exhibition featuring works by our participants and Arts Workers. Other highlights include a solo exhibition by one of our participants at The Pottery Wrecclesham, participation in SAOS winter exhibition, an innovative partnership with Active Learning to help Ukrainian refugees and a collaboration with Univeristy for the Creative Arts Farnham to provide specialist arts workshops throughout the year. We have also developed and strengthened relationships with local cultural organisations including University of Creative Arts in Farnham, Farnham Maltings, DAISY, Space2Grow, Red Box Gallery and Stoppap Dance Company.

We were also delighted to take part in the Farnham Literary Festival.

Achievements and performance

We provide case studies and regular updates on individual's progress. We also provide full details of projects and money spent to our grant providers such as Community Foundation for Surrey and the Postcode Lottery. Our individual grants generally have specific outcomes against which we report to the funders in line with our agreements with them.

Creative Response agreed a new agreement in 2022 with Surrey Council, whereby, Participants were directly supported by Surrey Adult Social Care. We have also agreed a collaboration with Broadhurst to extend participant support in NE Hants.

We have also formed a partnership with Active Learning to provide sessions to Ukrainian refugees.

In addition, we have enhanced our collaboration with the University for the Creative Arts to run a series of workshops.

We have also taken part in the Farnham literary festival, with a number of participants reciting their own work at the festival.

Although the majority of our participants have enduring health issues, we have been successful in reducing demands of participants on the health service and adult social services.

Our services have now fully recovered from the impact of the pandemic.

We have also increased the number of people supported by 35.

The Board would like to record their gratitude for the amazing work done by our Arts Workers, Volunteers, office staff and Participants during the past year.

Financial Review

a. GOING CONCERN

After making appropriate enquiries, the Trustees have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. For this reason they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Accounting Policies.

b. RESERVES POLICY

The Trustees have set a reserves policy to hold a minimum of three month's operating costs to account for fluctuations in income.

c. PRINCIPAL FUNDING

Our Principal Funding came from Surrey County Council Adult Social Care, NE Hants CMHRS, NE Hants Adult Social Care, Broadhurst charity, Private Funding, Grants. The Friends Scheme and other donations have continued steadily throughout the year. We have also increased our funding through Grants from a wide range of sources. Specific projects and workshops are funded through separate fundraising.

No income was received from outside of the UK.

d. RISK MANAGEMENT

The Trustees have reviewed our risk management policies and procedures and have assessed the major risks to which the company is exposed, in particular those related to premises, safeguarding, funding and financial risk. The company is satisfied that systems and procedures are in place to mitigate our exposure to the major risks.

In 2022/2023 we reviewed our Risk Register, conflict of interest policy and completed an overhaul of our main policies and procedures. We also updated our fire risk assessment. We have also continued to review and improve our core policies and governance structures.

We are pleased to report that the Charity had no reportable incidents during the reporting year.

e. FUNDS

A portion of funds held are defined as restricted. See Section 11 for details of restricted funds.

f. RESULTS FOR THE YEAR

The results for the year and the financial position of the company are as shown in the annexed financial statements.





1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS 102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

Creative Response (Arts) Limited meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

1.2 Company Status

The company is a company limited by guarantee. The members of the company are the Trustees named on page . In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

1.3 Going concern

The Trustees consider that there are no material uncertainties about the company's ability to continue as a going concern.

1.4 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

1. Accounting policies (continued)

1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the company and include project management carried out at Headquarters. Governance costs are those incurred in connection with administration of the company and compliance with constitutional and statutory requirements.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation. A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed assets may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, on a reducing balance basis.

1.7 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.8 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.9 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

1.10 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

1.11 Operating leases

Rentals paid under operating leases are charged to the Statement of financial activities on a straight line basis over the lease term.

1.12 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the company for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

TRUSTEES' REPORT
FOR THE YEAR ENDED 31 MARCH 2022

The Trustees (who are also Directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Creative Response (Arts) Limited for the year ended 31 March 2022.

The Annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the company qualifies as small under section 382 of the Companies Act 2006, the Strategic report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Structure, governance and management

a. CONSTITUTION

Set up in 1993, Creative Response became a company limited by guarantee in 2003 with company registration number 04404746 (England and Wales) and was set up by memorandum and articles of association on 7 April 2003. It is a registered charity, registration number 1096890 (England and Wales).

The principal object of the company is to relieve persons with mental health problems or alcohol or drug problems by provision of therapeutic arts activities. Geographically, we will provide arts for wellbeing services to people who live in Surrey and North East Hampshire.

The charity's administrative function comprises an Chief Officer, an Operations Manager, a financial support person and media administrator, both working 2- 3 days per week.

A team of paid Arts Workers and volunteers, as well as student placements from Universities and Colleges run the sessions for participants

There have been no changes in the objectives since the last annual report.

b. METHOD OF APPOINTMENT OR ELECTION OF TRUSTEES

The management of the company is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

Each new trustee needs to be proposed and then seconded by current Trustees. Once appointed, they then attend the regular Trustee meetings. In addition to this each Trustee will specialise in their own area of interest/expertise in order to assist the Charity.

c. ORGANISATIONAL STRUCTURE AND DECISION MAKING

Creative Response (Arts) Limited, as an organisation, has a board of trustees, usually five but the board by its governing document may continue to manage with two trustees.

Creative Response (Arts) Limited has a Chief Officer assisted by an Operations Manager, a media administrator, a finance person, 12 arts workers and 7 volunteers. We use practising artists who on a work part time, self-employed basis.

All Trustees, Staff, Arts Workers and Volunteers receive DBS checks on a regular basis. Trustees received no remuneration or benefit, no staff received a remuneration of over £60,000. Our highest paid member of staff received remuneration and benefits of £19499 in the financial year reported.

The Chief Officer has overall responsibility for the day-to-day management of the organisation. Hannah Dix resigned on 2 September 2021. The charity successfully recruited a replacement, Kathryn McManus, who joined the charity on 4 January 2022.

We would like to thank Hannah for her hard work, dedication and overall contribution to the charity during the especially challenging times of the Covid-19 pandemic

The company has developed a strategic plan, which has the following as its primary objectives:

- Provide participants with a safe space to enable them to develop coping mechanisms and resilience, new skills through art and to enable them to live their lives to their fullest potential.
- Maintain our current range of services including:
 - Provision of a safe and caring environment
 - Use of art to help develop coping mechanisms
 - Provide opportunities to work on collaborative projects to enhance creative skills and experiences
 - Use events and exhibitions to showcase participants talents
 - Extend outreach program to support participants who cannot utilise the core facility
 - Provide support for those who are able and wish to become more independent
- Maintain our core values, ethos and behaviors, as these are part of our greatest strengths.
- Promote our Values:
 - Participants needs come first
 - Provide a supportive and caring people and environment
 - Developing everyone's potential
 - Understanding participants individual needs
- Environment
 - Remain in current premises.
 - Continue to develop collaborative partnership such as those developed with Daisy and Space2Grow as well as working with the Library and other charities to offer our services to more participants and enhance space available to disabled participants.
- Hours of Operation:
 - As a result of Covid-19 we adapted our services and provided until April 2022 Covid-19 compliant face-to-face sessions Tuesday through Thursday 10 till 3. Friday 10 till 12 as well as remote zoom services Tuesday and Thursday afternoons. We provide music sessions on Friday afternoons and creative writing sessions on a Thursday.

- Funding Priorities are:
 - To protect existing funding base.
 - Ensure smooth transfer from Catalyst block funding to direct funding via Surrey County Council Adult Social care. The Catalyst contract ended 31 March 2022.
 - Expand our relationships with Broadhurst charity as well as NE Hants Care Commissioning Group, NE Hants social services and social prescribing organisations.
 - Seek to increase funding base by exploring new sources

As a result of Covid-19 the Charity restricted face-to-face services from our premises in Farnham from April 2021. Face to face was delivered in two hour sessions fully Covid-19 compliant and where weather permitted in outdoor sessions Unfortunately due to the impact of covid-19 our Cranleigh service was no longer viable. We did however provide on line services to those who cannot travel to Farnham.

We gained sufficient funding through grants to enable us to continue to offer a range of services throughout the year, culminating with a return to full service provision in April 2022. We also ran a project targeted at young people under 25, a small number of whom now attend the full service. In addition we ran a successful collaboration with the Space2 Grow Charity in Farnham to provide permanent creative arts works for all to enjoy in the Space2Grow garden. We celebrated nature through exhibitions and published an anthology of poems on the subject. We are extremely grateful for the support we received from Farnham and Surrey Council, NE Hants Adult Social Services, CFFS and the Post Code Lottery fund, during this challenging period. We have successfully continued to provide services and support to our participants:

- Online Arts Services
- Supply of Arts packs and activity sheets by Post
- Open-air Arts sessions
- Telephone support to participants

Creative Response is an arts for wellbeing charity working with individuals who are vulnerable due to physical, mental, learning difficulties and substance misuse problems. Practising artists work alongside participants to share skills, knowledge and creativity in a safe and supportive environment. This gives a new focus and the experience of engaging with life in a different way. The aim is to foster resilience and so enable them to move on to achieve greater independence.

b. MAIN ACTIVITIES UNDERTAKEN TO FURTHER THE CHARITY'S PURPOSES FOR PUBLIC BENEFIT

Creative Response is an independent, arts for wellbeing organisation, established by professional practising artists who offer a unique, supportive environment, promoting personal resilience and wellbeing through art.

We offer creative sessions of person centred support, based on a foundation of mutual trust.

Transferable life skills gained through participation in art, craft, music and performance to maintain wellbeing. An Outreach service is available for those struggling to access our service with a view to them joining the art group for the social element as well as the creativity.

There is a continuing emphasis on building resilience and independence.

We take referrals from Surrey, Hampshire and Berkshire through key workers, CPN, Occupational Therapist, GP, CMHRS, Adult Social Care and Self-Referral.

We run different sessions over four days a week at our offices in Farnham in Surrey, as well as on line sessions. We also provide a creative writing group, a music session once per week and telephone support for those who cannot attend any sessions.

In addition, Creative Response has its own dedicated professional exhibition space that hosts seasonal exhibitions of our artists work. We have also developed relationships with local cultural organisations including University of the Creative Arts in Farnham, Cranleigh Arts Centre, Farnham Maltings, DAISY, Space2Grow, Red Box Gallery and Stopgap Dance Company.

Achievements and performance

a. KEY FINANCIAL PERFORMANCE INDICATORS

Statistics have been submitted on a quarterly basis with case studies to Catalyst and Surrey County Council Partnership that provides details of the costs of our service and evidence of performance criteria related to the Recovery Star, referrals and discharges as well as other key performance indicators. We also provide details of projects and money spent to our grant providers such as community Foundation for Farnham and the Postcode Lottery.

b. REVIEW OF DEVELOPMENTS, ACHIEVEMENTS AND PERFORMANCE

Creative Response received in 2018, a three-year contract to be part of Community Connections and The Welcome Project, extended for a further year in 2021. This funding came to an end in March 2022 and has been replaced with a new agreement directly with Surrey Council, whereby, Participants will be directly supported by Surrey Adult Social Care. We have also agreed a collaboration with Broadhurst to extend participant support in NE Hants.

Although the majority of our participants have enduring health issues we have been successful in helping them cope through the Covid-19 restrictions and as a result we believe we have been able to reduce demands of participants on the health service and adult social services. We have encouraged the development of participants' creativity and as a result held a number of exhibitions by participants and historically have enabled a small number to go on to take academic Arts degrees.

Despite the impact of the pandemic we have successfully maintained services either as a remote on line service or latterly with face-to-face sessions for those who are able to do so. The period of the pandemic has been particularly challenging for our participants and sadly a small number succumbed to the virus, they will be sadly missed. We are proud to have been able to support our participants throughout the pandemic and have through the use of technology been able to provide new types of service.

The Board would like to record their gratitude for the amazing work done by our Arts Workers, Volunteers and office staff during this extremely challenging period.

We have been extremely fortunate to benefit from grants and rent rebates from Surrey County Council Community Foundation for Surrey, Post Code Lottery and many others.

Financial Review

a. GOING CONCERN

After making appropriate enquiries, the Trustees have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. For this reason they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Accounting Policies.

b. RESERVES POLICY

The Trustees have set a reserves policy to hold one month's operating costs to account for fluctuations in income.

c. PRINCIPAL FUNDING

Our Principal Funding came from a combination of our contract through the Welcome Project, administered by Catalyst from Surrey County Council Partnership, Private Funding, Grants and collaboration with other charities. This Welcome Project contract was worth £50,000 per annum. Following the ending of the contract we have signed a new contract with Surrey County Council to provide direct funding for participants. In addition we have agreements to provide services to participants referred to us by NE Hampshire and Broadhurst Charity. Participants from these services are invoiced based upon sessions provided. In 2021/22 we have as part of our funding strategy continued to increase the number of private payments. The Friends Scheme and other donations have continued steadily throughout the year. We have also increased our funding through Grants from a wide range of sources. Specific projects and workshops are funded through separate fundraising.

No income was received from outside of the UK.

d. RISK MANAGEMENT

The Trustees have reviewed our risk management policies and procedures and have assessed the major risks to which the company is exposed, in particular those related to on-going pandemic risks, safeguarding, funding and financial risk. The company is satisfied that systems and procedures are in place to mitigate our exposure to the major risks.

In 2021/2022 we reviewed our Risk Controls, Business Continuity Plans, security and fire risk assessments.. We have also continued to review and improve our core policies and governance structures.

We are pleased to report that the Charity had no reportable incidents during the reporting year.

e. FUNDS

A significant portion of funds held are defined as restricted. See Section 11 for details of restricted funds.

f. RESULTS FOR THE YEAR

The results for the year and the financial position of the company are as shown in the annexed financial statements.

g. SMALL COMPANY PROVISIONS

This report has been prepared in accordance with the special provisions relating to companies subject to the small companies regime within Part 15 of the Companies Act 2006.





1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS 102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

Creative Response (Arts) Limited meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

1.2 Company Status

The company is a company limited by guarantee. The members of the company are the Trustees named on page . In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

1.3 Going concern

The Trustees consider that there are no material uncertainties about the company's ability to continue as a going concern.

1.4 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the company and include project management carried out at Headquarters. Governance costs are those incurred in connection with administration of the company and compliance with constitutional and statutory requirements.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation. A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed assets may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, on a reducing balance basis.

1.7 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.8 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.9 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

1.10 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

1.11 Operating leases

Rentals paid under operating leases are charged to the Statement of financial activities on a straight line basis over the lease term.

1.12 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the company for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

The Trustees (who are also Directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Creative Response (Arts) Limited for the year ended 31 March 2021.

The Annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the company qualifies as small under section 382 of the Companies Act 2006, the Strategic report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Structure, governance and management

a. CONSTITUTION

Set up in 1993, Creative Response became a company limited by guarantee in 2003 with company registration number 04404746 (England and Wales) and was set up by memorandum and articles of association on 7 April 2003. It is a registered charity, registration number 1096890 (England and Wales).

The principal object of the company is to provide an arts for wellbeing service to people who live in Surrey and North East Hampshire.

The charity's administrative function comprises a financial support person and an administrator, both working 2-3 days per week.

A team of paid Arts Workers and volunteers, as well as student placements from Universities and Colleges run the sessions for participants.

There have been no changes in the objectives since the last annual report.

b. METHOD OF APPOINTMENT OR ELECTION OF TRUSTEES

The management of the company is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

Each new trustee needs to be proposed and then seconded by current Trustees. Once appointed, they then attend the regular Trustee meetings. In addition to this each Trustee will specialise in their own area of interest/expertise in order to assist the Charity.

c. ORGANISATIONAL STRUCTURE AND DECISION MAKING

Creative Response (Arts) Limited, as an organisation, has a board of trustees, usually six but the board by its governing document may continue to manage with two trustees.

Creative Response (Arts) Limited has a Chief Officer assisted by an administrator, a finance person, 12 arts workers and 7 volunteers. We use practising artists who on a work part time, self-employed basis.

All Trustees, Staff, Arts Workers and Volunteers receive DBS checks on a regular basis. Trustees received no remuneration or benefits, no staff received a remuneration of over £60,000. Our highest paid member of staff received remuneration and benefits of £24,241.82 in the financial year reported.

The Chief Officer has overall responsibility for the day-to-day management of the organisation. Hannah Dix resigned on 2 September 2021 in order to look after her recently bereaved father. The charity is currently recruiting a replacement and hopes to have a suitably qualified person in place by December 2021. We would like to thank Hannah for her hard work, dedication and overall contribution to the charity during the especially challenging times of the Covid-19 pandemic.

The company has developed a strategic plan, which has the following as its primary objectives:

- Provide participants with a safe space to enable them to develop coping mechanisms and resilience, new skills through art and to enable them to live their lives to their fullest potential.
- Maintain our current range of services including:
 - Provision of a safe and caring environment
 - Use of art to help develop coping mechanisms
 - Provide opportunities to work on collaborative projects to enhance creative skills and experiences
 - Use events and exhibitions to showcase participants talents
 - Extend outreach program to support participants who cannot utilise the core facility
 - Provide support for those who are able and wish to become more independent
- Maintain our core values, ethos and behaviors, as these are part of our greatest strengths.
- Promote our Values:
 - Participants needs come first
 - Provide a supportive and caring people and environment
 - Developing everyone's potential
 - Understanding participants individual needs
- Environment
 - Remain in current premises.
 - Continue to develop collaborative partnership such as those developed with Daisy and Space2Grow as well as working with the Library and other charities to offer our services to more participants and enhance space available to disabled participants.
- Hours of Operation:
 - As a result of Covid-19 we have had to adapt our services. We now provide Covid-19 compliant face-to-face sessions Tuesday through Thursday 10 till 3. Friday 10 till 12 as well as remote zoom services Tuesday and Thursday afternoons. We provide music sessions on Friday afternoons.

As a result of Covid-19 the Charity suspended all services from our premises in Farnham and Cranleigh, on 23 March 2020 and closed our premises at Vernon House Farnham.

We gained sufficient funding through grants to enable us to offer online and open-air services throughout the summer and into spring 2021. We are extremely grateful for the support we received from Farnham and Surrey councils during this challenging period. We have successfully continued to provide services and support to our participants. As part of our response to the pandemic we launched our Re-Connect Service in July 2020, which provided Participants with the following support:

- Online Arts Services
- Supply of Arts packs and activity sheets by Post
- Open-air Arts sessions
- Telephone support to participants

With the easing of Covid-19 restrictions we re-launched covid-19 compliant face to face services at our Farnham premises in April 2021 whilst continuing to provide remote services for those participants who were unwilling or unable to come to the face to face sessions.

Objectives and Activities

a. POLICIES AND OBJECTIVES

Creative Response is an Arts for wellbeing charity working with individuals who are vulnerable due to physical, mental, learning difficulties and substance misuse problems. Practising artists work alongside participants to share skills, knowledge and creativity in a safe and supportive environment. This gives a new focus and the experience of engaging with life in a different way. The aim is to foster resilience and so enable them to move on to achieve greater independence and move on to different services.

b. MAIN ACTIVITIES UNDERTAKEN TO FURTHER THE CHARITY'S PURPOSES FOR PUBLIC BENEFIT

Creative Response is an independent, arts for wellbeing organisation established by professional practising artists who offer a unique, supportive environment, promoting personal resilience and wellbeing through art.

We offer creative sessions of person centred support, based on a foundation of mutual trust.

Transferable life skills gained through participation in art, craft, music and performance maintain wellbeing. An Outreach service is available for those struggling to access our service with a view to them joining the art group for the social element as well as the creativity.

There is a continuing emphasis on building resilience and independence.

We take referrals from Surrey, Hampshire and Berkshire through key workers, CPN, Occupational Therapist, GP, CMHRS, Adult Social Care and Self-Referral.

We run different sessions over four days a week at our offices in Farnham in Surrey, as well as on line sessions. Sadly as a result of Covid-19 we have had to suspend our outreach sessions at Cranleigh. We also provide a creative writing group, a music session once per week and telephone support for those who cannot attend any sessions.

In addition, Creative Response has its own dedicated professional exhibition space that hosts seasonal exhibitions of our artists work. We have also developed relationships with local cultural organisations including University of the Creative Arts in Farnham, Cranleigh Arts Centre, Farnham Maltings, DAISY, Space2Grow and Stopgap Dance Company.

Finally, we have recognised the impact of the pandemic on our staff and arts workers and have started providing a counselling service for those who wish or need external support.

Achievements and performance

a. KEY FINANCIAL PERFORMANCE INDICATORS

At present statistics are submitted on a quarterly basis with case studies to Catalyst and Surrey County Council Partnership that provides details of the costs of our service and evidence of performance criteria related to the Recovery Star, referrals and discharges as well as other key performance indicators.

b. REVIEW OF DEVELOPMENTS, ACHIEVEMENTS AND PERFORMANCE

Creative Response received in 2018, a three-year contract to be part of Community Connections and The Welcome Project, extended for a further year in 2021. The funding comes from Surrey County Council Partnership and is administered through Catalyst. This allows greater security and we are one of 9 partners, which aids the sharing of good practice and resources. Statistics and case studies need to be submitted quarterly but they are collated by Catalyst then sent to the SCC Commissioner as Welcome Project/community connections statistics.

Although the majority of our participants have enduring health issues we have continued to be successful in reducing hospital admissions, A and E visits, GP visits and have enabled participants to become more self sufficient and independent. We have encouraged the development of participants' creativity and as a result held a number of exhibitions by participants and enabled a small number to go on to take academic Arts degrees. A number of participants have also become more independent.

Despite the impact of the pandemic we have successfully maintained services either as a remote on line service or latterly with face-to-face sessions for those who are able to do so. The period of the pandemic has been particularly challenging for our participants and sadly a small number succumbed to the virus, they will be sadly missed. We are proud to have been able to support our participants throughout the pandemic and have through the use of technology been able to provide new types of service.

We have been extremely fortunate to benefit from grants and rent rebates from Surrey County council as well as Community Foundation for Surrey, Barings Foundation and many others.

Financial Review

a. GOING CONCERN

After making appropriate enquiries, the Trustees have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. For this reason they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Accounting Policies.

b. RESERVES POLICY

The Trustees have set a reserves policy to hold one month's operating costs to account for fluctuations in income.

c. PRINCIPAL FUNDING

Our Principal Funding comes from a combination of our contract through the Welcome Project, administered by Catalyst from Surrey County Council Partnership. This contract is worth £50,000 per annum and is for a period of three years. The contract is up for renewal in April 2022. In addition we have agreements to provide services to participants referred to us by Adult Social Care Surrey and NE Hampshire. Participants from these services are invoiced based upon sessions provided. In 2020/21 we have as part of our funding strategy been able to increase the number of private payments. The Friends Scheme and other donations have continued steadily throughout the year. We have also increased our funding through Grants from a wide range of sources. Specific projects and workshops are funded through separate fundraising. No income was received from outside of the UK.

d. RISK MANAGEMENT

The Trustees have reviewed our risk management policies and procedures and have assessed the major risks to which the company is exposed, in particular those related to Covid-19, funding and financial risk. The company is satisfied that systems and procedures are in place to mitigate our exposure to the major risks.

In 2020/2021 we reviewed our Risk Controls, Business Continuity Plans and risk assessments as a result of the impact of the pandemic. We have also continued to review and improve our core policies and governance structures.

We are pleased to report that the Charity had no reportable incidents during the reporting year.

e. FUNDS

A significant portion of funds held are defined as restricted. See Section 11 for details of restricted funds.

f. RESULTS FOR THE YEAR

The results for the year and the financial position of the company are as shown in the annexed financial statements.

1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS 102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

Creative Response (Arts) Limited meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

1.2 Company Status

The company is a company limited by guarantee. The members of the company are the Trustees named on page . In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

1.3 Going concern

The Trustees consider that there are no material uncertainties about the company's ability to continue as a going concern.

1.4 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the company and include project management carried out at Headquarters. Governance costs are those incurred in connection with administration of the company and compliance with constitutional and statutory requirements.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation. A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed assets may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, on a reducing balance basis.

1.7 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.8 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.9 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

1.10 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

1.11 Operating leases

Rentals paid under operating leases are charged to the Statement of financial activities on a straight line basis over the lease term.

1.12 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the company for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.
