**Activities:** Raising funds by organising various events, functions, raffles etc. Disbursing funds for various welfare purposes to individuals & organisations such as local appeals to fund hospice, CAT scanners. Sponsor young people both locally and overseas. Water Aid and Lions global projects such as Sight First.
