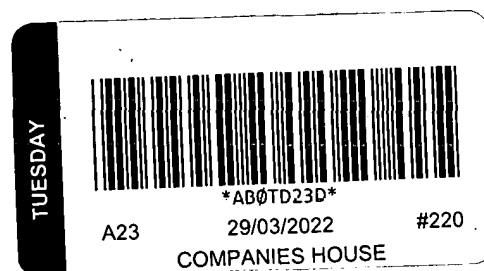

Report of the trustees for the period ended 30th November 2021

The trustees, who are also directors of the charity for the purposes of the Companies Act, are pleased to present their report together with the financial statements of the charity for the year ended 30th November 2021.

Legal and administration information set out on page 3 forms part of this report. The financial statements comply with current statutory requirements, the memorandum and articles of association and the Statement of Recommended Practice 2005 - Accounting and Reporting by Charities and Financial Reporting Standard 102 (FRS 102).

Object of the charity

The object of the charity is to improve the lives of children and young adults in Nottinghamshire who suffer from moderate to very severe learning and/or physical disability by funding facilities and services designed to provide fun, friendship, care and stimulation.

Organisation

A board of trustees met twice in the year to administer the charity. Representatives of each of the organisations we fund sit on the board of trustees or attend Board Meetings.

The charity has no paid staff and no fees are paid to any director/trustee.

The trustees of Fundays have adopted a formal "Equal Opportunities Policy" Those we fund are required to operate to the highest of standards.

We require the organisations we fund to have formal policies relating to "Health & Safety" and "Safeguarding, Children and Vulnerable Adult Protection" They are charged with adopting and monitoring the implementation of those policies.

Investment powers

Under the memorandum and articles of association, the charity has the power to make any investments which the trustees see fit. The policy of the trustees regarding investment of funds is to ensure security and liquidity.

Trustees

As a company limited by guarantee, the charity's trustees are directors appointed in accordance with Company Law and the memorandum and articles of association. New trustees are appointed by the director/trustees of the Company at board meetings.

The trustees' policy in seeking to recruit new trustees is to ensure a broad mix of skills and experience. New volunteer trustees are sought who will add to and complement those skills of the existing trustee body. The reputation, integrity and suitability of prospective trustees are examined before appointment.

Review of activities and future developments

Fundays in Nottinghamshire funds the provision of education, fun, recreation, friendship and stimulation for children and young adults with moderate to very severe physical and/or learning disabilities in Nottinghamshire. In order to make a significant difference to the lives of the young disabled amongst us, we need financial support, and are grateful to those who have provided it. In the year ended 30 November 2021, amongst the organisations and individuals that supported us were:

Without continuing support, we would have to disappoint the most vulnerable in our County, and it is our resolve that this must not happen. We will continue to ask for finance, and we will look to existing supporters for continuity while, at the same time, trying to open new avenues.

The Covid-19 Pandemic has continued to have a major impact on activities but in the summer 2021 we were delighted to continue our financial support of APTCOO in Mansfield and Retford and the summer schools at Yeoman Park School in Mansfield Woodhouse and summer activities provided by Rainbows.

Due to the pandemic the summer school and adult week at Oak Field School did not take place in the summer of 2021.

The Nottingham Theatre of Citizens continues to thrive in its new home at Nottingham high School for Girls and they are working on a new production. During August 2021, the group also managed some socially distanced meetings at the Arboretum, which were successful. Tutors continue to monitor individual student needs. The Magenta Dance Group is thriving at its new home at Dance4 in Sneinton. The Poetry Group will be running at the University of Nottingham in Spring 2022. The tutors for the different groups are ever mindful of the necessity to ensure safe practices whilst the pandemic is still with us.

The young people who we aim to help are a most vulnerable group, borne out of isolation, rejection and low self-esteem. The pandemic has highlighted this even more as the young people are in high-risk groups, many of whom had to shield for long periods. This vulnerability can leave them open to abuse of every kind. Often, their family circumstances mean that life opportunities are very limited – their chances to develop friendships are minimal. Our funding makes it possible for them to share enjoyable experiences and, through those shared experiences, to make friends and to have a greater understanding of the wider world including increased contact with the general community. This promotes inner strength and enhances self-esteem which does help to empower these vulnerable young people so that they have the self-respect to better stand up to abuse. The object is to allow people with disabilities to feel better

about themselves, and to support and sustain those better feelings, leading to happier lives. It has been wonderful to observe the young people as they return to more normal ways in which they can meet their friends.

In 2021, we financially supported the following events, some of which continue on a weekly basis. See above for notes on activities during the current Pandemic.

The trustees take due regard of the Charity Commission's guidance on public benefit when funding the events listed below. Many of the events we fund would not have been available to the disabled children and young people had it not been for the financial support offered by the charity.

Theatre Arts Group

"The Nottingham Theatre of Citizens" – established for age group 18-40 with about 30 young adults participating, all with moderate to severe learning difficulties, meets in central Nottingham for 36 evening sessions each year. It is a very successful theatrical production company, run by young tutors with appropriate skills, and is a great source of pleasure to all.

Magenta Dance Group

Weekly sessions for about 15 people, age group 19-40, meets in central Nottingham and is open to all with learning difficulties.

Poetry Group

We are funding a poetry course at Nottingham University for young adults with learning difficulties between January 2022 and March 2022. The course always receives very positive feedback from attendees.

FunDays in Conjunction with APTCOO (A Place To Call Our Own)

In 2021 we continued our successful relationship with APTCOO in Mansfield who, with our financial support, provided activities in the summer in Mansfield and in Retford. This was well received by the children attending. By pooling our resources, they are able to increase provision for our shared audience.

FunDays supporting Yeoman Park School and activities organised by Rainbow

Financial support from FunDays enabled the schools to operate a two-week summer school. The feedback was universally excellent. Without FunDays this would not have been possible.

Some of the activities we will be supporting in 2022 include

- Magenta Dance Group**
- Nottingham Theatre of Citizens**
- Poetry Group**
- APTCOO Summer activities**
- Yeoman Park Summer Scheme**

We plan to continue financial support for our range of activities. Clearly the current pandemic has curtailed some activities and planning for the future is more uncertain. Fundays will work with any of the providers who are intending to run summer schools in 2022.

Funding

Although a number of backers continue to support us on an annual basis this is becoming more difficult as demands increase. With this in mind we hope that all will understand the reason for us maintaining cash in the bank, and we will be pleased to talk to anyone to provide clarification. We hope that our supporters will understand the trustees' policy that the proper way to avoid disappointing the disabled young is that we raise money in one year and use it in the following year.

Our Team

The trustees are impressed with the skilled, dedicated and kind personnel who run the events funded by us on a day today basis. Looking after the young with complex physical and mental disabilities requires special people, and we are indeed fortunate that such individuals work at the summer schools and other events. The children, the young adults and their carers have good reason to be grateful to them.

Reserves policy and risk management

During the year the trustees have reviewed progress against the objectives and as part of that process have carried out a review of the risks which face the charity. All such risks are considered low risk by the trustees. An annual review will continue in addition to a review whenever a significant change to policy, people or procedures takes place.

The trustees' target for reserves is that cash of at least an amount equivalent to the subsequent twelve months anticipated expenditure should be held. The plan over the next year (year 22 of the charity's existence) is for expenditure of approximately £45,000. Our reserves at the end of November 2021 were £64,869. The plan for year 2022 is to maintain the funding from private sources and to continue to fund organisations which provide ongoing activities.

Trustees' responsibilities in relation to the financial statements



Basis of independent examiner's statement





1. Accounting policies

The principal accounting policies are summarised below. These policies have been applied consistently throughout the year and in the preceding year.

a) Basis of accounting

The financial statements have been prepared under the historical cost convention, in accordance with the Companies Act 2006 and the Statement of Recommended Practice; Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Charities Act 2011. There are no differences to be reported after adopting FRS 102 for the first time.

b) Fund accounting

Funds held by the charity are either:

- *Unrestricted general funds* – these are funds which can be used in accordance with the charitable objects at the discretion of the trustees.
- *Designated funds* – these are funds set aside by the trustees out of unrestricted general funds for specific future purposes or projects.
- *Restricted funds* – these are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

c) Incoming Resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income. All such income is derived from donations, grants and fundraising lunches.

d) Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred and includes any irrecoverable VAT. The charity makes grants to schools and therefore incurs no direct costs but simply supports the summer schools or similar events by funding. Other groups are supported in a similar manner. Details of these costs are listed in note 3.

e) Interest receivable

Interest is included on an accrual's basis.

2. Legal status of the charity

The charity is a company limited by guarantee and has no share capital. The liability of each member in the event of winding-up is limited to £10.

The Nottingham Theatre of Citizens has continued on line. During August 2020, the group did manage some socially distanced meetings at the Arboretum, which were successful. The group returned to College Street in the Autumn, but further restrictions led to a return to on line activity. Tutors continue to monitor individual student needs. London Academy of Music and Dramatic Arts (LAMDA) courses have continued on line. Magenta Dance Group met again when regulations allowed but had to close during restrictions. The Poetry Group met until the lock down in March.

Trustees have supported the Playhouse Platform for adults with learning disabilities. Again this continued mainly on line.

The young people who we aim to help are a most vulnerable group, borne out of isolation, rejection and low self-esteem. The pandemic has highlighted this even more as the young people are in high risk groups, many having to shield. This vulnerability can leave them open to abuse of every kind. Often, their family circumstances mean that life opportunities are very limited – their chances to develop friendships are minimal. Our funding makes it possible for them to share enjoyable experiences and, through those shared experiences, to make friends and to have a greater understanding of the wider world including increased

contact with the general community. In 2020 we continued our successful relationship with APTCOO in Mansfield who, with our financial support, provided activities in the summer in Mansfield and in Retford. This was well received by the children attending. By pooling our resources they are able to increase provision for our shared audience.

FunDays supporting Yeoman Park School and Ash Lea School

Financial support from FunDays enabled the schools to operate a two week summer school. The feedback was universally excellent. Without FunDays this would not have been possible.

Playhouse Platform – Fundays has supported this daytime theatre group run by Nottingham Playhouse for young adults with learning disabilities.

Events in 2021

We plan to continue financial support for our range of activities. Clearly the current pandemic has curtailed some activities and planning for the future is more uncertain. Fundays will work with any of the providers who are intending to run summer schools in 2021.

Funding

Although a number of backers continue to support us on an annual basis this is becoming more difficult as demands increase. With this in mind we hope that all will understand the reason for us maintaining cash in the bank, and we will be pleased to talk to anyone to provide clarification. We hope that our supporters will understand the trustees' policy that the proper way to avoid disappointing the disabled young is that we raise money in one year and use it in the following year.

Our Team

The trustees are impressed with the skilled, dedicated and kind personnel who run the events funded by us on a day today basis. Looking after the young with complex physical and mental disabilities requires special people, and we are indeed fortunate that such individuals work at the summer schools and other events. The children, the young adults and their carers have good reason to be grateful to them.

Reserves policy and risk management

During the year the trustees have reviewed progress against the objectives and as part of that process have carried out a review of the risks which face the charity. All such risks are considered low risk by the trustees. An annual review will continue in addition to a review whenever a significant change to policy, people or procedures takes place.

The trustees' target for reserves is that cash of at least an amount equivalent to the subsequent twelve months anticipated expenditure should be held. The plan over the next year (year 21 of the charity's existence) is for expenditure of approximately £70,000. Our reserves at the end of November 2020 were £64,869 (2019 £64,292). The plan for year 2021 is to maintain the funding from private sources and to continue to fund organisations who provide ongoing activities.

Trustees' responsibilities in relation to the financial statements


Company law requires the trustees to prepare financial statements that give a true and fair view of the state of affairs of the charity at the end of the financial year and of its surplus or deficit for the financial year. In doing so the trustees are required to:

**Report of the examiner
to the members of Fundays in Nottinghamshire**

I report on the accounts of the company for the year ended 30 November 2020 which are set out on pages 10 to 13.

Respective responsibilities of the trustees and examiner.



**Notes forming part of the financial statements
for the period ended 30th November 2020**

1. Accounting policies

The principal accounting policies are summarised below. These policies have been applied consistently throughout the year and in the preceding year.

a) Basis of accounting

The financial statements have been prepared under the historical cost convention, in accordance with the Companies Act 2006 and the Statement of Recommended Practice; Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Charities Act 2011. There are no differences to be reported after adopting FRS 102 for the first time.

b) Fund accounting

Funds held by the charity are either:

- *Unrestricted general funds* – these are funds which can be used in accordance with the charitable objects at the discretion of the trustees.
- *Designated funds* – these are funds set aside by the trustees out of unrestricted general funds for specific future purposes or projects.
- *Restricted funds* – these are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

c) Incoming Resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income. All such income is derived from donations, grants and fundraising lunches.

d) Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred and includes any irrecoverable VAT. The charity makes grants to schools and therefore incurs no direct costs but simply supports the summer schools or similar events by funding. Other groups are supported in a similar manner. Details of these costs are listed in note 3.

e) Interest receivable

Interest is included on an accrual's basis.

2. Legal status of the charity

The charity is a company limited by guarantee and has no share capital. The liability of each member in the event of winding-up is limited to £10.

8. Taxation

As a charity, Fundays in Nottinghamshire is exempt from income and gains falling within section 505 of the Taxes Act 1988 or S256 of the Taxation of Chargeable Games Act 1992 to the extent that these are applied to its charitable objects. No tax charges have arisen in the charity.

9. Related parties and overall control

The charity is an independent charity and is controlled by the trustees. In the year donations from trustees amounted to £370 (2018 £461). There were no other related party transactions.
