THE CREATION OF TRAINING OPPORTUNITIESF. THE PROVISION OF HOUSING FOR THOSE WHO ARE IN CONDITIONS OF NEED AND THE IMPROVEMENT OF HOUSING IN THE PUBLIC SECTOR OR IN CHARITABLE OWNERSHIP PROVIDED THAT SUCH POWER SHALL NOT EXTEND TO RELIEVING ANY LOCAL AUTHORITIES OR OTHER BODIES OF A STATUTORY DUTY TO PROVIDE OR IMPROVE HOUSINGG. THE MAINTENANCE, IMPROVEMENT OR PROVISION OF PUBLIC AMENITIESH. THE PROVISION OF RECREATIONAL FACILITIES FOR THE PUBLIC AT LARGE OR THOSE WHO BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, POVERTY OR SOCIAL AND ECONOMIC CIRCUMSTANCES, HAVE NEED OF SUCH FACILITIESI. THE PROTECTION OR CONSERVATION OF THE ENVIRONMENTJ. THE PROVISION OF PUBLIC HEALTH FACILITIES AND CHILDCAREK. THE PROMOTION OF PUBLIC SAFETY AND PREVENTION OF CRIMEL. SUCH OTHER MEANS AS MAY FROM TIME TO TIME BE DETERMINED SUBJECT TO THE PRIOR WRITTEN CONSENT OF THE CHARITY COMMISSIONERS FOR ENGLAND AND WALES
