Objects: 1) TO PROMOTE THE MAINTENANCE AND CONSERVATION OF THE ENVIRONMENT WITHIN THE HARROGATE AREA AND ESPECIALLY OF THE AREA KNOWN AS THE PINWOODS, SITUATED BETWEEN THE VALLEY GARDENS AND HARLOW CARR GARDENS, AND SUCH OTHER AREAS WITHIN THE HARROGATE DISTRICT WHICH THE CHARITY MAY FEEL FALLS WITHIN THEIR REMIT.2) TO PROMOTE AND ENCOURAGE THE CONSERVATION OF THE NATURAL HABITAT OF WILDLIFE IN THE AREA.3) TO ADVANCE THE EDUCATION OF THE PUBLIC IN THE USE OF THE WOODLANDS BY ENCOURAGING THEM TO PARTICIPATE IN THE MANAGEMENT OF THE WOODLANDS.
