THE SERVICE SHALL BE OFFERED WITH REGARDS TO THE USERS INDIVIDUAL NEEDS AND IN PURSUIT OF EQUAL OPPORTUNITIES.(II) THE MEANING OF 'DISABLED PERSONS' IS HERE TAKEN TO BE A PERSON WHO HAS A PHYSICAL, HAS A SENSORY OR LEARNING IMPAIRMENT EITHER TEMPORARY OR PERMANENTLY.

**Activities:** Hillingdon Shopmobility provides powered and manual wheelchairs and powered scooters to anyone with limited mobility, enabling them to access the leisure and shopping facilities in Uxbridge Town Centre with complete ease and independence. Available to young and old alike, whether their disability is temporary or permanent.
