Objects: 1. TO ADVANCE EDUCATION IN THE SKILLS, INDUSTRIES, TRADES, CRAFTS AND PROFESSIONS CONNECTED WITH AGRICULTURE BY THE PROVISION OF FINANCIAL ASSISTANCE OF STUDENTS CONNECTED WITH AGRICULTURE LIVING IN TODMORDEN AND BY RAISING THE PUBLIC AWARENESS IN ALL MATTERS RELATING TO AGRICULTURE

Activities: To hold an annual show, if possible, with classes for a wide variety of animals both farm and domestic, to encourage country crafts and skills. To award educational grants to young people to further their studies in connection with agriculture and related subjects, provided that they live in Todmorden or otherwise have a connection with the show.
