Objects: (1) TO RELIEVE PERSONS (IRRESPECTIVE OF AGE, COLOUR OR CREED) WHO ARE IN CONDITIONS OF NEED, HARDSHIP AND DISTRESS, IN PARTICULAR BUT NOT EXCLUSIVELY BY THE PROVISION OF TEMPORARY ACCOMMODATION, TRAINING AND SUPPORT WHICH INTEGRATES THEM INTO THE COMMUNITY.(2) TO ADVANCE THE EDUCATION OF SUCH PERSONS.(3) TO PROVIDE TRAINING AND EDUCATION, AND TO PROVIDE FACILITIES IN THE INTEREST OF SOCIAL WELFARE FOR RECREATION AND LEISURE-TIME OCCUPATION WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE SAID PERSONS, AND INTEGRATING THE SAID PERSONS INTO THE COMMUNITY.

Activities: To relieve people who are vulnerable and excluded, by working together to assess the need, identify the issues that need to be addressed and devise a way forward to change their lives for the better, in particular, but not exclusively by the provision of various services; including childcare, advice and guidance, training and facilities and equipment for recreation purposes.
