Objects: PROMOTE FOR THE BENEFIT OF PAKISTANI AND OTHER INHABITANTS ON CITY OF MANCHESTER (HEREINAFTER CALLED; THE AREA OF BENEFIT) AND THE NEIGHBOURHOOD WITHOUT DISTINCTION OF SEX, SEXUAL ORIENTATION, RACE, OR OF POLITICAL, RELIGIOUS OR OF OTHER OPINIONS, BY ASSOCIATING TOGETHER THE SAID INHABITANTS AND THE LOCAL AUTHORITIES, VOLUNTARY AND OTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND LEISURE-TIME OCCUPATION WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE SAID INHABITANTS; TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE THE SAME, (WHETHER ALONE OR IN CO-OPERATION WITH ANY LOCAL AUTHORITY OR OTHER PERSON OR BODY), IN FURTHERANCE OF THESE OBJECTS. (PROMOTE SUCH CHARITABLE PURPOSE AS MAY FROM TIME TO TIME BE DETERMINED.) A). FOR THE BENEFIT OF THE PUBLIC, AN IN PARTICULAR FOR THE BENEFIT OF THOSE MEMBERS OF THE PUBLIC WHO ARE OF PAKISTANI ORIGIN BY RELIEVING THOSE WHO ARE IN NEED BY REASON OF THEIR POVERTY, SICKNESS, AGE OR INFIRMITY BY ADVANCING EDUCATION AND PROVIDING AND ASSISTING IN THE PROVISION OF FACILITIES FOR RECREATION AND LEISURE TIME OCCUPATION IN THE INTEREST OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THOSE PERSONS, AND; B) FOR THE RELIEF OF POVERTY OF PAKISTANI REFUGEES WHO ARE RESIDENT OR WHO ARE INTENDING TO RESIDE IN THE UNITED KINGDOM BY PROVIDING SUCH PERSONS WITH FREE AND CONFIDENTIAL ADVICE, ASSISTANCE, REPRESENTATION, COUNSELLING, TRANSLATION AND INTERPRETING SERVICES IN MATTERS SUCH AS IMMIGRATION, FINANCE, DEBTS, WELFARE BENEFITS, HEALTH, HOUSING, SOCIAL SECURITY, EDUCATION, TRAINING AND EMPLOYMENT.
