Structure and governance

Rumic Foundation Trust is an unincorporated registered charity established by a declaration of trust dated 1st May 2003.

Objects of the charity

The objects are to promote financial assistance to disadvantaged, sick or disabled young persons in the Furness, South Lakeland and Copeland areas of Cumbria to improve their health, provide for medical assistance and to further their education and employment training.

Financial review and achievements in the year

During the year the charity received total income of £29986 (2023 - £10665), incurred expenses of £4469 (2023 - £11374) and made donations totalling £11360 (2023 - £3600). During the year they also purchased a new mini bus for £20860 (2023 - £Nil), this was funded by donations and the charity's reserves.

The deficit for the year £6703 (2023 – Deficit £4309) was deducted from funds brought forward of £114192 giving a total of £107489 to be carried forward. This is split between £99689 on unrestricted reserves and £7800 on restricted reserves.

All donations made are entirely at the discretion of the trustees, there is therefore no formal policy on reserves other than to pay donations out of income so that the original gift into the charity is not depleted.
