The Members of the Executive, which includes the Trustees of the charity have pleasure in presenting their report and financial statements for the year ended 30 SEPTEMBER 2020.

THE CHARITY

Black Minority Ethnic Television, Film and Media (BME TVFM) is a non profit voluntary organisation. It is registered with the Charity Commission under number 1099419. Charitable Status was obtained on 19th September 2003.

BMETVFM is a Foundation with strategic aims. It has launched a series of foundation and learning opportunities that had a clear path towards employment in the creative industries or elsewhere. We are here to support disadvantaged communities with fewer opportunities in the work place, with fewer learning opportunities and with fewer recreation and leisure opportunities.

REVIEW OF THE BUSINESS AND ACTIVITIES DURING THE YEAR

The pandemic and national emergency curtailed our plans to provide an Exhibition and Roadshow planned for June 2020 to August 2020 designed to attract more support, volunteers and to run projects in sport, broadcasting and personal development . We still continued with the volunteer maintenance and updating of Our Heritage TV, website, app and bmetv.net our internet television channel. Subject to the development and continued impact of the pandemic we do plan to overhaul the internet television channel and to consider working with volunteer members of the profession to offer advice and support on a career in the industry.

FINANCIAL REVIEW

Once again there were no financial activities to report on other than the usual support of i2i media in maintaining our internet television channel and completion of phase 2 of our heritage TV.

FUTURE

This remains a difficult and uncertain time for the charity. Not in terms of its financial stability or viability because we have always planned our activities linked to resources and funds raised. It is crucial because we have to remain relevant to the industry and the needs of our members. Because of our heritage website, mobile app and mobile website, we remain absolutely relevant and ensuring that the Black and Asian presence in broadcasting and other areas is recognised. This will continue to drive our focus moving forward.

There are no specific restrictions on the power of investment of the Executive Board.

INVESTMENT POLICY & PERFORMANCE

The Executive Board will prioritise the enhancement of our new Heritage App as we maintain our wish for it to evolve as a potential source of investment income within the next 3 years. This will be in line with our successful development of the first online Black & Asian Heritage Archive – www.ourheritage.tv

RESERVES POLICY

The Executive is committed to maintaining a level of reserves that is in accordance with its charitable objectives.

RISK ASSESSMENT

The Trustees continue to keep the Charity's activities under review and monitor performance, with particular regard to any major risks which may arise. The Trustees have assessed and categorised the risks which the Charity is, or may become, exposed to in order to ensure that there are satisfactory systems established to mitigate those risks.

A review of risks will be carried out by the Trustees on an annual basis in order to ensure that the process is constantly reviewed and updated.

NOTES TO THE FINANCIAL STATEMENTS
YEAR ENDED 30 SEPTEMBER 2020

1. ACCOUNTING POLICIES

a) Basis of preparation

The financial statements have been prepared under the historical cost convention, as modified by the revaluation of freehold properties and investments. The financial statements have been prepared in accordance with the Statement of Recommended Practice (SORP) issued in 2000, 'Accounting and Reporting by Charities' and applicable accounting standards.

b) Basis of consolidation

The financial statements incorporate the assets and liabilities of the Charity's subsidiaries as at 30 SEPTEMBER 2020 and their results for the year to 30 SEPTEMBER 2020.

c) Income

Income relating to the internet television project which includes forgone fees, is accounted for as received, unless it relates to future periods, in which case the appropriate portion is carried forward as deferred income. Other income is accounted for as received.

Income represents amounts receivable net of VAT where applicable.

d) Expenditure

Direct charitable expenditure comprises direct expenses incurred on the defined charitable purposes of the Charity and includes volunteer expenses directly attributable to the charitable activities.

Fundraising and publicity costs are those incurred in promoting the Charity and its activities both internally with the members and externally in the industry with the intention of attracting additional members and funding.

Support Costs comprises expenditure in support of the objects of the charity.

Management and administration costs include expenditure on compliance with constitutional and statutory requirements.

Expenses are included on an accruals basis.

Where costs cannot be assigned entirely to direct charitable expenses, fundraising and publicity, support costs or management and administration, they have been allocated between these categories on the basis of time spent on these three areas.

e) Restricted Funds

These are monies, which have legal restrictions on their use where donors have specified the funds can only be spent on certain of the charity's activities.

There were no staff costs to the Charity for 2019/20. All Management Costs relate to employing outside Project Specialists – Coaches, Trainers , Guest Speakers etc....

3. TAXATION

The Black and minority ethnic television, Film and Media is a registered charity and as such is entitled to the exemptions from tax afforded by section 505 ICTA 1988 and section 256 TCGA 1992 so far as its income and gains are applied for charitable purposes.

4. RESTRICTED FUNDS

The restricted funds relate to expenditure designated for specific projects. These were for Radio Broadcasting and Basketball. Also the investment made by i2i Technology was exclusively towards the development of the Internet Television Channel.

5. SHARE CAPITAL

The charity does not have any share capital.

6. TANGIBLE FIXED ASSETS

This relates to the website www.bmetv.net has depreciated owing to the acceleration of other streaming services such as Netflix and Amazon Prime. The Trustees plan to undertake an overhaul of the service in 2020/21 to modernise the offer and attractive of the site that still maintain a loyal if not smaller fan base.
