Considering the difficulties faced by independent bookshops, we were pleased to see an improvement in revenue. - We were able to provide Christian resources and material to the local church and members of the public and be a Christian presence in Newbury town centre.</p> <p>The coffee shop continued in a limited form throughout the year. Both the coffee shop and book shop provide an opportunity to give a Christian welcome to a variety of people and show hospitality to all those who enter into the shop. The bookshop gives help to those who are looking for spiritual help and guidance in the form of reading material and other items and encouraging others through Christian themed cards and gifts.</p> <p>As well as operating the bookshop itself, we were able to run bookstalls for a number of conferences and church events.</p>


