Objectives and activities

Summary of the purposes of the charity set out in its governing document

The charity's main objectives are

- 1) To promote the conservation, protection and improvement of the natural environment
- 2) To advance the education of the public in matters relating to the conservation of the environment and the creation of sustainable community woodlands and nature parks
- 3) To provide in the interests of social welfare and for the recreation or other leisure time occupation of persons resident in the area of operation who have need of such facilities by reason of their youth, age, infirmity or disablement, poverty or social and economic

Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts

We operate a charity shop, It's Donated in York which promotes the recycling of clothes and other items and which raises money which we currently spend on tree planting and work that improves the environment by supporting charities with donations both in this country and abroad.

As well as carrying out our own work the charity issues donations to other organisations to carry out environmental work both in this country and abroad. Projects are submitted to trustees for approval and are voted on at trustee meetings before funding is made available and going ahead.

The charity is wholly staffed by volunteers. No member of the charity receives any payment for the work which they carry out.

The trustees consider that they have complied with their duties to have due regard to the public benefit guidance published by the Charity Commission.

Achievements and performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.

This year has been challenging for the charity as our activities have been severely curtailed by the COVID 19 pandemic. The trustees have held regular meetings by zoom but the shop has only been open for short times in between the government lockdowns. Nevertheless, when the shop has been allowed to open we have accepted and sold items for recycling and have recently offered some surplus items for free to the local community during the last lockdown such as winter coats and also games and toys for children. The charity shop has been able to survive with the help of the substantial Covid Retail Grants which provided most of our income in this financial year.

Our volunteers have carried out tree planting and conservation activities at Kimberlow Hill in York in association with York University and the tree planting group Tremendous during the year. The aim of this project is five fold:-

- 1) To collect and reuse all tree protection materials (plastic and wood) that can be reused
- 2) To collect and responsibly dispose of the many hundreds of plastic guards that cannot be reused
- 3) To upgrade the natural habitats that exist on Kimberlow Hill by creating more habitable opportunities for the various forms of wildlife that live up there
- 4) To plant up areas with new saplings that have been designated by the University of York Estate Manager
- 5) To educate as much as possible ourselves, our volunteers and the general public into understanding what a precious resource and rich and diverse environment there is on Kimberlow Hill.

Financial review

Review of the charity's financial position at the end of the period

The Covid 19 pandemic has severely hit our shop operations and shop income in the financial year to 31 March 2021. The shop was only able to open for four months in the summer of 2020 and for a short period before Christmas. We were however entitled to the Government Covid 19 Retail Grants which have enabled the shop and charity to continue.

Shop income for the period was £7,098 (2019/20 £15,651) and income from ebay sales was £720 (2019/20 £2,599). The shop received Covid 19 Retail Grants of £19,431 (2019/20 £0) for the period it was forced to close which gave us a total income of £27,250 (2019/20 £18,250). This level of income means that for the first time the charity will need to have the Receipts and Payments accounts Independently Examined before submission to the Charity Commission as it has turnover in excess of £25,000.

Shop expenditure was £10,479 (2019/20 £12,308) which includes expenditure on rent, electricity, water, internet, card machine charges and insurance. No business rates were charged in the year due to the Government Rates relief. In addition we paid £980 to City of York Council for our share of the shop rewiring cost and £394 for the purchase and installation of a new shop door.

The charity made a £2,500 donation being the first part of an agreed donation of £5,000 to the Joliba Trust, a UK charity working in Mali who are working to restore livelihoods in Mali impacted by climate change. The first part of our donation was used for dune stabilisation.

Total expenditure including donations was therefore £14,354 (2019/20 £22,890).

Statement explaining the policy for holding reserves stating why they are held

The charity is to maintain reserves of £8,000 which is estimated to be sufficient monies to assess the viability of the shop operations and close down the shop if this proves necessary. Any surplus money following closure would be distributed in line with the charities' objectives.

Explanation of any uncertainties about the charity continuing as a going concern

The charity commenced the financial year with a cash balance of £8,520 and had a closing balance of £21,416 which was primarily due to the receipt of Covid 19 Retail Grants. This has enabled us to carry out a refit of the shop and improve its looks since the financial year end. We have also appointed a part time paid shop manager as advised by York CVS and to bring us into line with other charity shops in the area. It is not clear what the impact of the Groves low traffic neighbourhood trial will have on the shop takings in this financial year, if any, but we will monitor our income and expenditure closely to make sure that the shop and the charity remain viable.
