(A) THE ADVANCEMENT OF EDUCATION, (B) THE RELIEF OF PERSONS WHO ARE IN CONDITIONS OF POVERTY, SICKNESS, BY PROVIDING SUCH PERSONS WITH ADVICE, REPRESENTATION, TRANSLATION AND INTERPRETING SERVICES AND OTHER ASSISTANCE IN MATTERS SUCH AS IMMIGRATION, MONEY, DEBTS, WELFARE BENEFITS, HOUSING, HEALTH, EDUCATION, TRAINING AND EMPLOYMENT, IN ORDER THAT THEY MAY PARTICIPATE FULLY IN SOCIETY

**Activities:** To relieve poverty, hardship and distress among disadvantaged and socially excluded groups by providing information, advice, sign posting and referral representation, and to advance the education of said beneficiaries by any lawful charitable means. To provide and assist in the provision of facilities for education, recreation, leisure time occupation in the interest of social welfare
