As well as achieving our aims of providing facilities and equipment through fund-raising, these events enhance the development of staff, parent and pupil relationships. The Friends, where possible, also provide refreshments and assistance at school organised events. The Friends contribute to school Christmas and Year 6 leaving celebrations.
