**Activities:** TO RELIEVE THE SUFFERING AND DISTRESS OF ANIMALS THROUGHOUT THE WORLD - THE PROVISION OF MEDICAL AND FINANCIAL AID TO ANIMAL WELFARE ORGANISATIONS AND CHARITIES - THE PROVISION AND CO-ORDINATION OF VOLUNTEERS TO SUPPORT THE WORK OF ANIMAL WELFARE ORGANISATIONS OVERSEAS - THE PROVISION OF VETERINARY ADVICE AND SUPPORT - TO PROMOTE AND CONDUCT RESEARCH IN ALL MATTERS RELATING TO ANIMAL WELFARE.
