Report of the Trustees
for the year ended 31 March 2025

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The purpose of the charitable company is the selection, acquisition and documentation of the moving image culture and history of the East and West Midlands for public benefit and education.

Throughout 2024/25, MACE delivered its role as strategic lead organisation for screen heritage in the East and West Midlands regions. The main objective achieved in the year was the completion of a major collections review and the relocation of the collection to its new transitional home, ensuring that it is safeguarded and remains publicly accessible. Other key objectives achieved in the year include: upgrading the archive's CMS and the accessibility of our online platforms; working in partnership to deliver screen heritage activities to communities across the Midlands, and notably through our BFI-supported Save Our Screen Heritage project; and securing funding from the BFI's Screen Heritage Resilience programme and the National Lottery Heritage Fund to support the archive to build plans to achieve greater sustainability during the period 2023-2026.

Public benefit

In shaping our objectives for the year and planning our activities, the Trustees have considered the Charity Commissions guidance on public benefit, in particular, the Trustees consider how specific projects will contribute to their objectives.

The Archive contributes to the public benefit by creating, maintaining and making available a collection of moving image materials (film, tape and digital) to further understanding of the culture and heritage of the East and West Midlands. The collection is publicly available but is particularly used in educational contexts.

- Deliver strategic leadership for screen heritage across the Midlands' regions
- Sustain and develop a unique, significant and representative regional screen heritage collection
- Drive and enhance access to reach existing, new and diverse audiences
- Celebrate and promote diversity across our work and collections.

ACHIEVEMENTS AND PERFORMANCE

Charitable activities

Introduction

The year built on the significant work conducted in 2023/24 to review collections and develop plans to prepare the archive for a relocation in 2024, and a successful wholesale relocation of the collection to Gloucestershire Archives was achieved in the summer of 2024. During the year, MACE implemented the findings of the options appraisal work to develop long-term plans for the archive, including building new partnerships and setting out plans for front-end operational facilities for the transitional period until 2030 and identifying a site for future operations thereafter. Remarkable achievements were made by the staff team who, despite working remotely for part of the year, enabled the archive to continue to deliver its core remit and maintain access activity to the collections.

With the continued support of our partners, the archive successfully delivered its role as the strategic lead organisation for screen heritage in the Midlands. We are hugely thankful to the British Film Institute, the National Lottery Heritage Fund, The National Archives and all of our supporters, partners and donors for their highly valued support throughout the year. Looking ahead the archive continues to focus on building its sustainability as it moves through a period of transition and develops plans for its long-term future.

Collection matters

During 2024/25, monitoring of conditions in the storage vault showed that the facility continued to perform well prior to the collection relocation. The most significant piece of work was the successful wholesale relocation of the collection in the summer. From July to the end of year, the new storage vault was monitored during the bedding-in period and stable conditions have been achieved. Collecting activities ceased as the Save our Screen Heritage project completed and the relocation was underway.

Prior to the relocation, MACE's own programme of preservation across the year also resulted in 950+ items and c.100 hours of content digitised and digitally preserved. This work continued to benefit from the increased digital capacity and improved infrastructure implemented in the 2020/21 period as a result of support from NLHF.

The agreement with ITV for the arrangements relating to the collections of regional independent television held at MACE continues.

Accessibility

Virtual

There are now 69,664 titles included in the online catalogue, of which 9,350+ have an accompanying film extract and are available to view freely online. 500+ new catalogue entries were produced during the period. In addition, there are over 100 films or compilations from the collection available to view on MACE's Vimeo channel.

In terms of public engagement with MACE's collections online, engagement has remained steady.

In addition to 9,350+ film extracts available on MACE's website, the archive continues to supply 650+ free to view titles on the BFI's VoD BFI Player as well as 200+ titles to the new BFI Replay platform hosted by UK public libraries across the country.

Viewing and screening

MACE typically delivers screen heritage outreach, access and screening activities, collaborating with other heritage, film cultural and creative industries sector partners in the Midlands and beyond. The mix of in-venue and online activity continued throughout 2024/25, and MACE supported in the region of 100 activities across both Midlands regions by the end of year.

Education

The archive continued to support student and research engagement through its partnership with the Midlands4Cities Doctoral Training Partnership, hosting a Phd student placement in support of the archive's BFI-funded Save our Screen Heritage project. The latter project also provided opportunities for wider volunteering with communities in and around Leicester through a range of screen heritage activities. Additionally, at its host university, the archive supported a programme of volunteering for students.

The archive contributes to educational activities aimed at the wider film, cultural and heritage sectors. In 2024/25, the Archive Manager delivered the Training Coordinator role for Film Archives UK, the network for public film archives in UK. Additionally, MACE supports educational opportunities through volunteering and for people across the region and UK.

FINANCIAL REVIEW

Financial position

Part of MACE's annual income is derived from grant funding and a baseline level of funding awarded by the British Film Institute, which is subject to annual review, has been awarded for the period 2023- 2026. The BFI is MACE's primary funder and lead body for film. As previously reported, the BFI, from whom MACE has received regular grant funding as one of their partnership bodies, was cut in the spending review of November 2015. As a result, BFI discontinued the distribution of grant-in-aid to its partnership organisations, transferring a standstill sum into a Lottery Regional Archives Investment Fund award for which MACE made a successful bid. During 2016/17, the BFI announced a continuation of this fund alongside the launch of its five-year 2022 Strategy covering the period 2017-2022. MACE was awarded funding in 2017/18 for the period 2017-2020. During 2019/20, BFI introduced changes with respect to the financial support it provides to regional public film archives in England, and it discontinued the RAIF award in March 2020. For the period 2020-2023, MACE was awarded funding from the BFI's competitive Audience Fund programme. To cover the period from 2023-2026, MACE has been awarded funding through BFI's new Screen Heritage Resilience programme. MACE is making a further bid to the BFI's Screen Heritage Resilience programme for the period 2026-2029.

Other grant income is less predictable and annual income fluctuates according to the varying availability of traditional sources of project-based funding and the levels of funding grants awarded. During 2023-2025, MACE secured additional funding from the BFI's annual Screen Heritage Project fund. A further bid will be made during the period 2026-2029.

From April 2024, MACE received support from BFI through its Resilience fund (as above) focused on building the sustainability of the archive including undertaking an options appraisal to explore future partnerships and the relocation of the archive in 2024/25. MACE also secured additional funding from the National Lottery Heritage Fund to support the archive through this transitional period until March 2026. A major bid to the Heritage Fund to support the long-term future of the archive to be submitted in 2026 is underway.

Income generation continues to assume a significant role in the strategy for the long-term sustainability of the archive. At the year end, income generation totalled £321,785 (2024: £447,978). A balanced budget has been prepared for 2024/25.

Reserves policy

It is the policy of MACE to maintain unrestricted funds, which are the unrestricted general reserves of the Charity. The reserves will be reviewed annually. The charity will endeavour to maintain reserves at a level that would enable it to fulfil contractual and statutory obligations, carry out its mission to safeguard collections, mitigate shortfalls in income and meet unforeseen costs. The level of free reserves as at 31 March 2025 amount to £337,293 (2024: £280,471) which is considered adequate to cover the above requirements.

FINANCIAL REVIEW

Going concern

At a minimum, the Board of Trustees review the financial position of the company quarterly and on an annual basis. MACE has secured funding from the NLHF and BFI to support its relocation and operations and to build its sustainability during a transitional period until March 2026. Part of MACE's annual income is derived from grant funding awarded by the British Film Institute. The nature of this funding stream changed in 2023 as BFI introduced its new 10-year strategy. MACE secured an increased level of funding for the period 2023-2026. It additionally secured project funding from BFI and resilience funding from NLHF in 2023. MACE also continues to generate income from sales and licensing. While the latter does fluctuate, regular financial checks mean that levels of expenditure would be reduced to enable MACE to continue to operate were the level of income to fall significantly. MACE is not aware of any material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern.

FUTURE PLANS

Our priorities for 2025/26 are:

- To implement the relocation of the archive based on the outcomes of an options appraisal to explore new partnerships and to build business plans to safeguard collections and continue to deliver a regional public film archive service for the Midlands.
- To build the sustainability of MACE, securing resilience funding from BFI and a major grant from Heritage Lottery, and identifying new income streams to support transition plans and the future development of the archive.
- To develop and build on key partnerships that enable MACE to fulfil its access and engagement aims and develop opportunities for collaboration.
- To deliver a regional programme of work aimed at diversifying MACE's collections, reaching underrepresented groups and developing digital preservation practice.
- .To continue to develop a regionally representative collection, our practice and infrastructure in relation to digital preservation and access and to seek opportunities that will support further review and development in this area.
- To work closely with film, cultural and heritage sector partners to facilitate screen heritage outreach, access and screening activities, and to increase our reach with new and diverse audiences particularly across the Midlands.
- To continue to develop a successful working relationship with BFI, the BFI Film Audience Network (regional Film Hubs) and other BFI partners, such as IntoFilm, and to contribute to the concluding stages of delivery of its Heritage 22 programme and new 2033 Strategy where appropriate.
- To explore collaborative opportunities with colleagues across the film, cultural and heritage sectors, particularly in the areas of digital preservation and access, to contribute to the sustainability of MACE and the film archive sector more broadly.
- To contribute to regional archive networks nationally and across the East and West Midlands regions, including the Film Archives UK, Archives Connected East Midlands and Archives West Midlands networks.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

MACE (Media Archive of Central England LTD) is a charity and a not-for-profit company limited by guarantee, incorporated on 13 March 1996 and registered as a charitable trust on 26 November 2003. The company was established under a Memorandum of Association that established the objects and powers of the charitable company and is governed under its Articles of Association as amended by Special Resolutions dated 8 January 2002. In the event of the company being wound up, members are required to contribute an amount not exceeding £10 per member.

Recruitment and appointment of new trustees

As set out in the Articles of Association no person can be appointed a Trustee unless he has attained the age of 18 or in circumstances such that he has already been a Trustee, he would have been disqualified from acting under the provisions of Article 38. The Trustees may appoint a person who will act to be Trustee either to fill a vacancy or as an additional Trustee. The number of Trustees at any one time must not be less than 2 but is not subject to any maximum.

Nominations for Trustees are put forward by existing Trustees. Nominees may be invited to attend a meeting of the Board of Trustees. Appointment is by a majority vote.

Organisational structure

The Board meets at least 4 times per year and a Chair is appointed by the Trustees. To facilitate effective operations the Chair has delegated authority within terms of delegation approved by the Trustees, for operational matters including finance, employment and related activity to the Archive Manager (AM).

The Charity is organised so that the Trustees meet regularly to oversee its affairs. The AM manages the day-to-day administration of the Archive and its staff.

Induction and training of new trustees

All the new Trustees are invited to an induction meeting with the AM and the Chair who is also the Company Secretary. They will ensure new Trustees are fully aware of their legal obligations under Charity and Company Law.

The Chair and AM will also brief the new Trustees on the content of the Memorandum and Articles of Association, the Business Plan and financial performance. As part of the induction all new Trustees will be given the opportunity to meet all staff and fellow Trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Income:

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Grants:

Income from grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Donated services and facilities:

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

Volunteers:

We benefit from time given by a number of volunteers across the different services that we offer. In accordance with the Charities SORP (FRS 102) as we are able to value the use of volunteers the time offered by volunteers is recognised within the financial statements.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 25% on cost and 10% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the Financial Statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Financial instruments

Only basic financial instruments as defined in FRS 102 are held. Financial assets and financial liabilities are recognised in the accounts only when the entity becomes party to the contractual provisions of the instrument and their measurement basis is as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at transaction price.

Financial liabilities - trade creditors, accruals and other creditors are basic financial instruments, and are measured at amortised cost. Where a financial liability constitutes a financing transaction it is initially and subsequently measured at the present value of future payments, discounted at a market rate of interest.

Value Added Tax

The Charity is VAT registered. All figures shown are exclusive of VAT.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The purpose of the charitable company is the selection, acquisition and documentation of the moving image culture and history of the East and West Midlands for public benefit and education.

Throughout 2023/24, MACE delivered its role as strategic lead organisation for screen heritage in the East and West Midlands regions. Key objectives achieved in the year include: developing learning materials to support engagement with thousands of items digitised from at-risk videotapes to be made publicly available at libraries across the UK as a result of the British Film Institute-led 'Heritage 22' screen heritage partnership project; working in partnership to deliver screen heritage activities to communities across the Midlands, and notably through our BFI-supported Save Our Screen Heritage project; and securing funding from the BFI's Screen Heritage Resilience programme and the National Lottery Heritage Fund to support the archive to build plans to achieve greater sustainability during the period 2023-2026.

Public benefit

In shaping our objectives for the year and planning our activities, the Trustees have considered the Charity Commissions guidance on public benefit, in particular, the Trustees consider how specific projects will contribute to their objectives.

The Archive contributes to the public benefit by creating, maintaining and making available a collection of moving image materials (film, tape and digital) to further understanding of the culture and heritage of the East and West Midlands. The collection is publicly available but is particularly used in educational contexts.

Strategic Aims

- Deliver strategic leadership for screen heritage across the Midlands' regions
- Sustain and develop a unique, significant and representative regional screen heritage collection
- Drive and enhance access to reach existing, new and diverse audiences
- Celebrate and promote diversity across our work and collections.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

Introduction

The year saw significant work conducted on reviewing collections and developing plans to prepare the archive for a relocation in 2024. Alongside this crucial work, the archive continued to perform strongly throughout the period, reaching all targets for collecting, preservation and access activity. The higher level of audience engagement online achieved during the pandemic was maintained and the archive supported dozens of audience-facing activities across the Midlands' regions.

With the continued support of our partners, the archive successfully delivered its role as the strategic lead organisation for screen heritage in the Midlands. We are hugely thankful to the British Film Institute, the National Lottery Heritage Fund, The National Archives and all of our supporters, partners and donors for their highly valued support throughout the year. Looking ahead the archive continues to focus on building its sustainability as it moves into a period of transition and undertakes a relocation in 2024.

Collection matters

During 2023/24, monitoring of conditions in the storage vault showed that the facility continued to perform well. Collecting activities focused on targeted acquisitions amounting to some 700+ items collected and the core collection occupying approximately 85% of the available space.

A key focus for the year was the undertaking of a major collections review conducted in preparation for the archive's relocation in 2024. Also, the completion of the digitisation of thousands of at-risk videotapes, a selection of which were included in the publicly accessible BFI Replay platform in libraries across the UK as part of the BFI's Heritage 22 project. MACE's own programme of preservation across the year also resulted in 1100+ items and c.150 hours of content digitised and digitally preserved. This work continued to benefit from the increased digital capacity and improved infrastructure implemented in the 2020/21 period as a result of support from NLHF.

The agreement with ITV for the arrangements relating to the collections of regional independent television held at MACE continues.

Accessibility

Virtual

There are now 69,117 titles included in the online catalogue, of which 8,800+ have an accompanying film extract and are available to view freely online. 400+ new catalogue entries were produced during the period. In addition, there are over 100 films or compilations from the collection available to view on MACE's Vimeo channel.

In terms of public engagement with MACE's collections online, engagement has remained steady at higher than pre-pandemic levels.

In addition to 8,800+ film extracts available on MACE's website, the archive continues to supply 650+ free to view titles on the BFI's VoD BFI Player as well as 200+ titles to the new BFI Replay platform hosted by UK public libraries across the country.

Viewing and screening

MACE typically delivers screen heritage outreach, access and screening activities, collaborating with other heritage, film cultural and creative industries sector partners in the Midlands and beyond. The mix of in-venue and online activity continued throughout 2023/24, and MACE supported in the region of 100 activities across both Midlands regions by the end of year.

Education

The archive continued to support student and research engagement at its host university during the year, with the Director convening archive internship modules and supporting other teaching with the collections.

The archive contributes to educational activities aimed at the wider film, cultural and heritage sectors. In 2023/24, the Director acted as Chair of Film Archives UK, the network for public film archives in UK. Additionally, MACE supports educational opportunities through volunteering and for people across the region and UK. MACE is a partner of the Midlands4Cities AHRC consortium, through which a PhD candidate from Nottingham Trent University was supported to undertake a placement.

FINANCIAL REVIEW

Financial position

Part of MACE's annual income is derived from grant funding and a baseline level of funding awarded by the British Film Institute, which is subject to annual review, has been awarded for the period 2023- 2026. The BFI is MACE's primary funder and lead body for film. As previously reported, the BFI, from whom MACE has received regular grant funding as one of their partnership bodies, was cut in the spending review of November 2015. As a result, BFI discontinued the distribution of grant-in-aid to its partnership organisations, transferring a standstill sum into a Lottery Regional Archives Investment Fund award for which MACE made a successful bid. During 2016/17, the BFI announced a continuation of this fund alongside the launch of its five-year 2022 Strategy covering the period 2017-2022. MACE was awarded funding in 2017/18 for the period 2017-2020. During 2019/20, BFI introduced changes with respect to the financial support it provides to regional public film archives in England, and it discontinued the RAIF award in March 2020. For the period 2020-2023, MACE was awarded funding from the BFI's competitive Audience Fund programme. To cover the period from 2023-2026, MACE has been awarded funding through BFI's new Screen Heritage Resilience programme.

Other grant income is less predictable and annual income fluctuates according to the varying availability of traditional sources of project-based funding and the levels of funding grants awarded. During 2023-2026, MACE plans to apply for funding from the BFI's annual Screen Heritage Project fund. This additional funding for 2023-2025 has already been secured.

MACE continued to receive significant support from the University of Lincoln with donations received again during the current year, an arrangement that ceased in April 2024. As a result, MACE received support from BFI through its Resilience fund (as above) focused on building the sustainability of the archive including undertaking an options appraisal to explore future partnerships and the relocation of the archive in 2024. MACE has also secured additional funding from the National Lottery Heritage Fund to support the archive through this transitional period until March 2025.

Income generation continues to assume a significant role in the strategy for the long-term sustainability of the archive. At the year end, income generation totalled £447,978 (2023: £455,411). A balanced budget has been prepared for 2023/24.

FINANCIAL REVIEW

Reserves policy

It is the policy of MACE to maintain unrestricted funds, which are the unrestricted general reserves of the Charity. The reserves will be reviewed annually. The charity will endeavour to maintain reserves at a level that would enable it to fulfil contractual and statutory obligations, carry out its mission to safeguard collections, mitigate shortfalls in income and meet unforeseen costs. The level of free reserves as at 31 March 2024 amount to £337,293 (2023: £280,471) which is considered adequate to cover the above requirements.

Going concern

At a minimum, the Board of Trustees review the financial position of the company quarterly and on an annual basis. MACE has secured funding from the NLHF and BFI to support its relocation and operations and to build its sustainability during a transitional period until March 2025 and 2026 respectively. Part of MACE's annual income is derived from grant funding awarded by the British Film Institute. The nature of this funding stream changed in 2023 as BFI introduced its new 10-year strategy. MACE secured an increased level of funding for the period 2023-2026. It additionally secured project funding from BFI and resilience funding from NLHF in 2023. MACE also continues to generate income from sales and licensing. While the latter does fluctuate, regular financial checks mean that levels of expenditure would be reduced to enable MACE to continue to operate were the level of income to fall significantly. MACE is not aware of any material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern.

FUTURE PLANS

Our priorities for 2024/25 are:

- To implement the relocation of the archive based on the outcomes of an options appraisal to explore new partnerships and to build business plans to safeguard collections and continue to deliver a regional public film archive service for the Midlands.
- To build the sustainability of MACE, securing resilience funding and identifying new income streams to support transition plans and the future development of the archive.
- To develop and build on key partnerships that enable MACE to fulfil its access and engagement aims and develop opportunities for collaboration.
- To deliver a regional programme of work aimed at diversifying MACE's collections, reaching underrepresented groups and developing digital preservation practice.
- .To continue to develop a regionally representative collection, our practice and infrastructure in relation to digital preservation and access and to seek opportunities that will support further review and development in this area.
- To work closely with film, cultural and heritage sector partners to facilitate screen heritage outreach, access and screening activities, and to increase our reach with new and diverse audiences particularly across the Midlands.
- To continue to develop a successful working relationship with BFI, the BFI Film Audience Network (regional Film Hubs) and other BFI partners, such as IntoFilm, and to contribute to the concluding stages of delivery of its Heritage 22 programme and new 2033 Strategy where appropriate.
- To explore collaborative opportunities with colleagues across the film, cultural and heritage sectors, particularly in the areas of digital preservation and access, to contribute to the sustainability of MACE and the film archive sector more broadly.
- To contribute to regional archive networks nationally and across the East and West Midlands regions, including the Film Archives UK, Archives Connected East Midlands and Archives West Midlands networks.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

MACE (Media Archive of Central England LTD) is a charity and a not-for-profit company limited by guarantee, incorporated on 13 March 1996 and registered as a charitable trust on 26 November 2003. The company was established under a Memorandum of Association that established the objects and powers of the charitable company and is governed under its Articles of Association as amended by Special Resolutions dated 8 January 2002. In the event of the company being wound up, members are required to contribute an amount not exceeding £10 per member.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Recruitment and appointment of new trustees

As set out in the Articles of Association no person can be appointed a Trustee unless he has attained the age of 18 or in circumstances such that he has already been a Trustee, he would have been disqualified from acting under the provisions of Article 38. The Trustees may appoint a person who will act to be Trustee either to fill a vacancy or as an additional Trustee. The number of Trustees at any one time must not be less than 2 but is not subject to any maximum.

Nominations for Trustees are put forward by existing Trustees. Nominees may be invited to attend a meeting of the Board of Trustees. Appointment is by a majority vote.

Organisational structure

The Board meets at least 4 times per year and a Chair is appointed by the Trustees. To facilitate effective operations the Chair has delegated authority within terms of delegation approved by the Trustees, for operational matters including finance, employment and related activity to the Archive Manager (AM).

The Charity is organised so that the Trustees meet regularly to oversee its affairs. The AM manages the day-to-day administration of the Archive and its staff.

Induction and training of new trustees

All the new Trustees are invited to an induction meeting with the AM and the Chair who is also the Company Secretary. They will ensure new Trustees are fully aware of their legal obligations under Charity and Company Law.

The Chair and AM will also brief the new Trustees on the content of the Memorandum and Articles of Association, the Business Plan and financial performance. As part of the induction all new Trustees will be given the opportunity to meet all staff and fellow Trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Income:

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Grants:

Income from grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Donated services and facilities:

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

Volunteers:

We benefit from time given by a number of volunteers across the different services that we offer. In accordance with the Charities SORP (FRS 102) as we are able to value the use of volunteers the time offered by volunteers is recognised within the financial statements.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the Financial Statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Financial instruments

Only basic financial instruments as defined in FRS 102 are held. Financial assets and financial liabilities are recognised in the accounts only when the entity becomes party to the contractual provisions of the instrument and their measurement basis is as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at transaction price.

Financial liabilities - trade creditors, accruals and other creditors are basic financial instruments, and are measured at amortised cost. Where a financial liability constitutes a financing transaction it is initially and subsequently measured at the present value of future payments, discounted at a market rate of interest.

The Charity is VAT registered. All figures shown are exclusive of VAT.

Report of the Trustees

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The purpose of the charitable company is the selection, acquisition and documentation of the moving image culture and history of the East and West Midlands for public benefit and education.

Throughout 2022/23, MACE delivered its role as strategic lead organisation for screen heritage in the East and West Midlands regions. Key objectives achieved in the year include: selecting and preparing hundreds of items digitised from at-risk videotapes to be made publicly available at libraries across the UK as a result of the British Film Institute-led 'Heritage 22' screen heritage partnership project; working in partnership to deliver screen heritage activities to communities across the Midlands, notably through a number of regionally-based events of national significance including the Birmingham Commonwealth Games, the Unboxed festival, the Queen's Jubilee and Coventry City of Culture year; and securing funding from the BFI's new Screen Heritage Resilience programme to support the archive to build plans to achieve greater sustainability during the period 2023-2026.

Public benefit

In shaping our objectives for the year and planning our activities, the Trustees have considered the Charity Commissions guidance on public benefit, in particular, the Trustees consider how specific projects will contribute to their objectives.

The Archive contributes to the public benefit by creating, maintaining and making available a collection of moving image materials (film, tape and digital) to further understanding of the culture and heritage of the East and West Midlands. The collection is publicly available but is particularly used in educational contexts.

Strategic Aims

- Deliver strategic leadership for screen heritage across the Midlands' regions. Sustain and develop a unique, significant and representative regional screen heritage collection.
- Drive and enhance access to reach existing, new and diverse audiences.
- Celebrate and promote diversity across our work and collections.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

Introduction

The archive performed strongly during 2022/23, exceeding its targets for collecting, preservation and access activity. The upward trend in audience engagement online was maintained and the archive supported more than 100 audience-facing activities across the Midlands' regions. Activities included collaborations with partners celebrating major national events taking place in our region and a range of community and educational projects throughout the East and West Midlands.

With the continued support of our partners, the archive successfully delivered its role as the strategic lead organisation for screen heritage in the Midlands. We are hugely thankful to the university, to the British Film Institute and to our funders, partners and donors for their highly valued support throughout the year. Looking ahead the archive is focused on building its sustainability as it moves into a period of transition when its agreement with the University of Lincoln ceases in 2024. Accordingly, MACE secured funding from the BFI in the final quarter of 2022/23 to undertake resilience activities including a programme of fundraising, a major collections review and options appraisal to safeguard collections.

Collection matters

During 2022/23, monitoring of conditions in the storage vault showed that the facility continued to perform well. Collecting activities remained strong with 2522 items collected and the core collection occupying approximately 85% of the available space.

A major focus during the year was the selection and preparation of items digitally preserved from at-risk videotapes for inclusion on the publicly accessible BFI Replay platform in libraries across the UK as part of the BFI's Heritage 22 project. By 2023, some 600+ items from MACE will be included in the initiative. MACE's own programme of preservation across the year also resulted in 1500 items and 178 hours of content digitised and digitally preserved. This work continued to benefit from the increased digital capacity and improved infrastructure implemented in the 2020/21 period as a result of support from NLHF.

The agreement with ITV for the arrangements relating to the collections of regional independent television held at MACE continues.

Accessibility

Virtual

There are now 68,705 titles included in the online catalogue, of which 8,250+ have an accompanying film extract and are available to view freely online. 955 new catalogue entries were produced during the period. In addition, there are over 100 films or compilations from the collection available to view on MACE's Vimeo channel.

In terms of public engagement with MACE's collections online, there was a continued upward trend: engagement via the website grew by approx. 5% and was approximately 30% higher than pre-pandemic levels.

In addition to 8,250+ film extracts available on MACE's website, the archive continues to supply 650+ free to view titles on the BFI's VoD BFI Player and it also added 200+ titles to the new BFI Replay platform hosted by UK public libraries across the country.

Viewing and screening

MACE typically delivers screen heritage outreach, access and screening activities, collaborating with other heritage, film cultural and creative industries sector partners in the Midlands and beyond. The mix of in-venue and online activity continued throughout 2022/23 and MACE supported over 100 activities across both Midlands regions by the end of year.

Education

The archive continued to support student and research engagement at its host university during the year, with the Director convening archive internship modules and supporting other teaching with the collections.

The archive contributes to educational activities aimed at the wider film, cultural and heritage sectors. In 2022/23, the Director acted as Chair of Film Archives UK, the network for public film archives in UK. MACE collaborated with IntoFilm to support film-based workshops for school children related to the Birmingham Commonwealth Games. Additionally, MACE supports educational opportunities through volunteering and for people across the region and UK. MACE is a partner of the Midlands4Cities AHRC consortium and, separately, co-supervised a Collaborative Doctoral Award candidate with University of Warwick.

FINANCIAL REVIEW

Financial position

Part of MACE's annual income is derived from grant funding and a baseline level of funding awarded by the British Film Institute, which is subject to annual review, has been awarded for the period 2023-2026. The BFI is MACE's primary funder and lead body for film. As previously reported, the BFI, from whom MACE has received regular grant funding as one of their partnership bodies, was cut in the spending review of November 2015. As a result, BFI discontinued the distribution of grant-in-aid to its partnership organisations, transferring a standstill sum into a Lottery Regional Archives Investment Fund award for which MACE made a successful bid. During 2016/17, the BFI announced a continuation of this fund alongside the launch of its five-year 2022 Strategy covering the period 2017-2022. MACE was awarded funding in 2017/18 for the period 2017-2020. During 2019/20, BFI introduced changes with respect to the financial support it provides to regional public film archives in England and it discontinued the RAIF award in March 2020. For the period 2020-2023, MACE was awarded funding from the BFI's competitive Audience Fund programme. To cover the period from 2023-2026, MACE has been awarded funding through BFI's new Screen Heritage Resilience programme.

Other grant income is less predictable and annual income fluctuates according to the varying availability of traditional sources of project-based funding and the levels of funding grants awarded. During 2023-2026, MACE plans to apply for funding from the BFI's new Screen Heritage Project fund on an annual basis. This additional funding for 2023-2024 has already been secured.

MACE continued to receive significant support from the University of Lincoln with donations received again during the current year. However, the agreement with the University of Lincoln will cease in 2024. As a result, MACE received support from BFI through its Resilience fund (as above) focused on building the sustainability of the archive including undertaking an options appraisal to explore future partnerships and the relocation of the archive in 2024. MACE has also secured additional funding from the National Lottery Heritage Fund to support the archive through this transitional period until March 2025.

Income generation continues to assume a significant role in the strategy for the long-term sustainability of the archive. At the year end, income generation totalled £455,411 (2022: £408,060). A balanced budget has been prepared for 2023/24.

FINANCIAL REVIEW

Reserves policy

It is the policy of MACE to maintain unrestricted funds, which are the unrestricted general reserves of the Charity. The reserves will be reviewed annually. The charity will endeavour to maintain reserves at a level that would enable it to fulfil contractual and statutory obligations, carry out its mission to safeguard collections, mitigate shortfalls in income and meet unforeseen costs. The level of free reserves as at 31 March 2023 amount to £280,471 (2022: £190,004) which is considered adequate to cover the above requirements.

Going concern

At a minimum, the Board of Trustees review the financial position of the company quarterly and on an annual basis. As above, MACE's agreement with the University of Lincoln will cease in 2024. As a result, MACE has secured funding from the NLHF and BFI to support its relocation and operations and to build its sustainability during a transitional period until March 2025 and 2026 respectively. Part of MACE's annual income is derived from grant funding awarded by the British Film Institute. The nature of this funding stream changed in 2023 as BFI introduced its new 10-year strategy. MACE secured an increased level of funding for the period 2023-2026. It additionally secured project funding from BFI and resilience funding from NLHF in 2023. MACE also continues to generate income from sales and licensing. While the latter does fluctuate, regular financial checks mean that levels of expenditure would be reduced to enable MACE to continue to operate were the level of income to fall significantly. MACE is not aware of any material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern.

FUTURE PLANS

Our priorities for 2023/24 are:

- To plan for the future relocation of the archive, undertaking an options appraisal to explore new partnerships and to build business plans to safeguard collections and continue to deliver a regional public film archive service for the Midlands.
- To build the sustainability of MACE, securing resilience funding and identifying new income streams to support transition plans and the future development of the archive.
- To continue delivering on our partnership with the University of Lincoln, including delivery of accredited work placements and internships, student and academic engagement with the archive and opportunities for collaboration.
- To participate in the final year of activity of the BFI-lead national screen heritage partnership project, Heritage 2022, focused on videotape preservation and to select significant material for inclusion on the BFI Replay platform hosted by UK public libraries.
- To continue to develop a regionally representative collection, our practice and infrastructure in relation to digital preservation and access and to seek opportunities that will support further review and development in this area.
- To work closely with film, cultural and heritage sector partners to facilitate screen heritage outreach, access and screening activities, and to increase our reach with new and diverse audiences particularly across the Midlands.
- To continue to develop a successful working relationship with BFI, the BFI Film Audience Network (regional Film Hubs) and other BFI partners, such as IntoFilm, and to contribute to the concluding stages of delivery of its 2022 Strategy and Heritage 22 programme where appropriate.
- To explore collaborative opportunities with colleagues across the film, cultural and heritage sectors, particularly in the areas of digital preservation and access, to contribute to the sustainability of MACE and the film archive sector more broadly.
- To contribute to regional archive networks nationally and across the East and West Midlands regions, including the Film Archives UK, Archives Connected East Midlands and Archives West Midlands networks.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a memorandum and articles of association, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

MACE (Media Archive of Central England LTD) is a charity and a not-for-profit company limited by guarantee, incorporated on 13 March 1996 and registered as a charitable trust on 26 November 2003. The company was established under a Memorandum of Association that established the objects and powers of the charitable company and is governed under its Articles of Association as amended by Special Resolutions dated 8 January 2002. In the event of the company being wound up, members are required to contribute an amount not exceeding £10 per member.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Recruitment and appointment of new trustees

As set out in the Articles of Association no person can be appointed a Trustee unless he has attained the age of 18 or in circumstances such that he has already been a Trustee, he would have been disqualified from acting under the provisions of Article 38. The Trustees may appoint a person who will act to be Trustee either to fill a vacancy or as an additional Trustee. The number of Trustees at any one time must not be less than 2 but is not subject to any maximum.

Nominations for Trustees are put forward by existing Trustees. Nominees may be invited to attend a meeting of the Board of Trustees. Appointment is by a majority vote.

Organisational structure

The Board meets at least 4 times per year and a Chair is appointed by the Trustees. To facilitate effective operations the Chair has delegated authority within terms of delegation approved by the Trustees, for operational matters including finance, employment and related activity to the Chief Executive Officer (CEO).

The Charity is organised so that the Trustees meet regularly to oversee its affairs. The CEO manages the day-to-day administration of the Archive and its staff.

Induction and training of new trustees

All the new Trustees are invited to an induction meeting with the CEO and the Chair who is also the Company Secretary. They will ensure new Trustees are fully aware of their legal obligations under Charity and Company Law.

The Chair and CEO will also brief the new Trustees on the content of the Memorandum and Articles of Association, the Business Plan and financial performance. As part of the induction all new Trustees will be given the opportunity to meet all staff and fellow Trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Income:

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Grants:

Income from grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Donated services and facilities:

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

Volunteers:

We benefit from time given by a number of volunteers across the different services that we offer. In accordance with the Charities SORP (FRS 102) as we are able to value the use of volunteers the time offered by volunteers is recognised within the financial statements.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Tangible fixed assets

Computer equipment - 25% on cost and 10% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the Financial Statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Financial instruments

Only basic financial instruments as defined in FRS 102 are held. Financial assets and financial liabilities are recognised in the accounts only when the entity becomes party to the contractual provisions of the instrument and their measurement basis is as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at transaction price.

Financial liabilities - trade creditors, accruals and other creditors are basic financial instruments, and are measured at amortised cost. Where a financial liability constitutes a financing transaction it is initially and subsequently measured at the present value of future payments, discounted at a market rate of interest.

Value Added Tax

The Charity is VAT registered. All figures shown are exclusive of VAT.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The purpose of the charitable company is the selection, acquisition and documentation of the moving image culture and history of the East and West Midlands for public benefit and education.

Following a challenging year with the onset of the pandemic, the archive entered a period of readjustment and recovery in 2021/22. Throughout, and with grateful support to the British Film Institute, MACE delivered its role as strategic lead organisation for screen heritage in the East and West Midlands regions. Key objectives achieved in the year included: securing the preservation of thousands of at-risk videotapes through participation in the British Film Institute-led 'Heritage 22' screen heritage partnership project; continued delivery of activities related to the Coventry City of Culture year, notably curating materials for screenings, workshops and exhibitions in the city and collaboration with partners to support long-term preservation of and access to audiovisual collections; and delivery of a strategic review of public access film archives working with the professional network for film archives in the UK that reached out to 100+ individuals and organisations.

Public benefit

In shaping our objectives for the year and planning our activities, the Trustees have considered the Charity Commissions guidance on public benefit, in particular, the Trustees consider how specific projects will contribute to their objectives.

The Archive contributes to the public benefit by creating, maintaining and making available a collection of moving image materials (film, tape and digital) to further understanding of the culture and heritage of the East and West Midlands. The collection is publicly available but is particularly used in educational contexts.

Strategic Aims

- Deliver strategic leadership for screen heritage across the Midlands' regions.
- Sustain and develop a unique, significant and representative regional screen heritage collection.
- Drive and enhance access to reach existing, new and diverse audiences.
- Celebrate and promote diversity across our work and collections.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

Introduction

2021/22 was a year of readjustment and recovery for the archive following our period of closure the previous year. The ongoing pandemic continued to impact the archive but we were able to adapt ways of working to meet the challenges. Hybrid working became standard across the team and screening activities embraced the virtual sphere while a more limited number of in-venue events took place.

The year's challenges were ably met by our archive team under the strong leadership of our Director who has continued in very difficult circumstances to sustain the organisation and its staff. We are also hugely thankful to the university, to the British Film Institute and to our funders, partners and donors for their highly valued and continued support.

Collection matters

With the introduction of hybrid working, it was essential to maintain systems for remote monitoring of the conditions in the storage vault. During 2021/22, the Lincoln storage facility continued to perform well. Collecting activities picked up with 3,014 items collected. The core collection continues to occupy approximately 80% of the available space.

Continued access to our facilities throughout the year meant we were able to provide a programme of preservation across 2021/22 with over 1,000 items and 156 hours of content was digitised and digitally preserved. This was aided further by the increased digital capacity and improved infrastructure implemented the previous year through support from NLHF. During the year, 3,000+ items were also digitally preserved through the BFI's national Heritage 22 partnership project.

The agreement with ITV for the arrangements relating to the collections of regional independent television held at MACE continues.

Accessibility

Virtual

There was a gradual return to pre-pandemic levels in terms of cataloguing activity with 1,791 new catalogue entries produced. 67,770 titles are now included in the online catalogue and 7,700+ of these entries have an accompanying film extract and are available to view freely online. In addition, there are over 100 films or compilations from the collection available to view on MACE's Vimeo channel.

The comparatively sharp increase in the archive's reach with audiences online during 2020/21, which was understood to have resulted from a shift in user behaviour as a consequence of the Covid-19 pandemic, was not repeated this year. Nonetheless, the general upward trend continued regarding growth in public engagement with MACE's collections online and in public enquiries over the previous few years. Engagement via the website was approximately 30% higher than pre-pandemic levels.

In addition to 7,700+ film extracts available on MACE's website, the archive continues to supply 650+ free to view titles on the BFI's VoD BFI Player platform

Viewing and screening

MACE typically delivers screen heritage outreach, access and screening activities, collaborating with other heritage, film cultural and creative industries sector partners in the Midlands and beyond. Much of this in-venue activity could not go ahead while restrictions were imposed and planned events were either cancelled or postponed until Q3. Thereafter, the archive worked with partners to deliver screening activities in Coventry as part of the delayed City of Culture year and, separately, with other regional film archives on a short film produced in response to the pandemic. Overall, capacity to supply material for external screenings/events across the museums, libraries and archives and education sectors during the year shrank by 50%.

Education

MACE's Director and CEO, Dr Clare Watson, holds a senior academic position within the College of Arts at the University of Lincoln where, in addition to running the archive, she supports student and research engagement. During 2021/22, she convened archive internship modules with teaching returning onsite at the start of the year in line with university policy.

The archive contributes to educational activities aimed at the wider film, cultural and heritage sectors. In 2021/22, the Director, also Chair of Film Archives UK, the network for public film archives in UK, led the delivery of a TNA-funded project focused on strategic planning and digital skills for the sector. The project conducted research, several surveys and workshops, and it engaged 100+ individuals and organisations nationally. Additionally, MACE supports educational opportunities through volunteering and for people across the region and UK. MACE is a partner of the Midlands4Cities AHRC consortium and, separately, is co-supervising a Collaborative Doctoral Award candidate with University of Warwick.

FINANCIAL REVIEW

Financial position

Part of MACE's annual income is derived from grant funding and the baseline level of funding awarded by the British Film Institute, which is subject to annual review, is secured until 2023. The BFI is MACE's primary funder and lead body for film. As previously reported, the BFI, from whom MACE has received regular grant funding as one of their partnership bodies, was cut in the spending review of November 2015. As a result BFI discontinued the distribution of grant-in-aid to its partnership organisations, transferring a standstill sum into a Lottery Regional Archives Investment Fund award for which MACE made a successful bid. During 2016/17, the BFI announced a continuation of this fund alongside the launch of its five-year 2022 Strategy covering the period 2017-2022. MACE was awarded funding in 2017/18 for the period 2017-2020. During 2019/20, BFI introduced changes with respect to the financial support it provides to regional public film archives in England and it discontinued the RAIF award in March 2020. For the period 2020-2023, MACE has been awarded funding from the BFI's competitive Audience Fund programme aimed at organisations that engage audiences with film. From 2023, MACE will apply to BFI via its new competitive Lottery fund for screen heritage.

Other grant income is less predictable and annual income fluctuates according to the varying availability of traditional sources of project-based funding and the levels of funding grants awarded. During 2021/22, MACE was able to restart work on projects not possible during the earlier period of the Covid-19 pandemic. This included the BFI-led Heritage 22 screen heritage project and work for the Coventry City of Culture year.

MACE continues to receive significant support from the University of Lincoln with donations received again during the current year. The charity is immensely grateful to the University of Lincoln and hopes to retain their continued support over the coming years.

During 2021/22, the archive's financial position stabilised as the archive gradually settled into a new phase of hybrid working. Moving forward, income generation continues to assume a significant role in the strategy for the long term sustainability of the archive. At the year end, income generation totalled £408,060. A balanced budget has been prepared for 2022/23.

Reserves policy

It is the policy of MACE to maintain unrestricted funds, which are the unrestricted general reserves of the Charity. The reserves will be reviewed annually. The charity will endeavour to maintain reserves at a level that would enable it to fulfil contractual and statutory obligations, carry out its mission to safeguard collections, mitigate shortfalls in income and meet unforeseen costs. The level of free reserves as at 31 March 2022 amount to £190,004 (2021: £167,940) which is considered adequate to cover the above requirements.

Going concern

The Board of Trustees review quarterly and on an annual basis the financial position of the company. MACE are not aware of any material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern. Whilst monthly income generated from sales and licensing does fluctuate, it stabilised during the year. Part of MACE's annual income is derived from grant funding awarded by the British Film Institute. The nature of this funding stream will change in 2023 as BFI introduces its new 10-year strategy, but it is anticipated that a similar level of funding will be available. Other grant income is less predictable, however, regular financial checks mean that levels of expenditure would be reduced in order to enable MACE to continue to operate were the level of income to fall significantly.

FUTURE PLANS

Our priorities for 2022/23 are:

- To continue to develop and deliver a regional public film archive service offer for the East and West Midlands and to enhance the preservation of and access to a regionally representative collection.
- Further consolidation and development of the partnership with the University of Lincoln, including delivery of accredited work placements and internships, student and academic engagement with the archive and opportunities for collaboration.
- To build the sustainability of MACE, identify funding gaps and new income streams and submit funding bids as required.
- To continue to develop practice and infrastructure in relation to digital preservation and access and to seek opportunities that will support further review and development in this area.
- To participate in the BFI-led national screen heritage partnership project, Heritage 2022, focused on videotape preservation and to select significant, at-risk material for digitisation.
- To work closely with film, cultural and heritage sector partners to facilitate screen heritage outreach, access and screening activities, and to increase our reach with new and diverse audiences particularly across the Midlands.
- To continue to develop a successful working relationship with BFI, the BFI Film Audience Network (regional Film Hubs) and other BFI partners, such as IntoFilm, and to contribute to the delivery of its 2022 Strategy and Heritage 22 programme where appropriate.
- To explore collaborative opportunities with colleagues across the film, cultural and heritage sectors, particularly in the areas of digital preservation and access, in order to contribute to the sustainability of MACE and the film archive sector more broadly.
- To contribute to regional archive networks nationally and across the East and West Midlands regions, including Charing the Film Archives UK network, supporting the Archives Connected East Midlands network and acting as Trustee for Archives West Midlands.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a memorandum and articles of association, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

MACE (Media Archive of Central England LTD) is a charity and also a not for profit company limited by guarantee, incorporated on 13 March 1996 and registered as a charitable trust on 26 November 2003. The company was established under a Memorandum of Association that established the objects and powers of the charitable company and is governed under its Articles of Association as amended by Special Resolutions dated 8 January 2002. In the event of the company being wound up, members are required to contribute an amount not exceeding £10 per member.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Recruitment and appointment of new trustees

As set out in the Articles of Association no person can be appointed a Trustee unless he has attained the age of 18 or in circumstances such that he has already been a Trustee, he would have been disqualified from acting under the provisions of Article 38. The Trustees may appoint a person who will act to be Trustee either to fill a vacancy or as an additional Trustee. The number of Trustees at any one time must not be less than 2 but is not subject to any maximum.

Nominations for Trustees are put forward by existing Trustees. Nominees may be invited to attend a meeting of the Board of Trustees. Appointment is by a majority vote.

Organisational structure

The Board meets at least 4 times per year and a Chair is appointed by the Trustees. To facilitate effective operations the Chair has delegated authority within terms of delegation approved by the Trustees, for operational matters including finance, employment and related activity to the Chief Executive Officer (CEO).

The Charity is organised so that the Trustees meet regularly to oversee its affairs. The CEO manages the day-to-day administration of the Archive and its staff.

Induction and training of new trustees

All the new Trustees are invited to an induction meeting with the CEO and the Chair who is also the Company Secretary. They will ensure new Trustees are fully aware of their legal obligations under Charity and Company Law.

The Chair and CEO will also brief the new Trustees on the content of the Memorandum and Articles of Association, the Business Plan and financial performance. As part of the induction all new Trustees will be given the opportunity to meet all staff and fellow Trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Income:

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Grants:

Income from grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Donated services and facilities:

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

Volunteers:

We benefit from time given by a number of volunteers across the different services that we offer. In accordance with the Charities SORP (FRS 102) as we are able to value the use of volunteers the time offered by volunteers is recognised within the financial statements.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 25% on cost and 10% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the Financial Statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Financial instruments

Only basic financial instruments as defined in FRS 102 are held. Financial assets and financial liabilities are recognised in the accounts only when the entity becomes party to the contractual provisions of the instrument and their measurement basis is as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at transaction price.

Financial liabilities - trade creditors, accruals and other creditors are basic financial instruments, and are measured at amortised cost. Where a financial liability constitutes a financing transaction it is initially and subsequently measured at the present value of future payments, discounted at a market rate of interest.

Value Added Tax

The Charity is VAT registered. All figures shown are exclusive of VAT.
