### **TRUSTEES' ANNUAL REPORT FOR THE YEAR ENDED 31<sup>ST</sup> MARCH 2024**

The trustees present their annual report and the financial statements for the year ended 31st March 2024.

#### **1. LEGAL AND ADMINISTRATION**

Jamia Masjid Anwar-e-Madina and Islamic Study Centre is a registered charity, number 1101647, and is subject to the regulation of the Charity Commission.

#### **2. STRUCTURE, GOVERNANCE AND MANAGEMENT:**

The charity is governed by its constitution adopted on 8th May 1998. The charity is constituted as an unincorporated association consisting of members. Trustees are appointed or re-appointed at the Annual General Meeting. All trustees give their time voluntarily and receive no remuneration or other benefits.

#### **3. TRUSTEES**

The day-to-day affairs of the charity are managed by the trustees with the help of the volunteers. There are five trustees.

The following charity trustees managed the charity during the year to 31<sup>st</sup> March 2024.

Trustees delegate some day-to-day tasks to the volunteers of the charity.

#### **4. CHARITABLE OBJECTS**

- A. To promote the benefit of the inhabitants of Huddersfield (hereinafter called "the area of benefit") without distinction of sex, race, political, or other opinions, by associating together the said inhabitants and the local authorities, voluntary and other organizations in a common effort to advance education, advance the Islamic religion, teachings, values and practices and to provide facilities in the interest of the relief of poverty, of social welfare, recreations and leisure-time occupation with the object of improving the conditions of life for the said inhabitants.
- B. To work towards the elimination of racial discrimination and to promote equality of opportunity and good relations between persons of different racial groups.
- C. Establish or secure the establishment of a community centre (hereinafter called "The Centre") and maintain and manage the same, whether alone or in co-operation with any local authority or other person or body in furtherance of these objects

D. Promote such other charitable purposes as may from time to time be determined.

### 5. CHARITY'S ACTIVITIES AND PERFORMANCE.

The charity's activities during the year were as follows:

- i. Teaching the children the Quran and the Islamic religion
- ii. Facilitate five daily prayers
- iii. Facilitate funerals
- iv. Organisation of key Islamic events
- v. Refresher courses for adults

### 6. FINANCIAL REVIEW OF THE CHARITY AT THE END OF THE YEAR

In the financial year to 31st March 2024, the charity had an income of £94,060 (2023: £68,064) and an expenditure of £61,841 (2023: £49,347).

### 7. RESERVES POLICY

The charity's reserve policy is to hold sufficient funds in reserve to enable the charity to operate for six months if no other funds are available.

### 8. FUNDS IN DEFICIT

There are no funds held by the charity that are materially in deficit.

### 9. PUBLIC BENEFIT STATEMENT.

The trustees confirm they have complied with their duty in Section 17(3) of the 2011 Charities Act to have due regard to the guidance on public benefit by the Charity Commission in exercising their powers and duties.

### 10. FUTURE PLANS

- ii. To enlarge the prayer areas for both men and women.



## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31<sup>st</sup> MARCH 2024

### 1. ACCOUNTING POLICIES

The principle accounting policies adopted in the preparation of the financial statements are set below: -

#### a. Basis of Preparation

The accounts have been prepared under the historic cost convention, on a going concern basis, and in accordance with the Statement of Recommended Practice for charity accounts issued in March 2005 (The charities SORP 2005) and with accounting standards.

#### b. Depreciation

Depreciation is provided on the cost of tangible fixed assets in order to write off such costs after taking account of scrap values over the expected (held for use by the entity) useful lives as follows: -

No depreciation is charged in respect of land and buildings.

#### c. Incoming Resources

Fee income and Donations & Gifts are included in the Statement of receipts and payments when received by the charity.

#### d. Expenditure Recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

#### e. Management and Administration Expenditure

Includes all expenditures not directly related to the charitable activity of fundraising ventures.

#### f. Taxation

The organization is recognized as a charity by HM Revenue and Customs and thereby benefits from certain exemptions from taxation on income and gains to the extent they are applied for charitable purposes.

#### g. Unrestricted funds

All the funds received are unrestricted funds. Unrestricted funds are those funds that can be used in accordance with the charitable objectives at the discretion of the trustees.

### 2. FEES & DONATIONS:

Donations consist of weekly collections, donations for funerals, and from the charity's education program.
