### REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31ST DECEMBER 2024

---

The trustees present their report and the financial statements for the year ended 31 December 2024. The trustees who served during the year and upto the date of this report are set out on page 1.

#### **Structure, governance and management**

Zia Ul Khair Foundation UK was registered as a charity on 28 January 2004 (1101777)

The charity was established under a constitution, which established the objects and powers of the charitable company.

The trustees in charity law are responsible for the overall management and control of the charity working with other persons on an entirely voluntary basis.

Trustees are appointed in accordance with Zia Ul Khair Foundation UK constitution. Once appointed, Trustees are given introduction of the charity and information about its objects, Trustees are also given the copy of the constitution and aims and objective, Role description are issued to each trustee and full induction is given setting out the obligations of a trustee. All trustees are issued with copies of the Charity Commission's guidance.

The trustees meet regularly and at least every 2 months.

The trustees actively review the major risk to which the charity is exposed to on a regular basis, in particular those relating to its operations and finances. The system is established to mitigate these.

#### **Objectives and activities for the public benefit**

The principal aims of the charity and objective of the charitable company are

(1) To advance the Islamic religion. (2) To promote the benefits for the inhabitants of the united kingdom (hereinafter called the area of benefit) without distinction of sex or of political, religious, or other opinions by associating with local authorities, voluntary organisations and inhabitants in a common effort to advance education and training and to provide facilities in the interest of social welfare for recreation and leisure time occupation with the objects of improve the quality of life for the said inhabitants and protect good health where felt necessary. (3) To secure and establish community centres to maintain and manage and to co-operate with statutory organisations, agencies and trust in the maintenance and management of activities promoted by the Zia-Ul-Uloom and its constituent bodies in furtherance of the objects.

#### **Achievement and performance**

During the year we support educational projects and orphan children in the surrounding areas. We implemented water projects and food distribution through Qurbani. Alongside this we supported a number of welfare projects for the local community.

#### 1 Accounting policies

##### 1.1 Basis of accounting

The financial statements are prepared under the historic cost convention and in accordance with the Financial Reporting standards, the Statement of Recommended Practice 'Accounting and Reporting by Charities' issued in March 2005 (SORP 2005) and the Charities Act 1993.

##### 1.2 Funding accounting

Unrestricted funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity

Restricted funds are those donated for use in a particular area or for specific purpose, the use of which is restricted to that area or purpose.

##### 1.3 Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy.

##### 1.4 Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and costs linked to the strategic management of the charity.

##### 1.5 Depreciation

Depreciation is calculated to write off the cost, less estimated residual values of tangible fixed assets over their estimated useful lives to the Charity. The annual depreciation rates and methods are as follows:-
